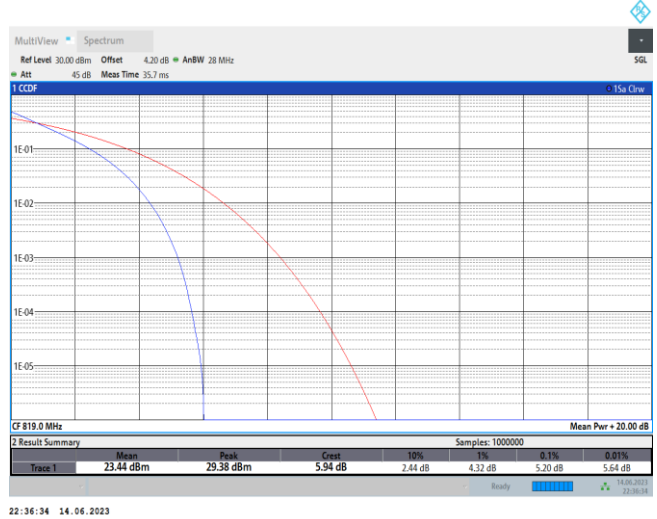

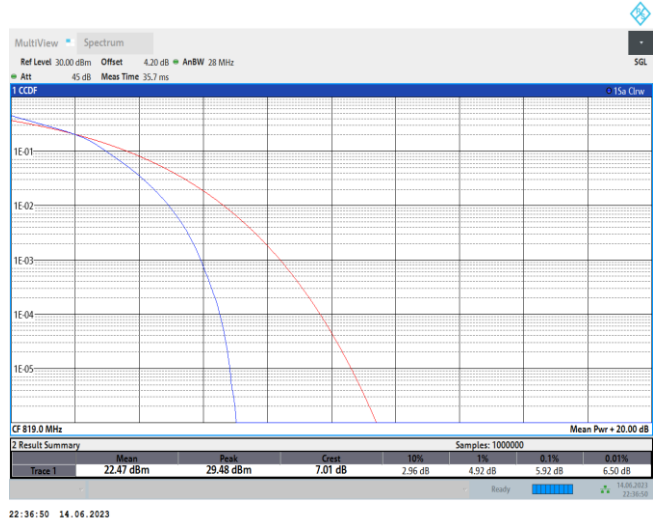

Band26-10MHz-16QAM-26740-50RB#0

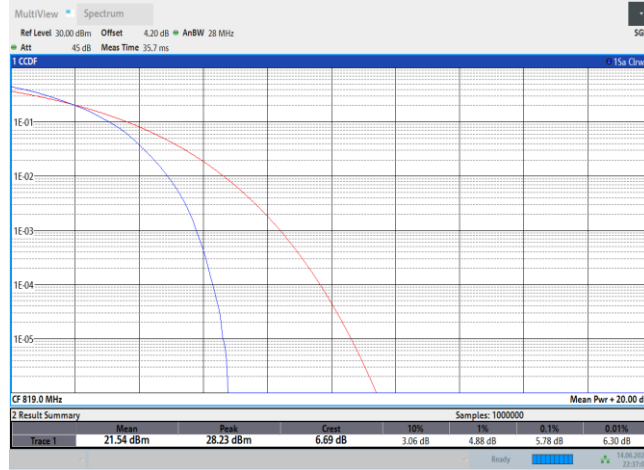
