Radiated Spurious Emissions

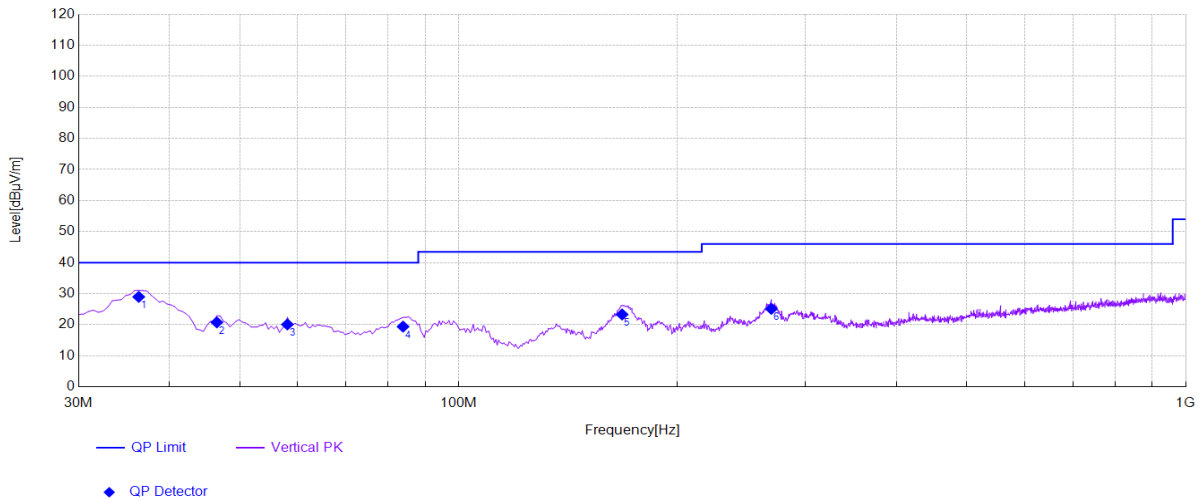
