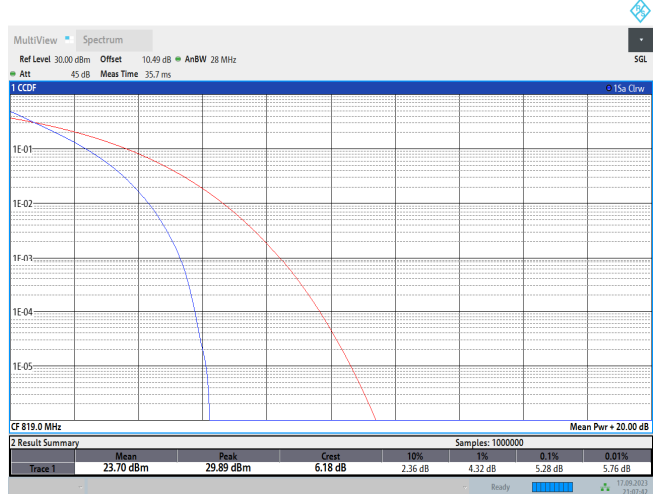

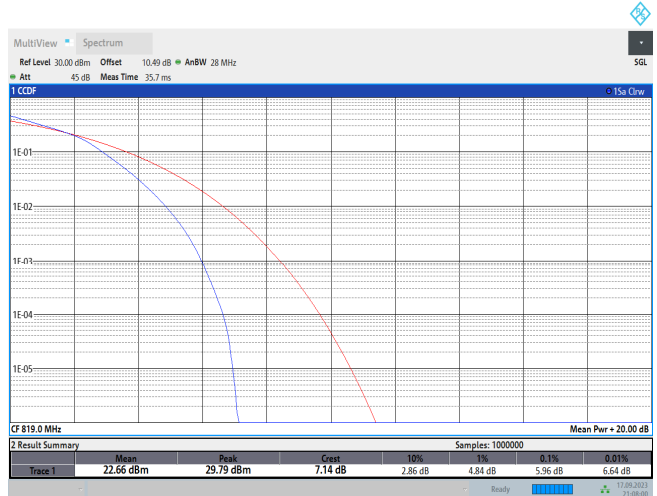

Band26-10MHz-QPSK-26740-50RB#0



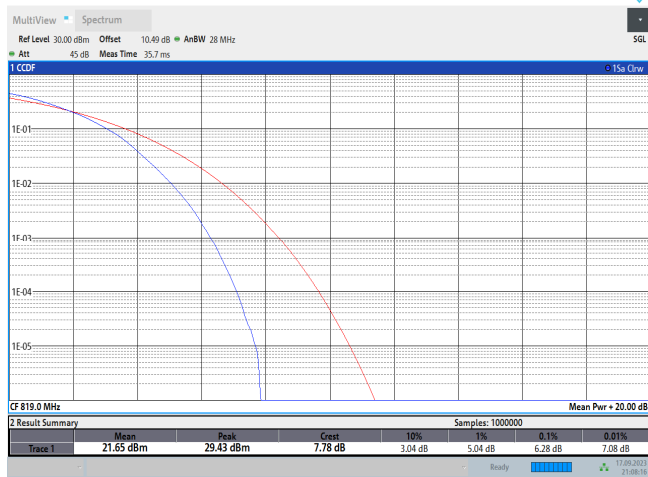
