




- 1. The EUT was placed 0.4 meter from the conducting wall of the shielding room, and it was kept at least 80 centimeters from any other grounded conducting surface.
- 2. Connect EUT to the power mains through a line impedance stabilization network (LISN).
- 3. All the support units are connecting to the other LISN.
- 4. The LISN provides 50 ohm coupling impedance for the measuring instrument.
- 5. The FCC states that a 50 ohm, 50 microhenry LISN should be used.
- 6. Both sides of AC line were checked for maximum conducted interference.
- 7. The frequency range from 150 kHz to 30 MHz was searched.
- 8. Set the test-receiver system to Peak Detect Function and specified bandwidth (IF Bandwidth = 9kHz) with Maximum Hold Mode. Then measurement is also conducted by Average Detector and Quasi-Peak Detector Function respectively.



3.3 Frequency Stability Measurement

3.3.1 Limit

The frequency tolerance of the carrier signal shall be maintained within +/- 0.01% (100ppm) of the operating frequency over a temperature variation of -20 degrees to +50 degrees C at normal supply voltage, and for a variation in the primary supply voltage from 85% to 115% of the rated supply voltage at a temperature of 20 degrees C. 



- Configure the EUT according to ANSI C63.10. The EUT was placed on the top of the turntable 0.8 meter above ground. The phase center of the loop receiving antenna mounted antenna tower was placed 3 meters far away from the turntable.
- 2. Power on the EUT and all the supporting units. The turntable was rotated by 360 degrees to determine the position of the highest radiation.
- 3. The height of the receiving antenna was fixed at one meter above ground to find the maximum emissions field strength.
- 4. For Fundamental emissions, use the receiver to measure QP reading.
- 5. When the radiated emissions limits are expressed in terms of the average value of the emissions, and pulsed operation is employed, the measurement field strength shall be determined by averaging over one complete pulse train, including blanking intervals, as long as the pulse train does not exceed 0.1 seconds. As an alternative (provided the transmitter operates for longer than 0.1 seconds) or in cases where the pulse train exceeds 0.1 seconds, the measured field strength shall be determined from the average absolute voltage during a 0.1 second interval during which the field strength is at its maximum value.

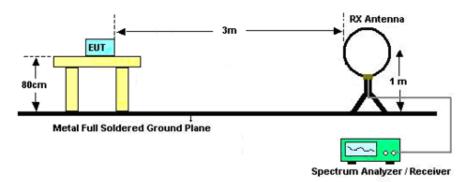
- 9. Power on the EUT and all the supporting units. The turntable was rotated by 360 degrees to determine the position of the highest radiation.
- 10. The height of the broadband receiving antenna was varied between one meter and four meters above ground to find the maximum emissions field strength of both horizontal and vertical polarization.
- 11. For each suspected emissions, the antenna tower was scan (from 1 M to 4 M) and then the turntable was rotated (from 0 degree to 360 degrees) to find the maximum reading.
- 12. Set the test-receiver system to Peak or CISPR quasi-peak Detect Function with specified bandwidth under Maximum Hold Mode.
- 13. When the radiated emissions limits are expressed in terms of the average value of the emissions, and pulsed operation is employed, the measurement field strength shall be determined by averaging over one complete pulse train, including blanking intervals, as long as the pulse train does not exceed 0.1 seconds. 
