

ANNEX A: MEASUREMENT RESULTS

A.1 Radiated Emission (§15.109(a))

A.1.1 Method of measurement

The field strength of radiated emissions from the unintentional radiator (USB mode of MS and charging mode of MS) at a distance of 3 meters is tested. Tested in accordance with the procedures of ANSI C63.4 – 2003, section 8.3. The test set-up please refers to Annex C.1.




Figure A.1 Radiated Emission from 30MHz to 1GHz




Figure A.2 Radiated Emission from 1GHz to 4GHz




Figure A.5 Radiated Emission from 30MHz to 1GHz




Figure A.6 Radiated Emission from 1GHz to 4GHz



A.2 Conducted Emission (§15.107(a))





