Band48-20MHz-QPSK-55990-1RB#0-Range1:30~30000MHz

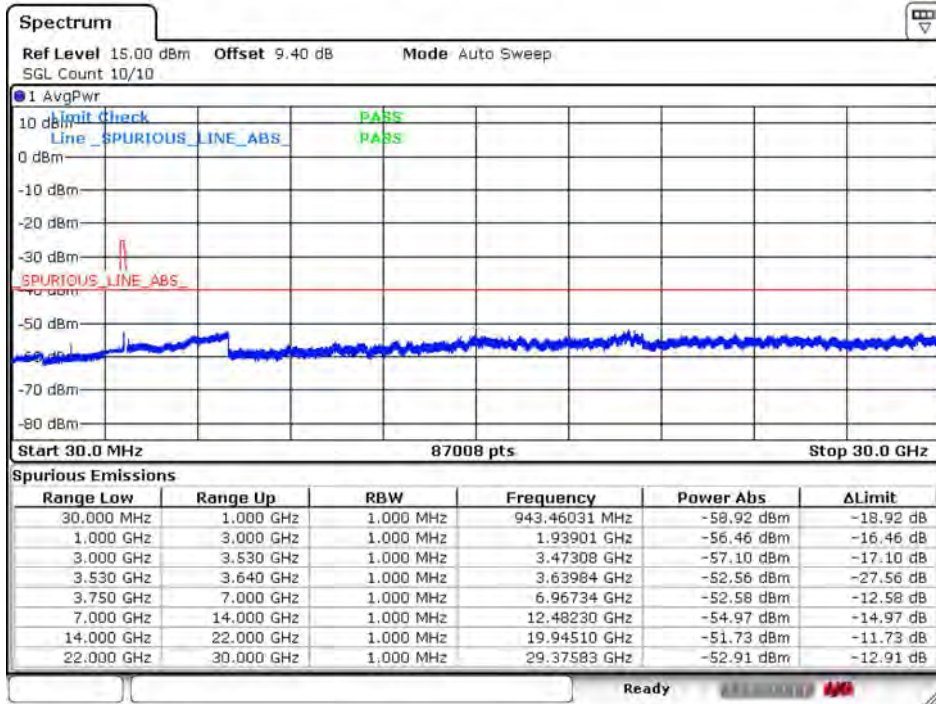
