1. Below 1 GHz, the channel 1, 6, and 11 were pre-tested in chamber. The channel 11, worst case one, was chosen for final test.
2. Above 1 GHz, the channel 1, 6, and 11 were tested individually.
3. Test result, which were mentioned on section 3.1.
4. Transfer rate, 11Mbps with CCK technique and 6Mbps with OFDM technique, the worst case, were chosen for final test.

### 3.3 GENERAL DESCRIPTION OF APPLIED STANDARDS

The EUT is a SpeedTouch 180 Wireless Access Point. According to the specifications of the manufacturer, it must comply with the requirements of the following standards:

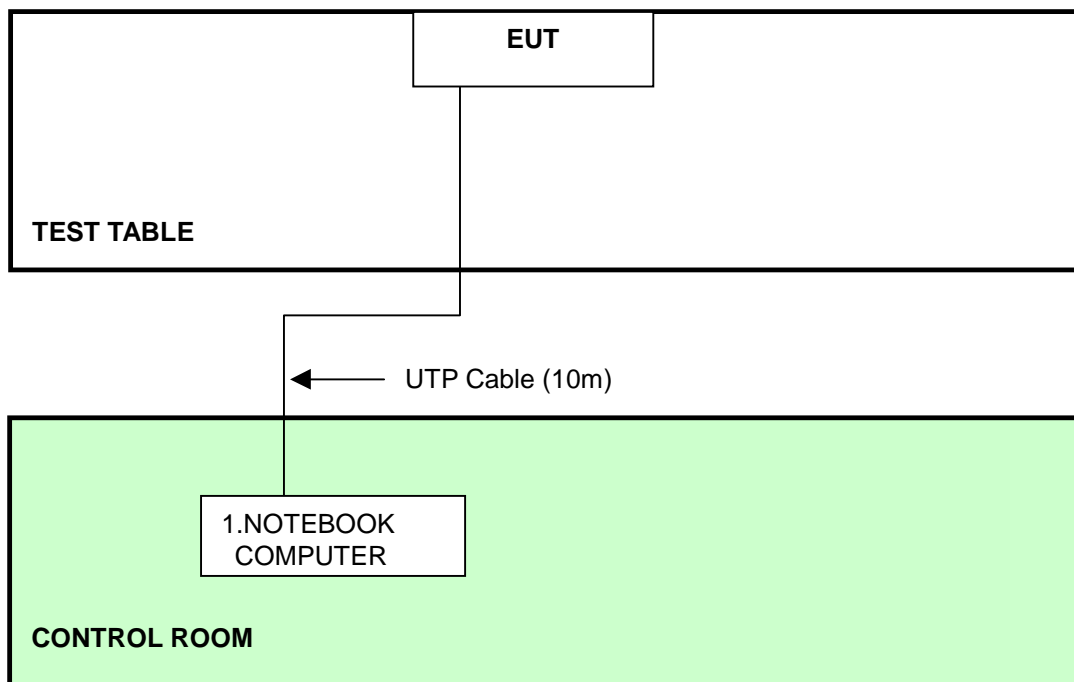

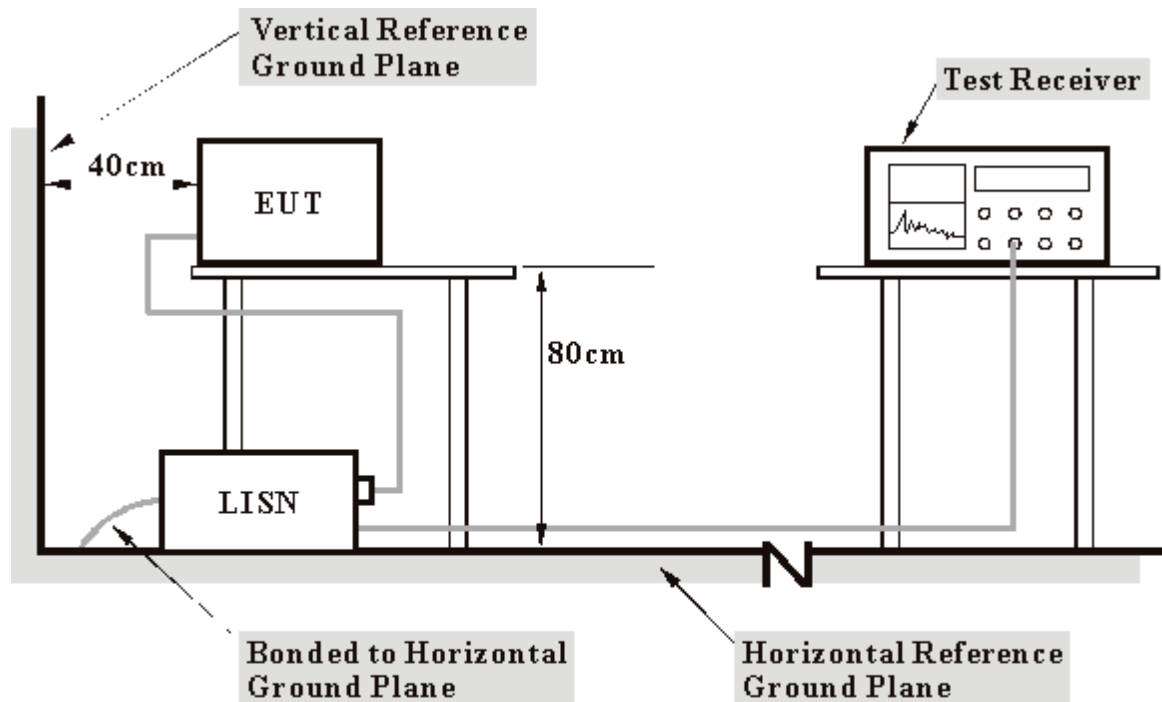

### 3. TEST PROCEDURES

- a. The EUT was placed 0.4 meters from the conducting wall of the shielded room with EUT being connected to the power mains through a line impedance stabilization network (LISN). Other support units were connected to the power mains through another LISN. The two LISNs provide 50 ohm/ 50uH of coupling impedance for the measuring instrument.
- b. Both lines of the power mains connected to the EUT were checked for maximum conducted interference.
- c. The frequency range from 150 kHz to 30 MHz was searched. Emission levels over 10dB under the prescribed limits could not be reported

1. Support units were connected to second LISN.
  2. Both of LISNs (AMN) 80 cm from EUT and at the least 80 cm from other units and other metal planes support units.

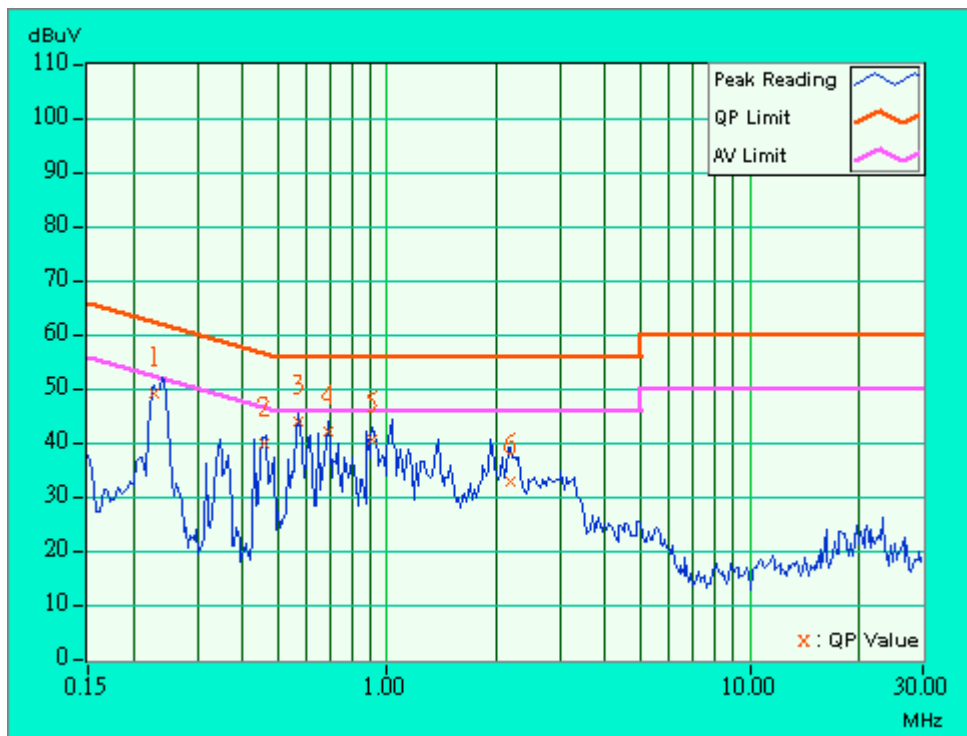

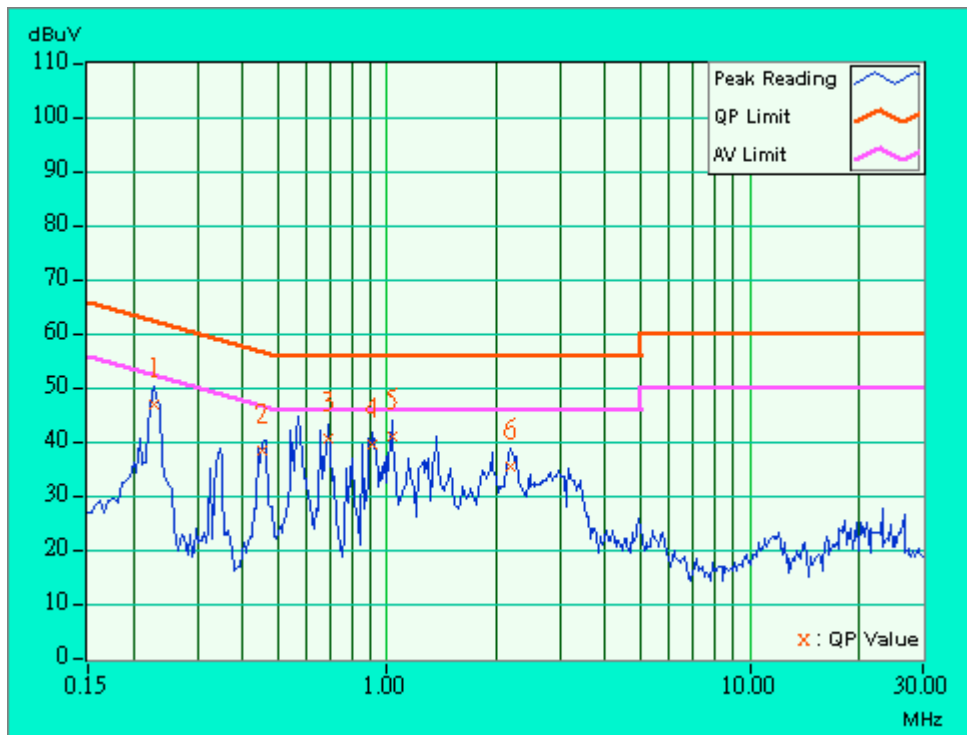

## 4.2 RADIATED EMISSION MEASUREMENT

### 4.2.1 LIMITS OF RADIATED EMISSION MEASUREMENT

Field strength limits are at the distance of 3 meters, emissions radiated outside of the specified bands, shall be according to the general radiated limits in 15.209 as following:

#### 4.2.3 TEST PROCEDURES

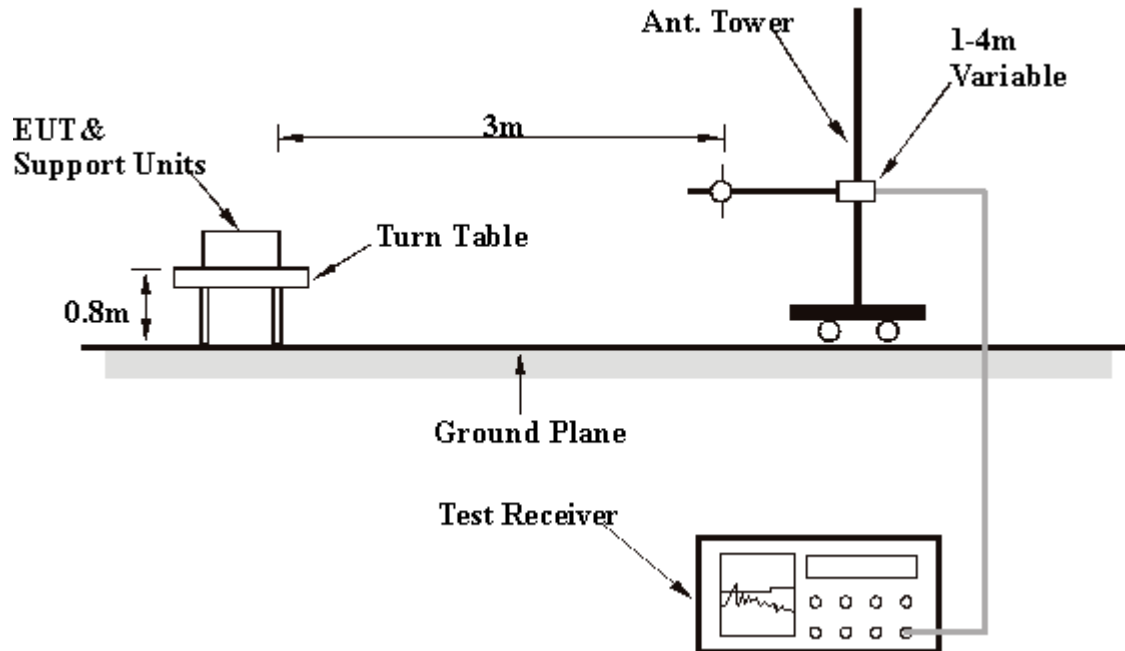
- a. The EUT was placed on the top of a rotating table 0.8 meters above the ground at a 10 meter open area test site. The table was rotated 360 degrees to determine the position of the highest radiation.
- b. The EUT was set 3 meters away from the interference-receiving antenna, which was mounted on the top of a variable-height antenna tower.
- c. The antenna is a broadband antenna, and its height is varied from one meter to four meters above the ground to determine the maximum value of the field strength. Both horizontal and vertical polarizations of the antenna are set to make the measurement.
- d. For each suspected emission, the EUT was arranged to its worst case and then the antenna was tuned to heights from 1 meter to 4 meters and the rotatable table was turned from 0 degrees to 360 degrees to find the maximum reading.
- e. The test-receiver system was set to Peak Detect Function and Specified Bandwidth with Maximum Hold Mode.
- f. If the emission level of the EUT in peak mode was 10 dB lower than the limit specified, then testing could be stopped and the peak values of the EUT would be reported. Otherwise the emissions that did not have 10 dB margin would be re-tested one by one using peak, quasi-peak or average method as specified and then reported in a data sheet.

**NOTE:**

1. The resolution bandwidth and video bandwidth of test receiver/spectrum analyzer is 120kHz for Peak detection (PK) and Quasi-peak detection (QP) at frequency below 1GHz.
2. The resolution bandwidth and video bandwidth of test receiver/spectrum analyzer is 1 MHz for Peak detection at frequency above 1GHz.
3. The resolution bandwidth of test receiver/spectrum analyzer is 1 MHz and the video bandwidth is 300 Hz for Average detection (AV) at frequency above 1GHz.

The transmitter output was connected to the spectrum analyzer via a low lose cable. Set both RBW and VBW of spectrum analyzer to 100 kHz with suitable frequency span including 100 kHz bandwidth from band edge. The band edges was measured and recorded.

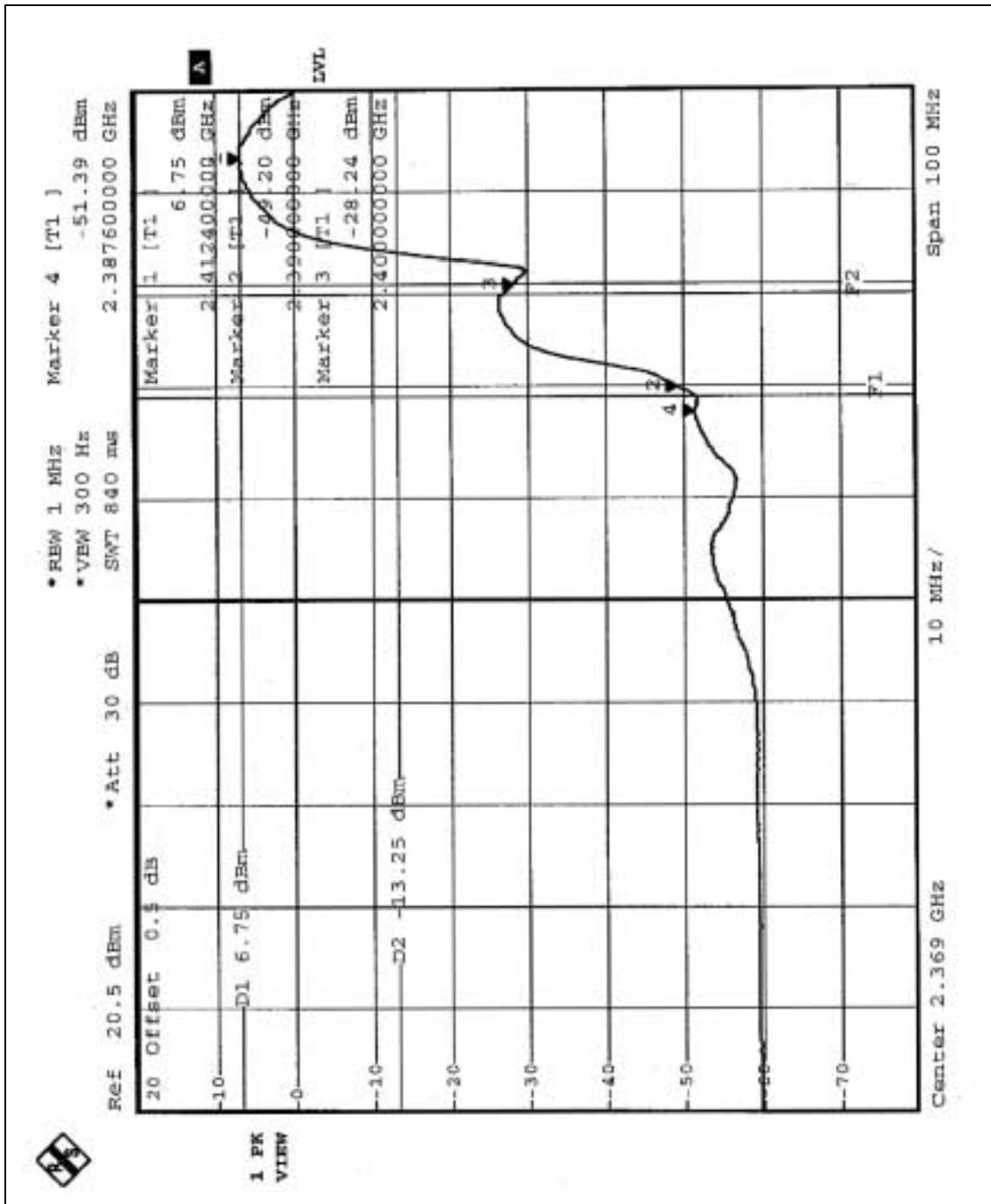

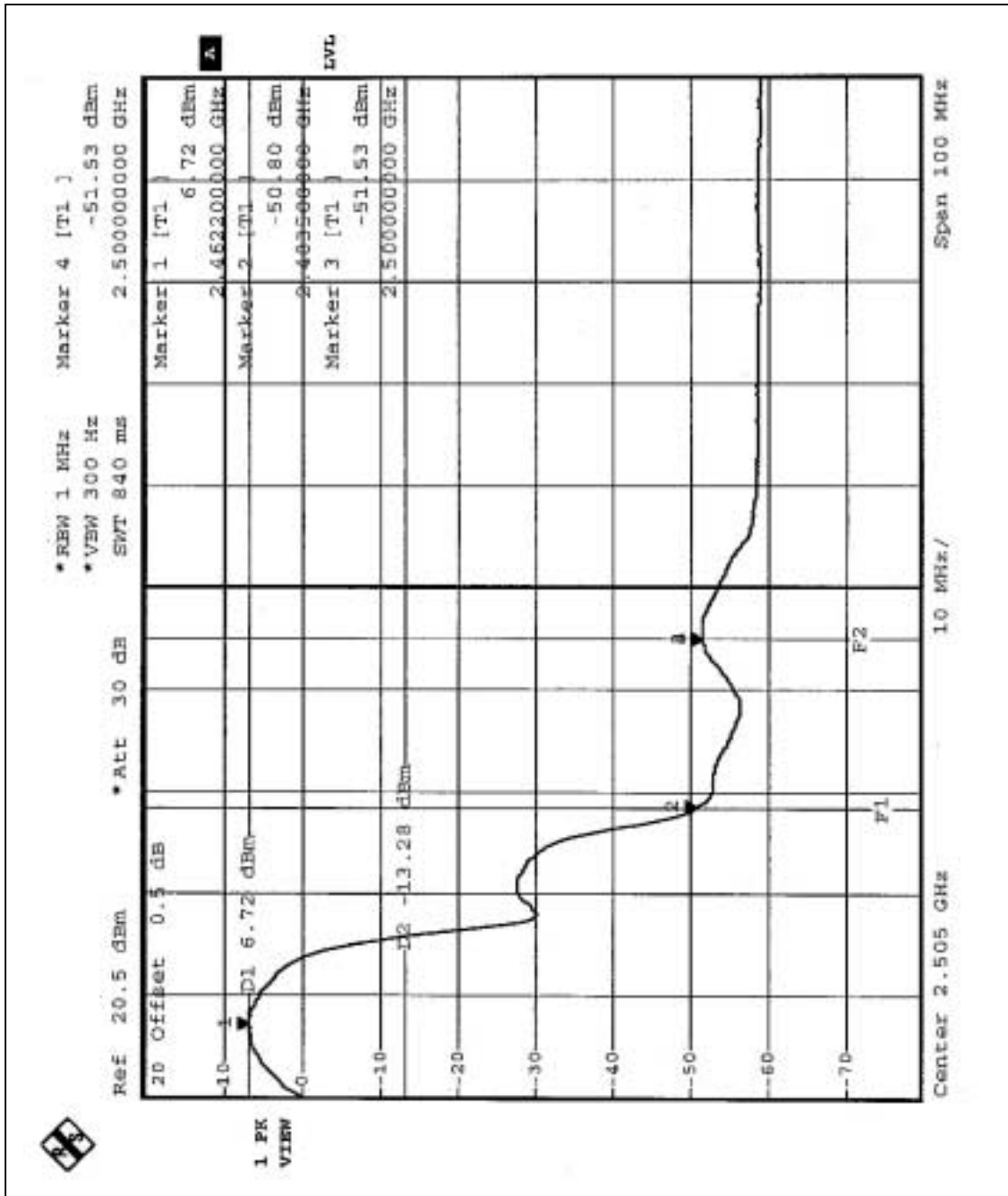

Note - The delta method is only used up to 2 MHz away from the restricted bandage, The radiated emissions which located in other restricted frequency band, the result, please refer to 4.2.7.

**NOTE (1):** The band edge emission plot on the following first page shows 55.95dB delta between carrier maximum power and local maximum emission in restrict band (2.3900GHz). The emission of carrier strength list in the test result of channel 1 at the item 4.2.7 is 101.00dBuV/m, so the maximum field strength in restrict band is  $101.00 - 55.95 = 45.05$  dBuV/m which is under 54 dBuV/m limit.

**NOTE (2):** The band edge emission plot on the following second page shows 57.52dB delta between carrier maximum power and local maximum emission in restrict band (2.4835GHz). The emission of carrier strength list in the test result of channel 11 at the item 4.2.7 is 104.2dBuV/m, so the maximum field strength in restrict band is  $104.2 - 57.52 = 46.68$  dBuV/m which is under 54 dBuV/m limit.







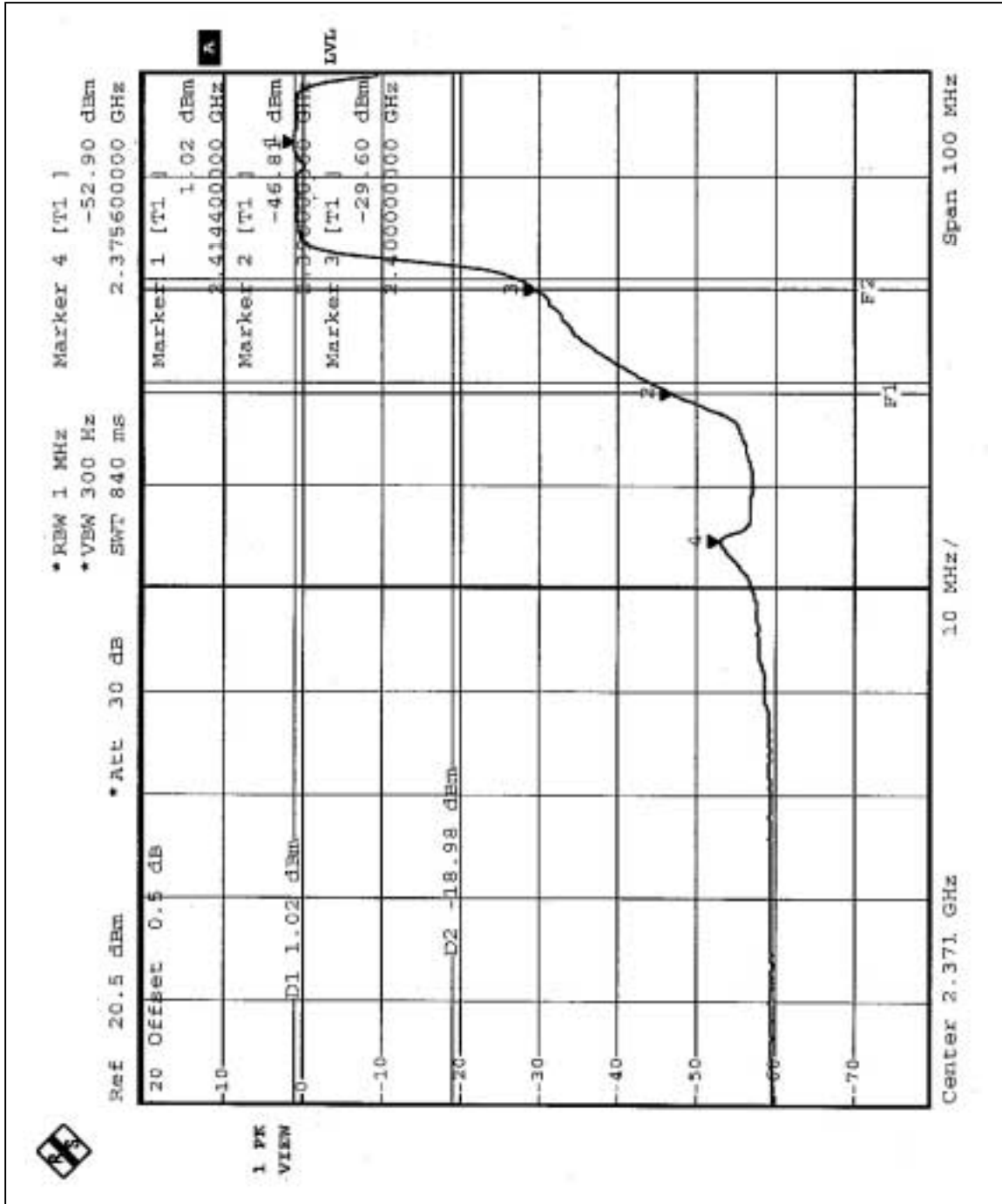

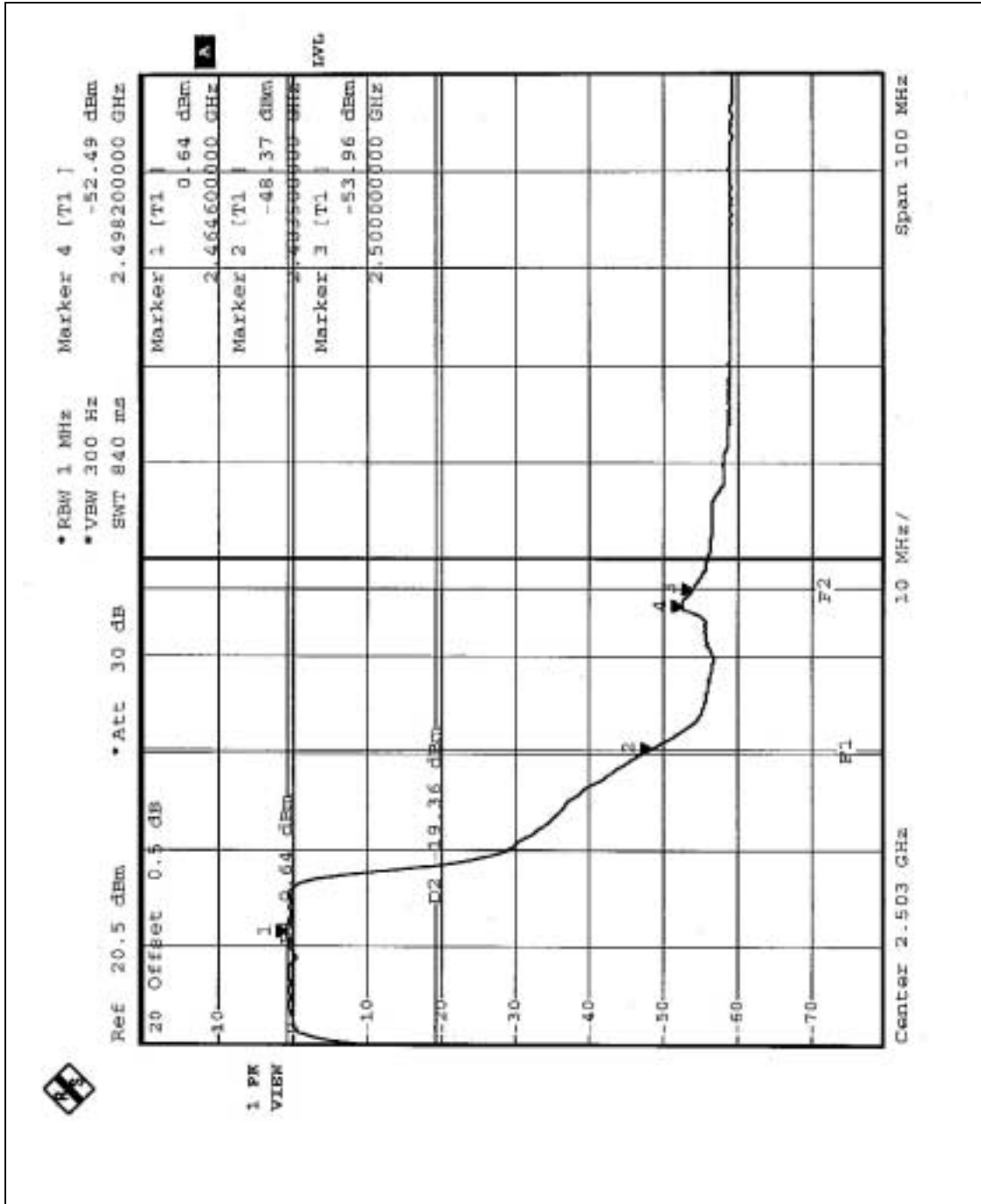

And according to FCC 47 CFR Section 15.247 (b), if transmitting antennas of directional gain greater than 6dBi are used, the power shall be reduced by the amount in dB that the directional gain of the antenna exceeds 6dBi.

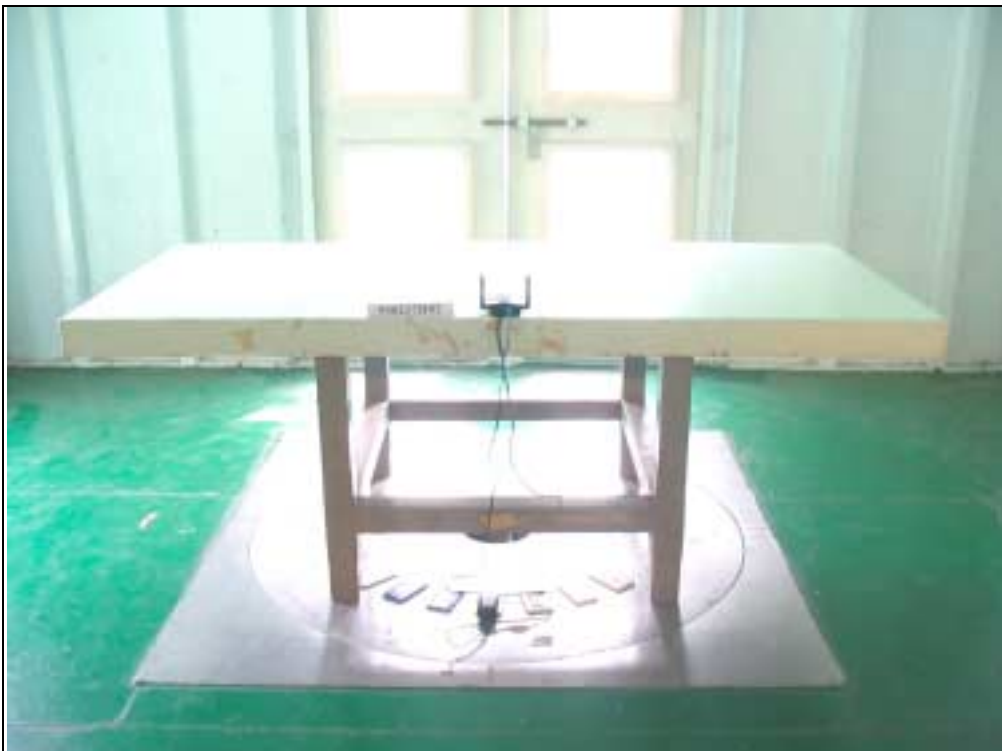
The antenna type used in this product is Dipole Antenna without connector. And the maximum Gain of this antenna is only 1.5 dBi.
