



The EUT was tested according to ANSI C63.4-2009. The Frequency spectrum From 0.15MHz to 30MHz was investigated. The LISN used was 500hm/50uH as specified by section 5.1 of ANSI C63.4 –2009. 


A: Conducted Emission on Live Terminal (150kHz to 30MHz)




Block diagram of Test setup
