2. *Correct factor = Antenna Factor + Cable Loss – Preamplifier Factor*
3. *“*” means this data is too weak instrument of signal is unable to test.*
4. *The emission levels of other frequencies are very lower than the limit and not show in test report.*

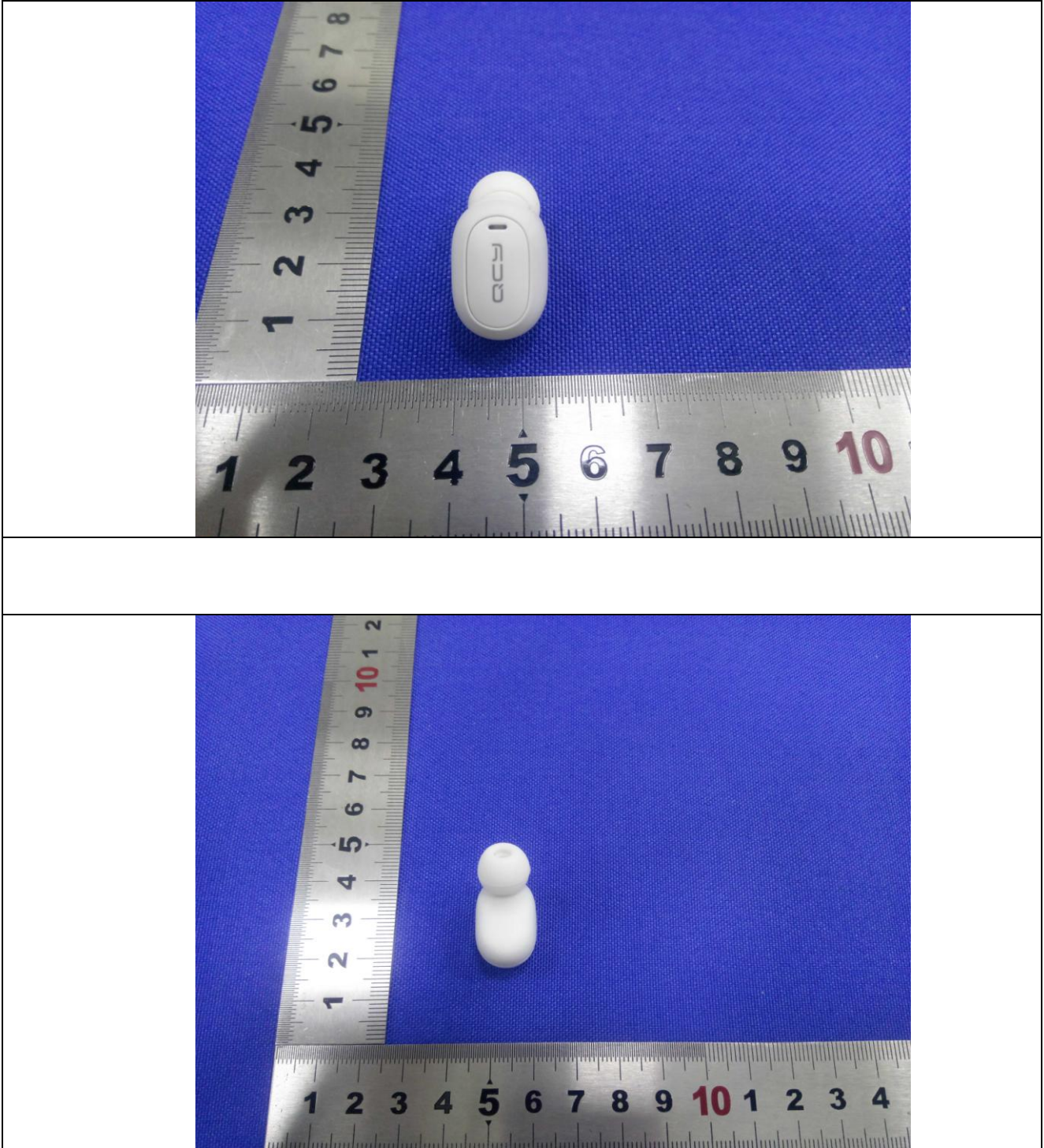
Radiated Emission



Conducted Emission

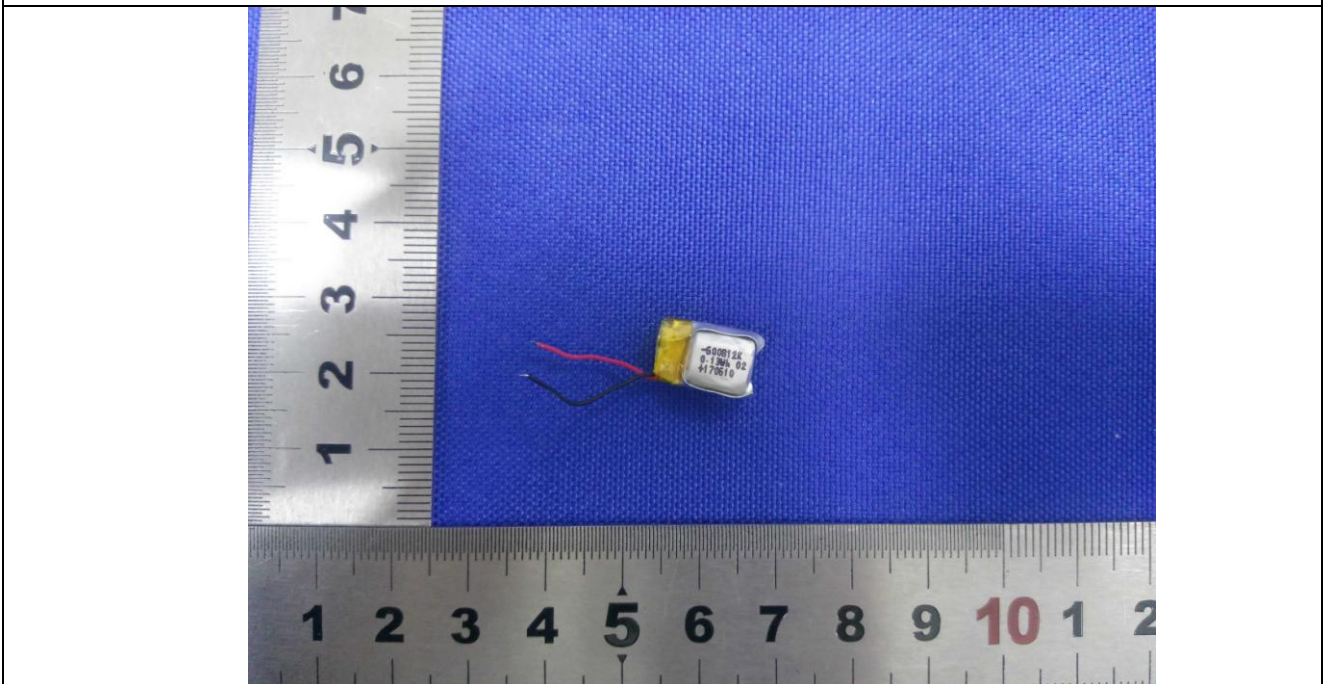
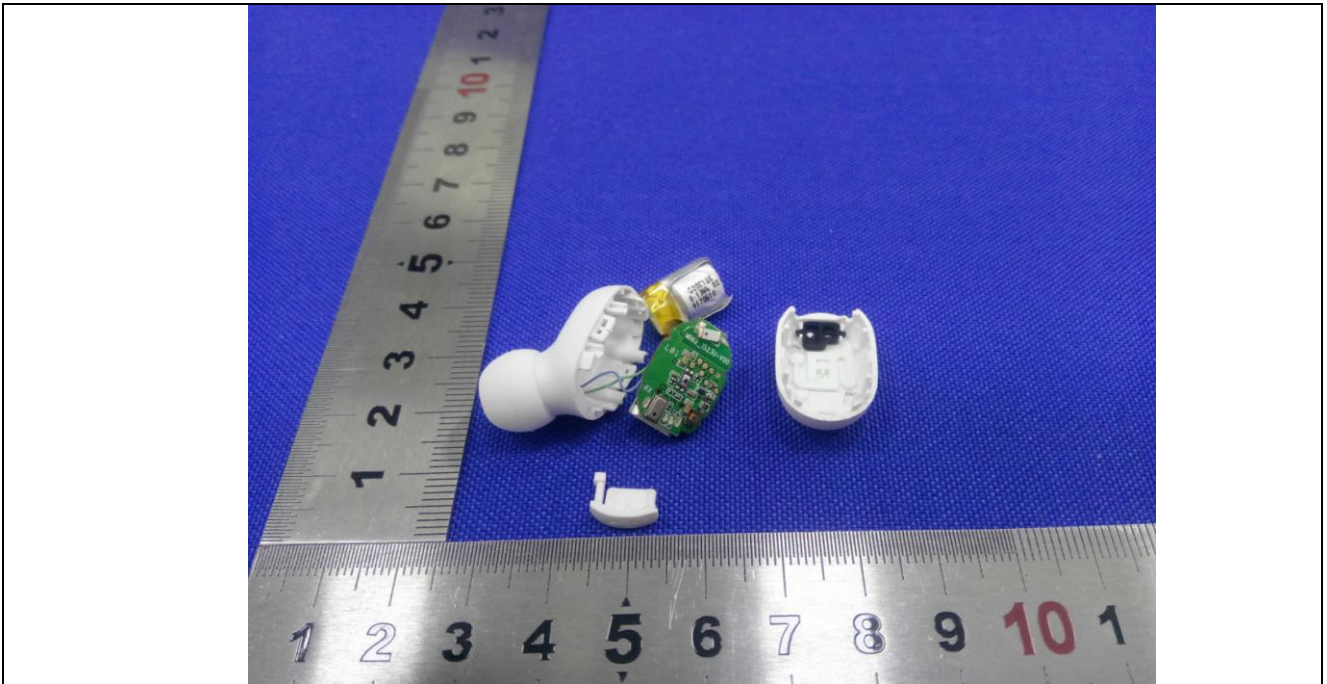


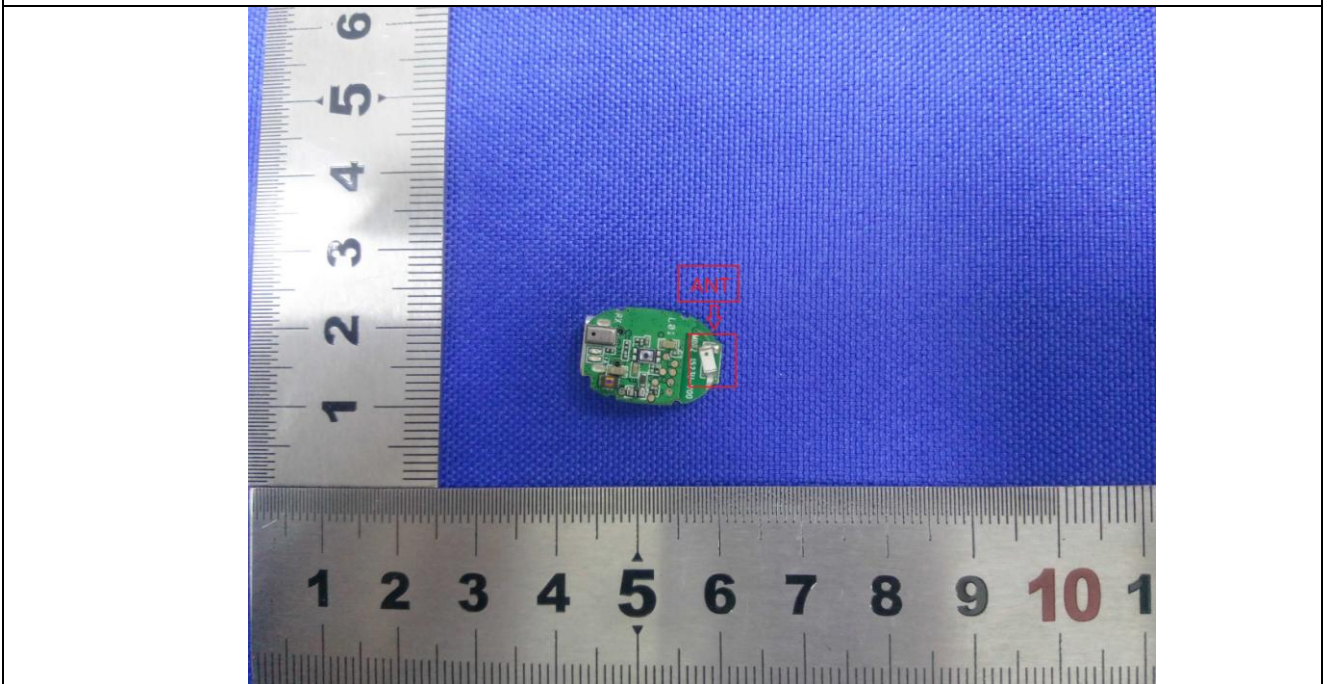
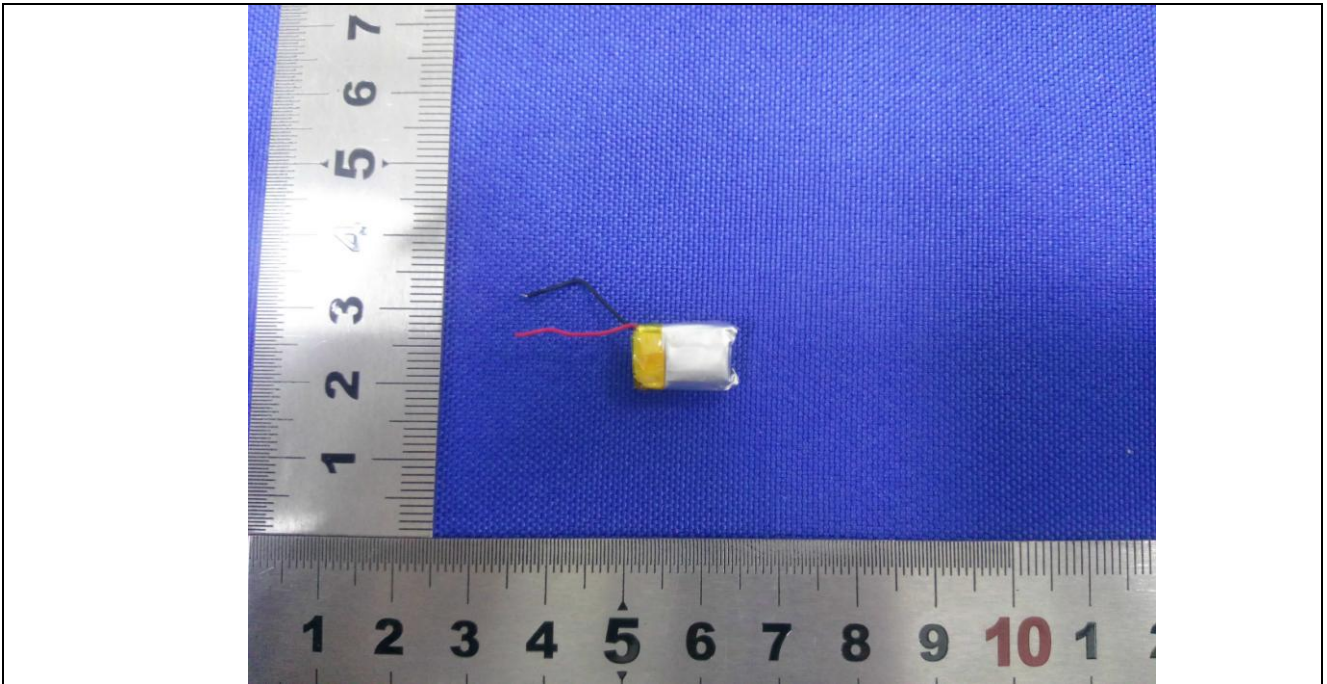
