





4.2 Test Method and test Procedure

The EUT was tested according to ANSI C63.4-2014. The Frequency spectrum From 0.15MHz to 30MHz was investigated. The LISN used was 50ohm/50uH as specified by section 5.1 of ANSI C63.4 -2014. Cables and peripherals were moved to find the maximum emission levels for each frequency. Test Voltage: 120V~, 60Hz



Block diagram of Test setup




