



The EUT was tested according to ANSI C63.4-2014. The Frequency spectrum From 0.15MHz to 30MHz was investigated. The LISN used was 50ohm/50uH as specified by section 5.1 of ANSI C63.4 –2014. 





Block diagram of Test setup


