


#### Duty Cycle Detail, Over a 100 ms Interval



# Duty Cycle Detail, Over a 5.0 ms Interval




# Duty Cycle Detail, Over a 5.0 ms Interval

# Tranmitter Turn-Off Relaese Time, Upon Momentary Activation of Push Switch (Showing release time less than 2 seconds)













EUT bottom view




# EUT inside whole view
