

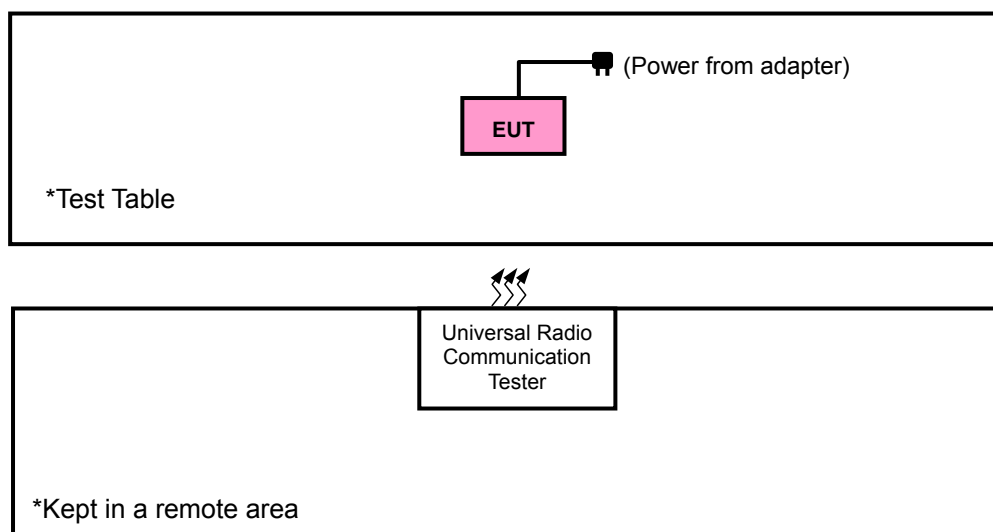

NOTE:

1. Below 1 GHz, the channel 512, 661, and 810 were pre-tested in chamber. The channel 512 was chosen for final test.
2. Above 1 GHz, the channel 512, 661, and 810 were tested individually.
3. The worst case for final test is chosen when the power control level set 0.
4. The channel space is 0.2MHz.
5. The EUT is a GPRS class 10 device (Multislot class: 10, Mobile Terminal B), which provide 2 up-link. After pre-tested both functions, found up-link with 1 time slot is worse, therefore, test results of output power, frequency stability, occupied bandwidth and band edge tests came out from this.
6. The EUT has GSM & GPRS functions. After pre-testing, GSM function is the worst case for all the emission tests.

4.1 OUTPUT POWER MEASUREMENT

4.1.1 LIMITS OF OUTPUT POWER MEASUREMENT

The radiated peak output power shall be according to the specific rule Part 24.232(b) that “Mobile / Portable station are limited to 2 watts e.i.r.p” and 24.232(c) specific that “Peak transmit power must be measure over any interval of continuous transmission using instrumentation calibration in terms of rms-equivalent voltage.”

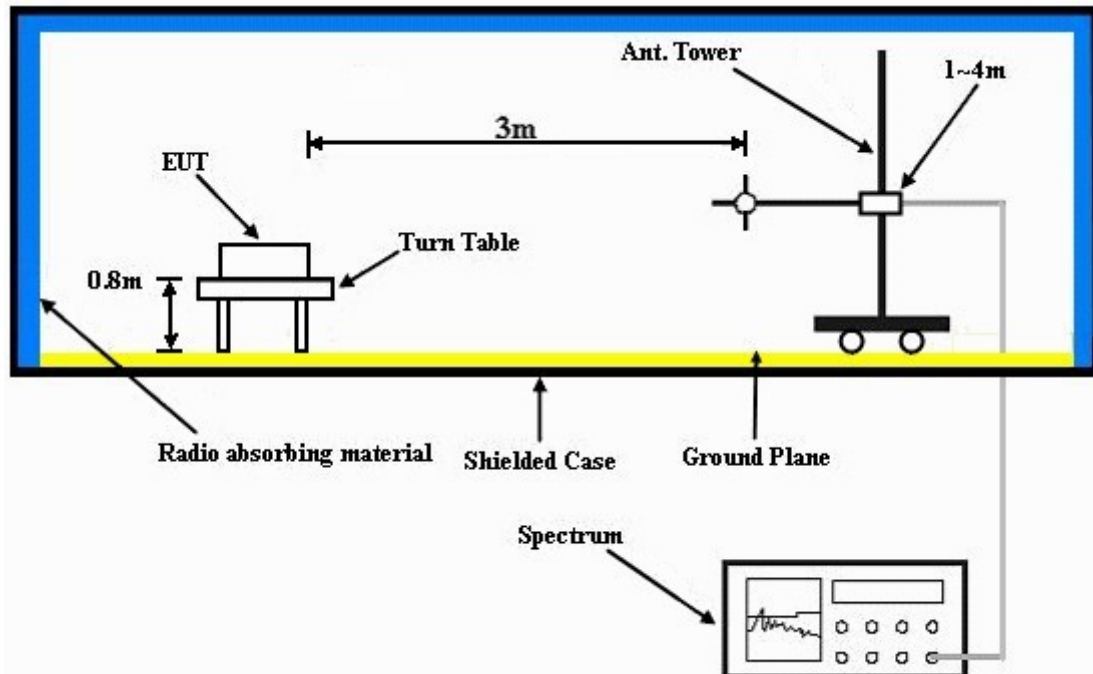

4.1.3 TEST PROCEDURES

- a. The power was measured with R&S Spectrum Analyzer. All measurements were done at 3 channels, 512, 661 and 810 (low, middle and high operational frequency range.)
- b. The conducted peak output power used the power splitter via EUT RF power connector between simulation base station and spectrum analyzer. The path loss included the splitter loss, cable loss and 20dB pad loss. The spectrum set RB/VB 1MHz, then read peak power value and record to the test. (All transmitted path loss shall be considered in the test report data.)
- c. Substitution method is used for E.I.R.P measurement. In the semi-anechoic chamber, EUT placed on the 0.8m height of Turn Table, rotated the table around 360 degrees to search the maximum radiation power and receiver antenna shall be rotated vertical and horizontal polarization and moved height from 1m to 4m to find the maximum polar radiated power. The “Read Value” is the spectrum reading the maximum power value.
- d. The substitution horn antenna is substituted for EUT at the same position and signals generator export the CW signal to the substitution antenna via a tx cable . Rotated the Turn Table and moved receiving antenna to find the maximum radiation power. Adjust output power level of S.G to get a Value of spectrum reading equal to “Read Value “ of step c. Record the power level of S.G
- e. $EIRP = \text{Output power level of S.G} - \text{TX cable loss} + \text{Antenna gain of substitution horn}.$

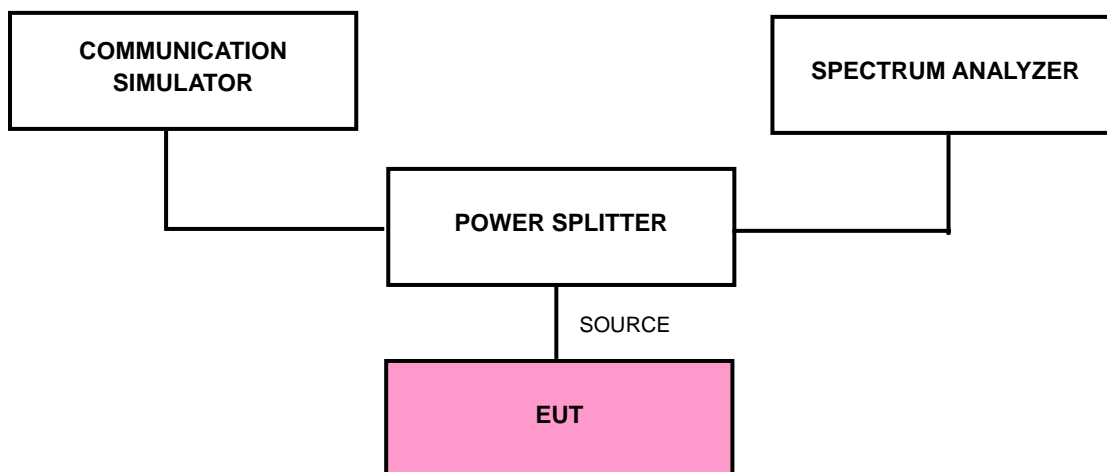

4.2 FREQUENCY STABILITY MEASUREMENT

4.2.1 LIMITS OF FREQUENCY STABILITY MEASUREMENT

According to the FCC part 24.235 shall be tested the frequency stability. The rule is defined that "The frequency stability shall be sufficient to ensure that the fundamental emission stays within the authorized frequency block." The frequency error rate is according to the JTC standard that the frequency error rate shall be accurate to within 2.5ppm of the received frequency from the base station. The test extreme voltage is according to the 2.1055(d)(1) Vary primary supply voltage from 85 to 115 percent of the nominal value for other than hand carried battery equipment and the extreme temperature rule is comply with the 2.1055(a)(1) $-20^{\circ}\text{C} \sim 60^{\circ}\text{C}$.

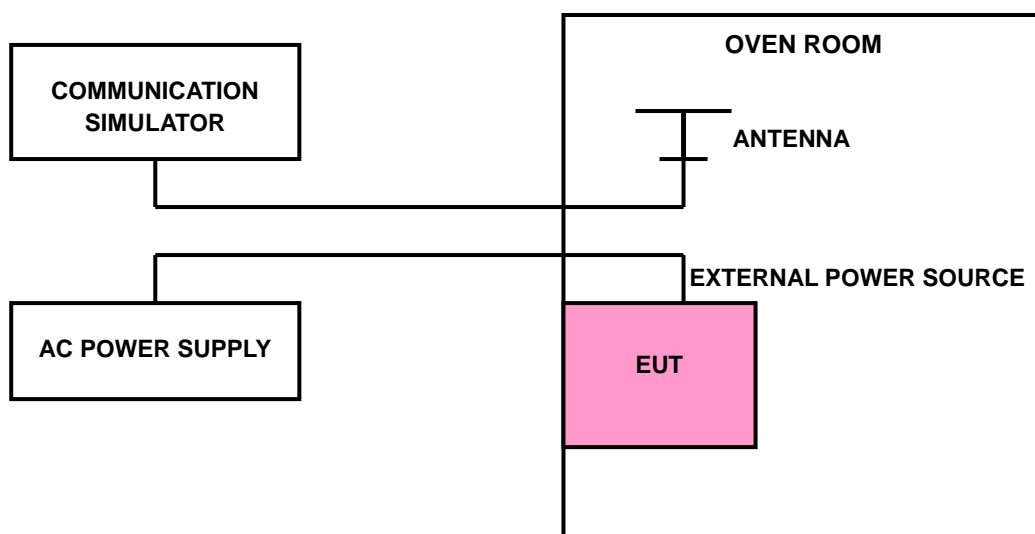

4.2.3 TEST PROCEDURE

- Because of the measure the carrier frequency under the condition of the AFC lock, it shall be used the mobile station in the GSM link mode. This is accomplished with the use of the R&S CMU200 simulator station. The oven room could control the temperatures and humidity. The GSM link channel is the 661.

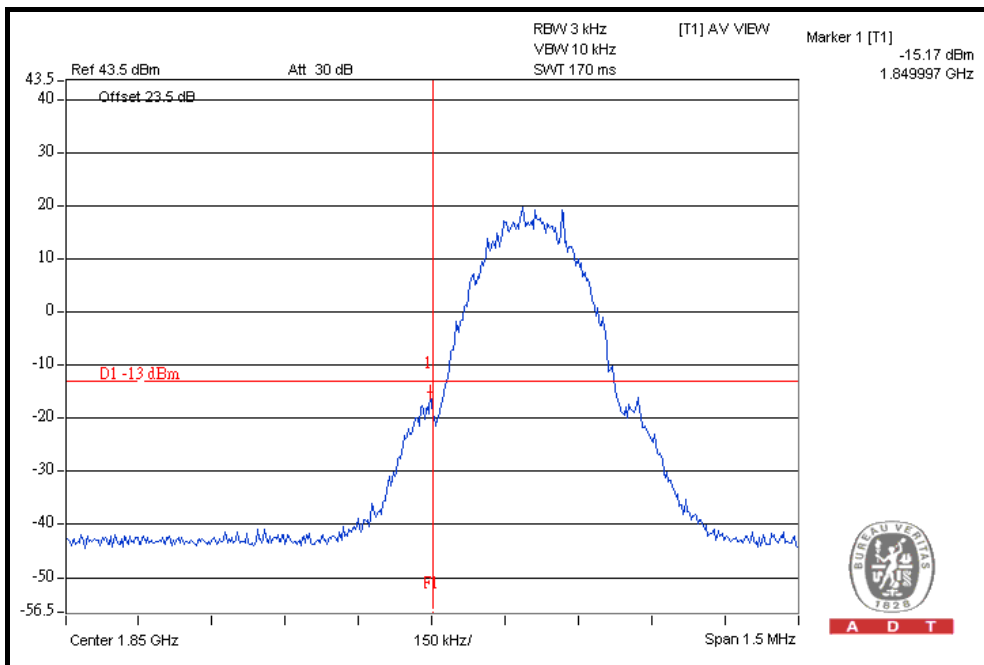


HIGHER BAND EDGE

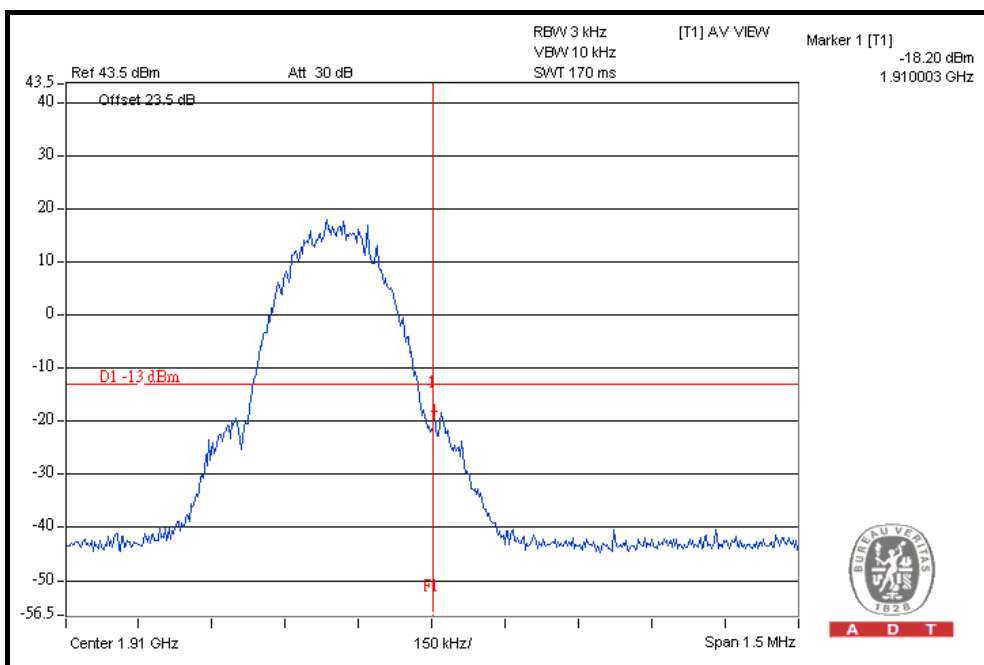
