I have reviewed the above referenced TCB application and find that the following items are needed before the review can be completed:

1. Page 79 of the Users Manual mentions Professional Installers, but does not require professional installers. In order to comply with the requirements of 15.203 with the use of a standard connector (the enclosure appears to have an Nconnector and the manual recommends Lightning Arrestors) Professional Installation is required and must be clearly documented in the installation guide. Please update the Installation Guide with clear Professional Installation wording. Ans: The userman had been revised on p80 (warming statement). Professional Installation wording on page 6.

2. The MPE Exhibit in the test report, Remark #1 states that the RF power is 22.44dBm, but this is not consistent with the remainder of the application. Please correct this discrepancy.

Ans: The test report had been revised on page 69.

The items indicated above must be submitted before processing can continue on the above referenced application. Failure to provide the requested information within 30 days of the original e-mail date may result in application dismissal and
