# EXHIBIT 1

## **GENERAL DESCRIPTION**

#### 1.0 General Description

#### 1.1 Product Description

The equipment under test (EUT) is a transmitter for a wireless lamp operating at 2.402 GHz, 2.404 GHz and 2.406 GHz which is controlled by a RF module. The EUT is powered by 4 AA batteries or 120V AC to 7.5V DC adaptor. The EUT is a digital lamp. The user can follow the instruction manual to control the digital lamp and play melodies with it. And also, the user can let the EUT to communicate with the corresponding wireless alarm clock by transceiving RF signal.

The Model : 77927 is the same as the Model : 77928 in hardware aspect. The models are difference in color only.

The brief circuit description is saved with filename : descri.pdf

1.2 Related Submittal(s) Grants

this is an application for certification of a transmitter portion. The receiver portion, associated with this transmitter, can be exempted from technical requirement of the FCC Part 15 Standard.

The wireless digital clock, associated with this EUT, has FCC ID: RS4-77923 and will be granted afterward.

#### 1.3 Test Methodology

Both AC mains line-conducted and radiated emission measurements were performed according to the procedures in ANSI C63.4 (2003). All measurements were performed in Open Area Test Sites. Preliminary scans were performed in the Open Area Test Sites only to determine worst case modes. All Radiated tests were performed at an antenna to EUT distance of 3 meters, unless stated otherwise in the "**Justification Section**" of this Application.

#### 1.4 Test Facility

The open area test site and conducted measurement facility used to collect the emission data is located at Garment Centre, 576 Castle Peak Road, Kowloon, Hong Kong. This test facility and site measurement data have been fully placed on file with the FCC.

# SYSTEM TEST CONFIGURATION

#### 2.0 System Test Configuration

#### 2.1 Justification

The system was configured for testing in a typical fashion (as a customer would normally use it), and in the confines as outlined in ANSI C63.4 (2003).

The EUT was powered by 4 new AA batteries or 120V AC to 7.5V DC adaptor during test.

For maximizing emissions, the EUT was rotated through 360°, the antenna height was varied from 1 meter to 4 meters above the ground plane, and the antenna polarization was changed. This step by step procedure for maximizing emissions led to the data reported in Exhibit 3.0.

The equipment under test (EUT) was configured for testing in a typical fashion (as a customer would normally use it). The EUT was placed on a turn table, which enabled the engineer to maximize emissions through its placement in the three orthogonal axes.

The frequency range from 9kHz to 25GHz was searched for spurious emissions from the device. Only those emissions reported were detected. All other emissions were at least 26 dB below the applicable limits.

#### 2.2 EUT Exercising Software

The EUT exercise program (if any) used during radiated testing was designed to exercise the various components in a similar to a typical use.

#### 2.3 Special Accessories

There are no special accessories necessary for compliance of this product.

#### 2.4 Equipment Modification

Any modifications installed previous to testing by Hasbro Far East Ltd. will be incorporated in each production model sold/leased in the United States.

No modifications were installed by Intertek Testing Services.

2.5 Measurement Uncertainty

When determining the test conclusion, the measurement uncertainty of test has been considered.

# **EMISSION RESULTS**

### 3.0 Emission Results

Data is included worst case configuration (the configuration which resulted in the highest emission levels). A sample calculation, configuration photographs and data tables of the emissions are included.

#### 3.1 Field Strength Calculation

The field strength is calculated by adding the reading on the Spectrum Analyzer to the factors associated with preamplifiers (if any), antennas, cables, pulse desensitization and average factors (when specified limit is in average and measurements are made with peak detectors). A sample calculation is included below.

FS = RA + AF + CF - AG + PD + AV

where FS = Field Strength in  $dB\mu V/m$ RA = Receiver Amplitude (including preamplifier) in  $dB\mu V$ CF = Cable Attenuation Factor in dB AF = Antenna Factor in dB AG = Amplifier Gain in dB PD = Pulse Desensitization in dB AV = Average Factor in -dB

In the radiated emission table which follows, the reading shown on the data table may reflect the preamplifier gain. An example of the calculations, where the reading does not reflect the preamplifier gain, follows:

FS = RA + AF + CF - AG + PD + AV

#### 3.1 Field Strength Calculation (cont'd)

#### Example

Assume a receiver reading of 62.0 dB $\mu$ V is obtained. The antenna factor of 7.4 dB and cable factor of 1.6 dB is added. The amplifier gain of 29 dB is subtracted. The pulse desensitization factor of the spectrum analyzer was 0 dB, and the resultant average factor was -10 dB. The net field strength for comparison to the appropriate emission limit is 32 dB $\mu$ V/m. This value in dB $\mu$ V/m was converted to its corresponding level in  $\mu$ V/m.

### 8.0 Miscellaneous Information

This miscellaneous information includes details of the measured bandwidth, the test procedure and calculation of factors such as pulse desensitization.

### 8.1 Measured Bandwidth

The plot saved in bw.pdf which shows the fundamental emission is confined in the specified band. And it also shows that the emission is at least 42 dB below the carrier level at the band edge (2400 and 2483.5 MHz). Emissions radiated outside of the specified frequency bands, except harmonics, are attenuated by 50 dB below the level of the fundamental or to the general radiated emission limits in Section 15.209, whichever is the lesser attenuation. It meets the requirement of Section 15.249(d).

Peak Measurement

Bandedge compliance is determined by applying marker-delta method, i.e (Plot A and Plot B).

Resultant field strength= Fundamental emissions (peak value) - delta from the plot A

= 93.6dBµV/m - 42dB

= 51.6dBµV/m

- Resultant field strength= Fundamental emissions (peak value) delta from the plot B
  - = 93.5BµV/m 50dB
  - = 43.5dBµV/m

The resultant field strength meets the general radiated emission limit in section 15.209, which does not exceed 74dB $\mu$ V/m (Peak Limit) and 54dB $\mu$ V/m (Average Limit).

Pursuant to FCC Part 15 Section 15.215(c), the 20dB bandwidth of the emission was contained within the frequency band designated (mentioned as above) which the EUT operated. The effects, if any, from frequency sweeping, frequency hopping, other modulation techniques and frequency stability over excepted variations in temperature and supply voltage were considered.

### 8.2 Discussion of Pulse Desensitization

The determination of pulse desensitivity was made in accordance with Hewlett Packard Application Note 150-2, *Spectrum Analysis ... Pulsed RF.* 

The effective period ( $T_{eff}$ ) was approximately 110 µs for a digital "1" bit. With a resolution bandwidth (3 dB) of 1 MHz, the pulse desensitivity factor was 0 dB.

### 8.3 Emissions Test Procedures

The following is a description of the test procedure used by Intertek Testing Services in the measurements of transmitters operating under Part 15, Subpart C rules.

The test set-up and procedures described below are designed to meet the requirements of ANSI C63.4 - 2003.

The transmitting equipment under test (EUT) is placed on a wooden turntable which is four feet in diameter and approximately one meter in height above the ground plane. During the radiated emissions test, the turntable is rotated and any cables leaving the EUT are manipulated to find the configuration resulting in maximum emissions. The EUT is adjusted through all three orthogonal axes to obtain maximum emission levels. The antenna height and polarization are varied during the testing to search for maximum signal levels.

The frequency range scanned is from the lowest radio frequency signal generated in the device which is greater than 9 kHz to the tenth harmonic of the highest fundamental frequency or 40 GHz, whichever is lower. For line conducted emissions, the range scanned is 150 kHz to 30 MHz.

### 8.3 Emissions Test Procedures (cont'd)

The EUT is warmed up for 15 minutes prior to the test.

AC power to the unit is varied from 85% to 115% nominal and variation in the fundamental emission field strength is recorded. If battery powered, a new, fully charged battery is used.

Conducted measurements are made as described in ANSI C63.4 - 2003.

The IF bandwidth used for measurement of radiated signal strength was 10 kHz for emission below 30 MHz and 120 kHz for emission from 30 MHz to 1000 MHz.

Above 1000 MHz, a resolution bandwidth of 1 MHz is used.

Transmitter measurements are normally conducted at a measurement distance of three meters. However, to assure low enough noise floor in the restricted bands and above 1 GHz, signals are acquired at a distance of one meter or less. All measurements are extrapolated to three meters using inverse scaling, but those measurements taken at a closer distance are so marked.
