

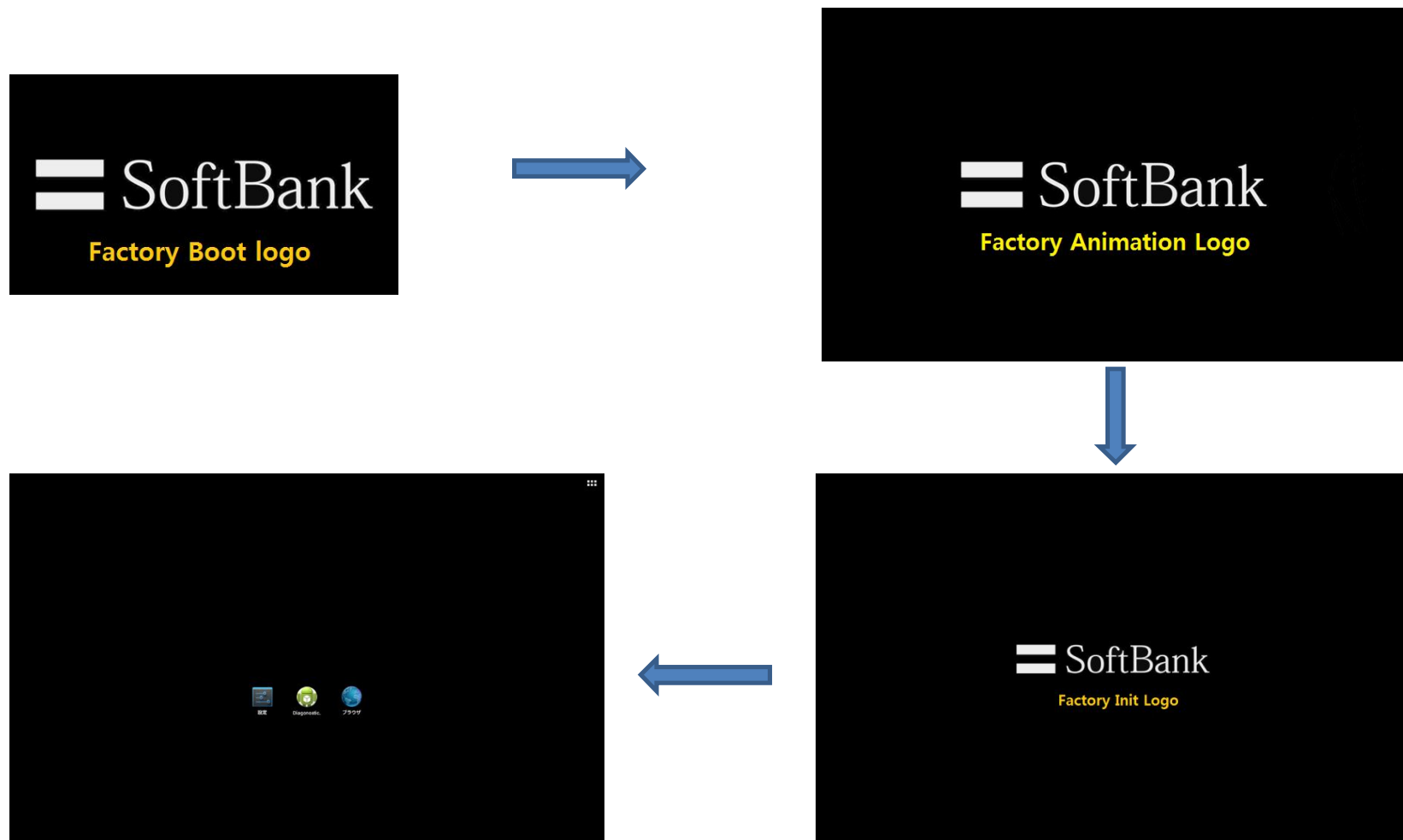

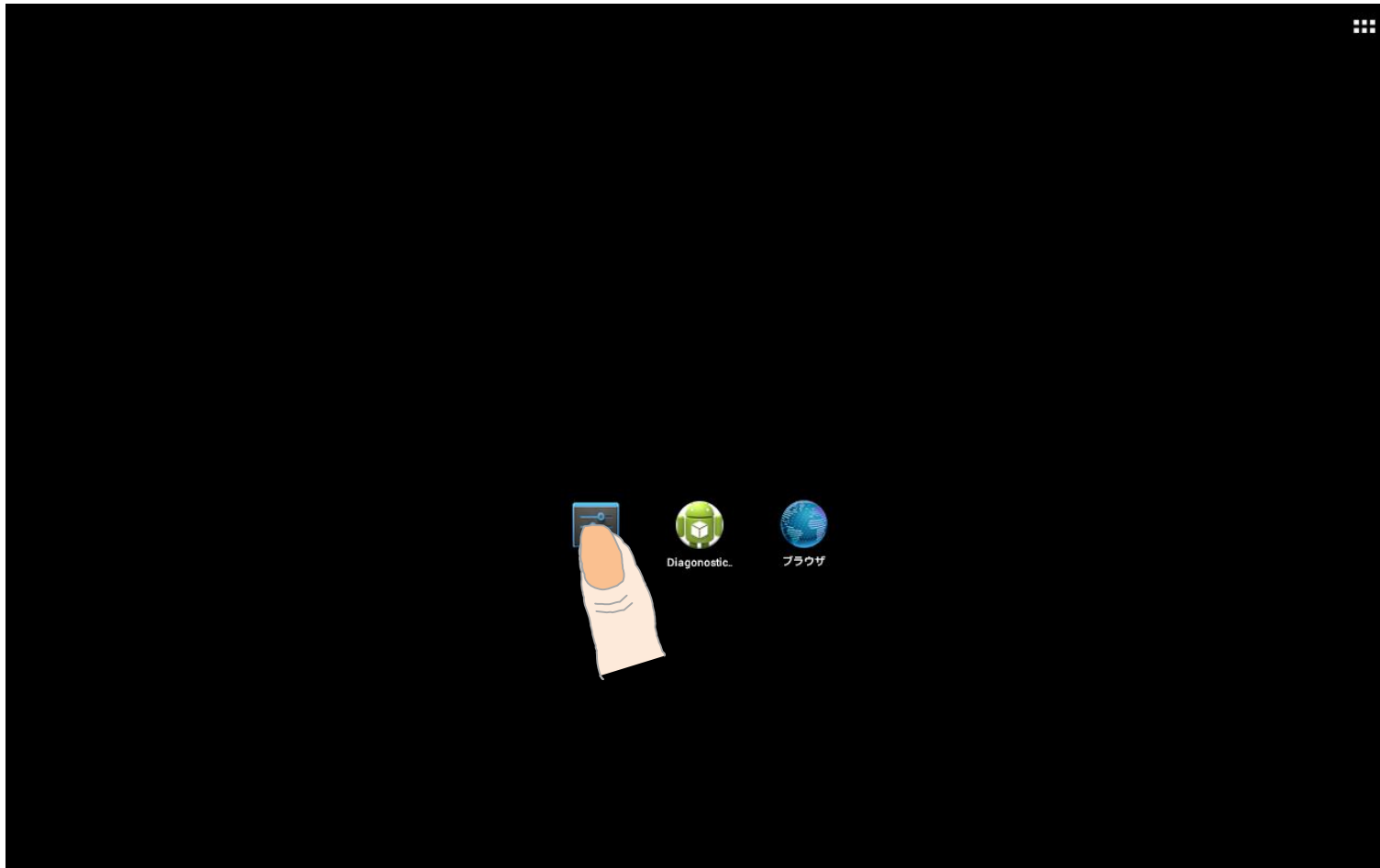
1. Booting

1. Download verification OS, and check logo for verification OS.



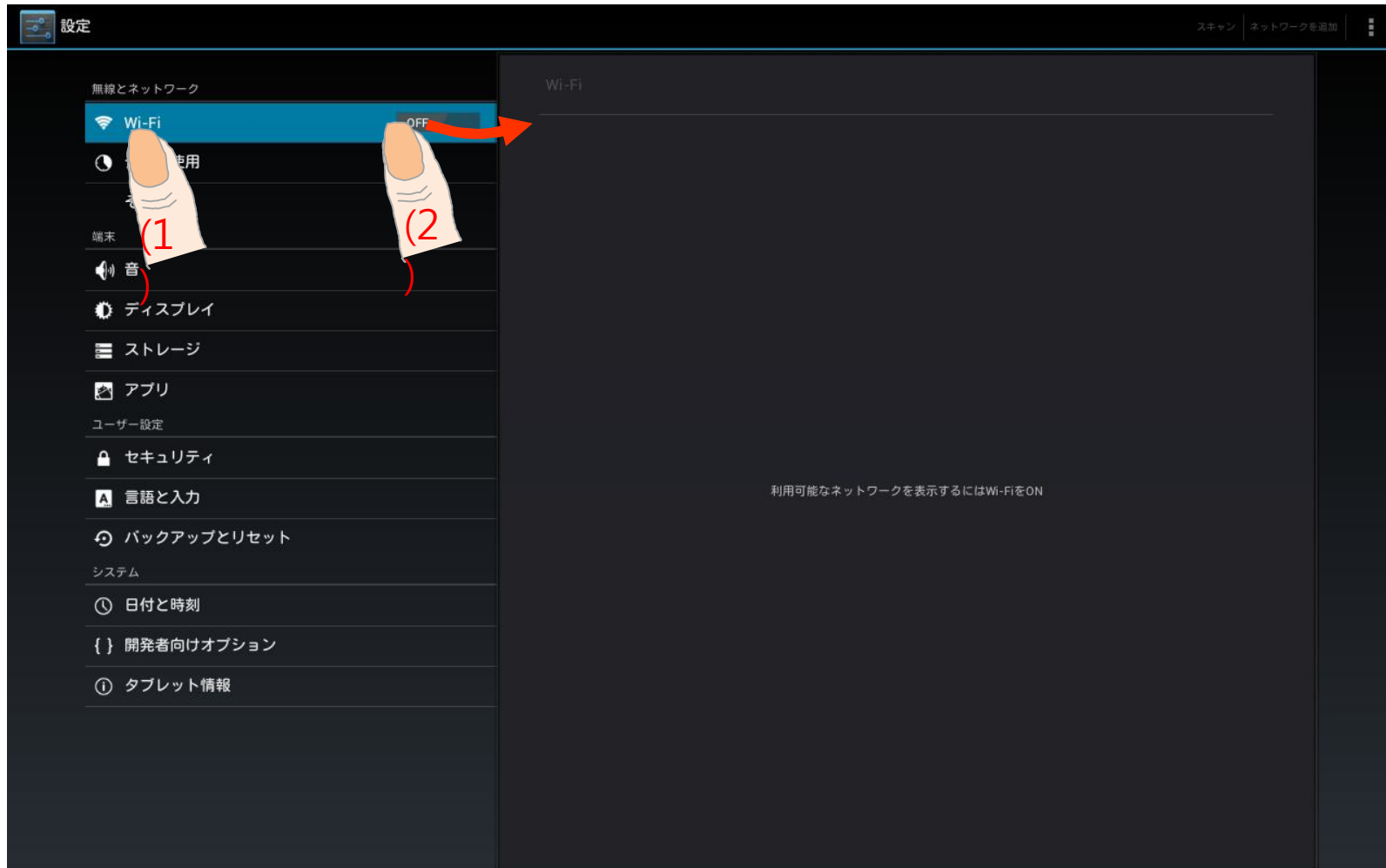
2. Setting (1/7)

2. Select 'WiFi (1)', and move button from OFF to ON (2).



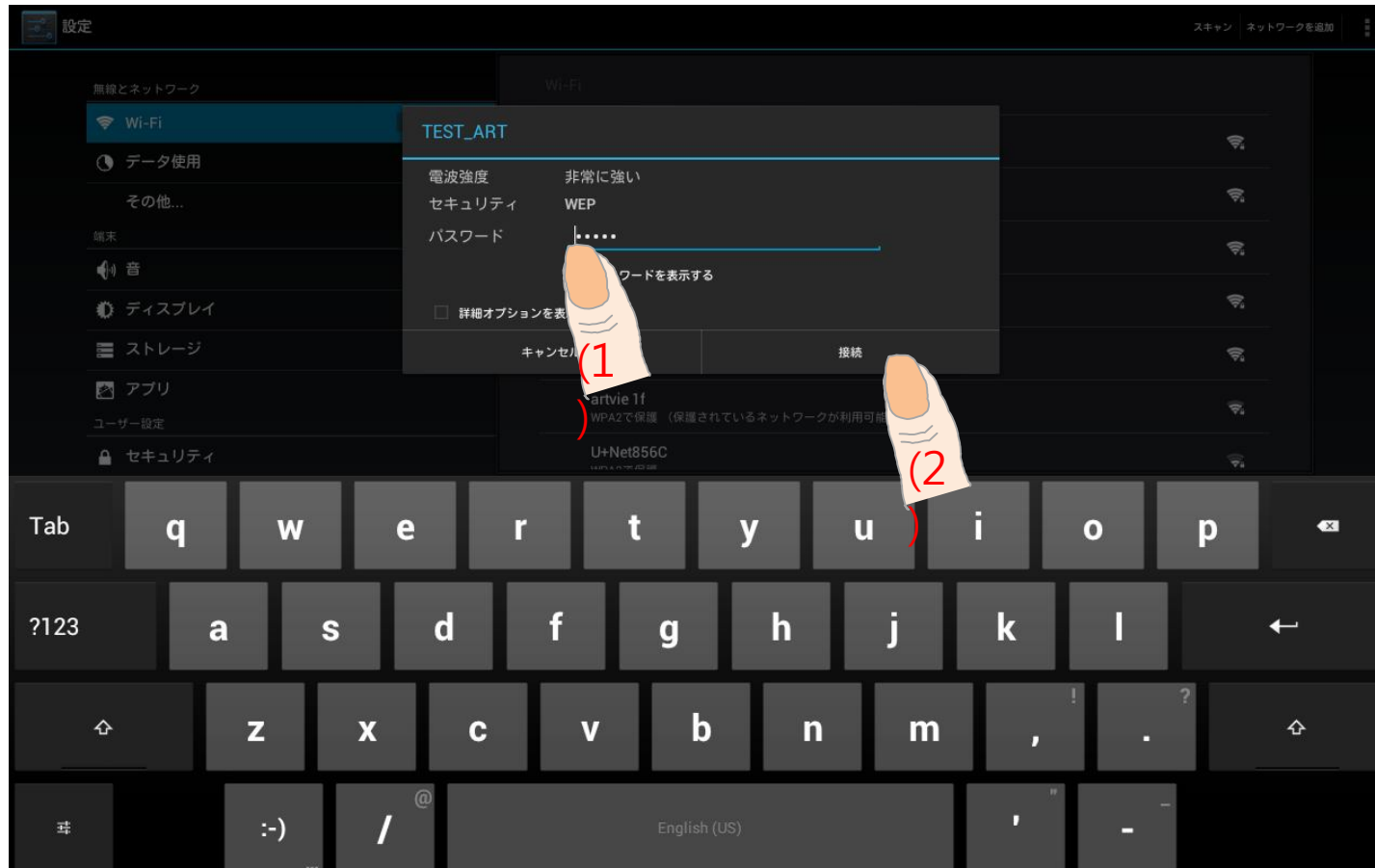
2. Setting (3/7)

6. Screen of the AP connection complete.



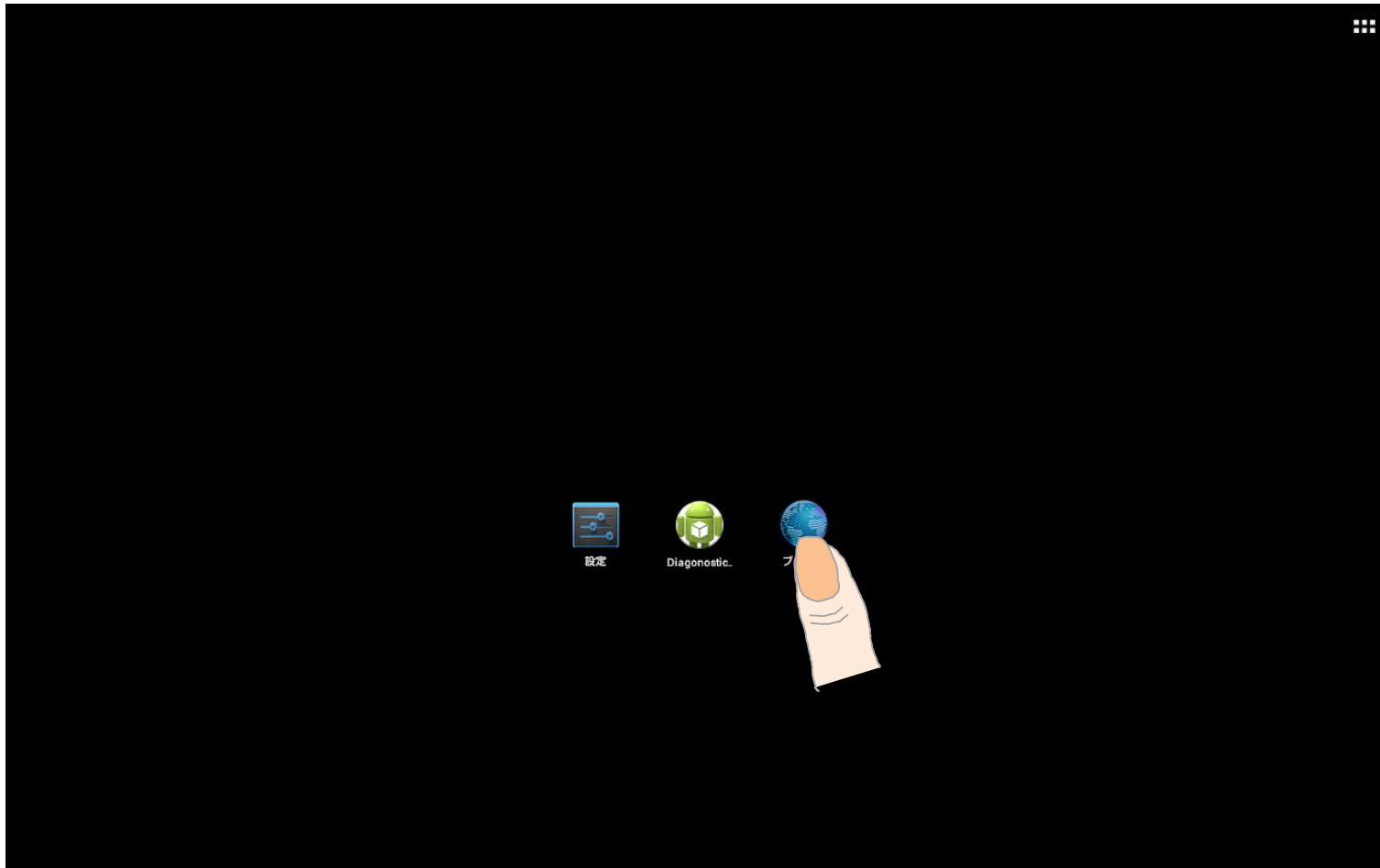
2. Setting (7/7)

7. When the connection is completed, press the "HOME" button, and go to the main screen, .



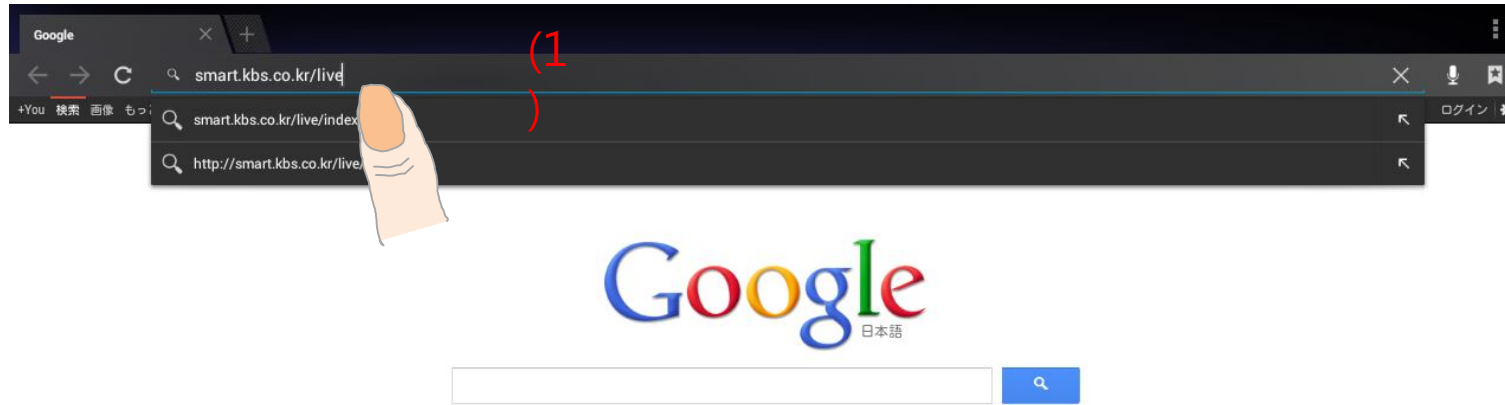
3. Wi-Fi (1/5)

8. Run by selecting the "Browser" icon on the Home screen.



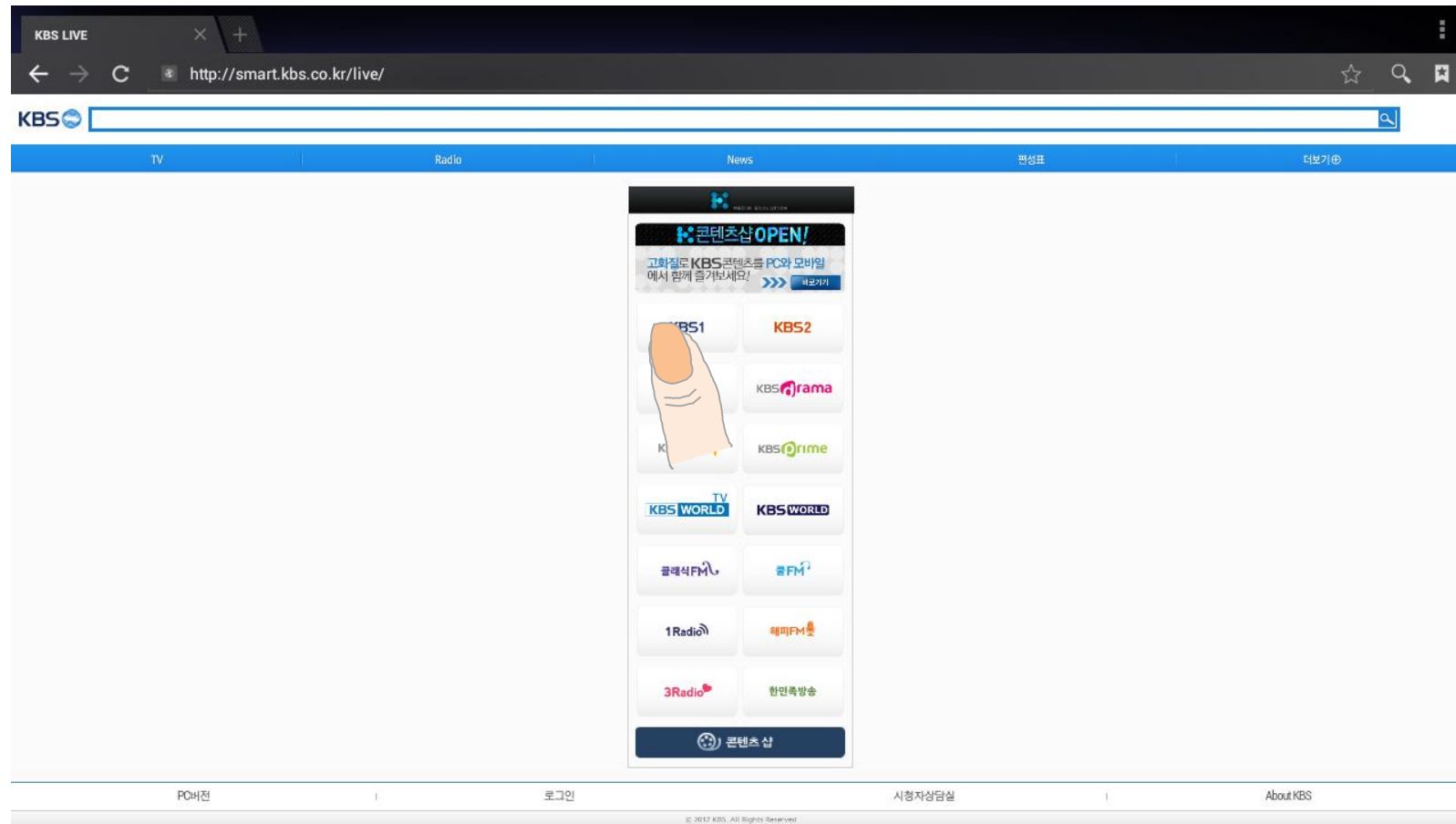
3. Wi-Fi (2/5)

9. Click your web browser address bar (1), and enter "smart.kbs.co.kr/live".



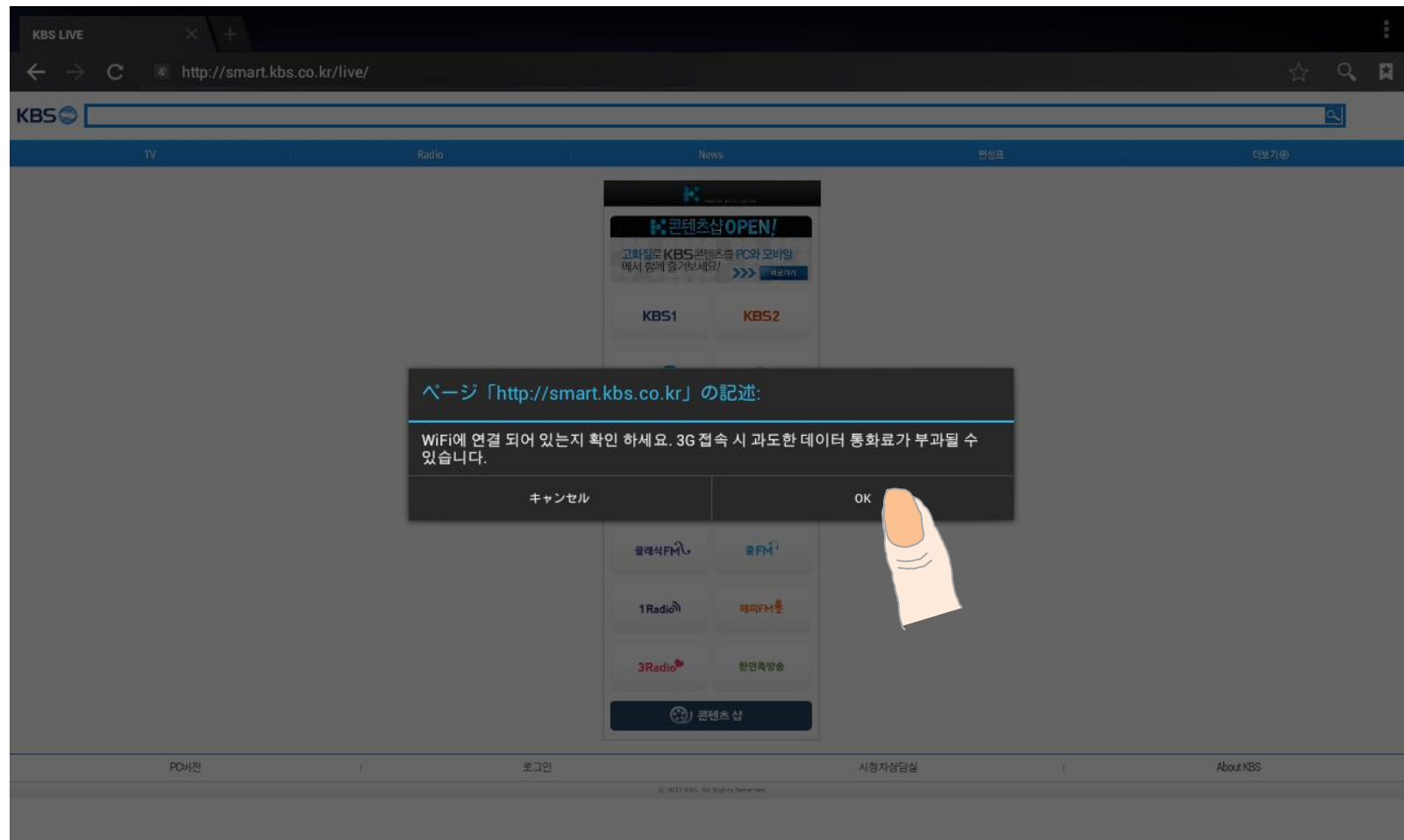
3. Wi-Fi (3/5)

12. Check that broadcasting is normal during 12 hours.
