3. TEST METHODOLOGY

The tests documented in this report were performed in accordance with ANSI C63.4. Radiated

testing was performed at an antenna to EUT distance 3 meters.

3.1 EUT CONFIGURATION

The EUT configuration for testing is installed on RF field strength measurement to meet the

Commissions requirement and operating in a manner that intends to maximize its emission

characteristics in a continuous normal application.

3.2 EUT EXERCISE

The EUT was operated in the engineering mode to fix the Tx frequency that was for the purpose of








Test Plot

Peak Power (CH Low)




Peak Power (CH Mid)





Peak Power (CH High)








PPSD (CH Mid)




Detector mode: Average Polarity: Vertical






Detector mode: Peak Polarity: Horizontal



Test Plot 20 dB bandwidth






Test Plot CH Low


