











## 5.1.7.2. Radiated Spurious Emissions - 30MHz - 1000MHz

FCC, Part 15 Subpart C §15.205/ §15.209 Industry Canada RSS-210 §2.2

#### **Test Procedure**

Testing 30M-1 GHz was performed in a 3-meter anechoic chamber using a CISPR compliant receiver. Preliminary radiated emissions were measured on every azimuth and with the receiving antenna in both horizontal and vertical polarizations. To further maximize emissions the receive antenna was varied between 1 and 4 meters. The emissions are recorded with receiver in peak hold mode. Emissions closest to the limits are measured in the quasi-peak mode with the tuned receiver using a bandwidth of 120 kHz. Only the highest emissions relative to the limit are listed. The anechoic chamber test set-up is identified in Section 6 Test Set-Up Photographs.

The EUT had two methods of powering on ac/dc converter and Power over Ethernet (POE). Both modes were tested for emissions below 1GHz.

#### **Field Strength Calculation**

The field strength is calculated by adding the Antenna Factor and Cable Loss, and subtracting Amplifier Gain from the measured reading. In this test facility, the Antenna Factor, Cable Loss, and Amplifier Gains are loaded into the Rohde & Schwarz Receiver and the corrected field strength can be read directly on the receiver.

FS = R + AF + CORR

where:

FS = Field Strength
R = Measured Receiver Input Amplitude
AF = Antenna Factor
CORR = Correction Factor = CL – AG + NFL
CL = Cable Loss
AG = Amplifier Gain

### For example:

Given a Receiver input reading of  $51.5dB_{\mu}V$ ; Antenna Factor of 8.5dB; Cable Loss of 1.3dB; Falloff Factor of 0dB, an Amplifier Gain of 26dB and Notch Filter Loss of 1dB. The Field Strength of the measured emission is:

 $FS = 51.5 + 8.5 + 1.3 - 26.0 + 1 = 36.3 dB_{\mu}V/m$ 

Conversion between  $dB\mu V/m$  (or  $dB\mu V$ ) and  $\mu V/m$  (or  $\mu V$ ) are done as:

Level (dB $\mu$ V/m) = 20 \* Log (level ( $\mu$ V/m))

40 dB $\mu$ V/m = 100 $\mu$ V/m 48 dB $\mu$ V/m = 250 $\mu$ V/m



## Radiated Emission Measurement Setup - Below 1 GHz









# 6.1. Radiated Test Setup Below 1 GHz - Test Setup





# 6.2. Radiated Emissions Above 1 GHz - Test Setup




