
Photograph of the Tissue Simulant Fluid Liquid (Head & Body)






Fig.3 Right Head Section / Cheek-Touch Position







Fig.4 Right Head Section / Ear-Tilt Position(15°)






Fig.5 Left Head Section / Cheek-Touch Position




Fig.7 EUT Front side to flat phantom






Fig.8 EUT Back side to flat phantom




Fig.9 EUT Front side to flat phantom






Fig.10 EUT Back side to flat phantom






Fig.11 EUT Bottom side to flat phantom




Fig.12 EUT Top side to flat phantom






Fig.13 EUT Left side to flat phantom






Fig.14 EUT Right side to flat phantom




Fig.15 EUT Back side to flat phantom







Fig.16 EUT Front side to flat phantom






Fig.17 EUT Top side to flat phantom




Fig.18 EUT Bottom side to flat phantom






Fig.19 EUT Right side to flat phantom




Fig.23 Antenna position of EUT
