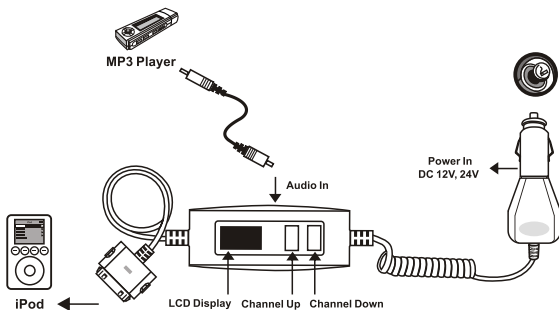


# **Cigarette Lighter FM Transmitter for iPod**

**User instruction**

1. Connect to the cigarette adapter through car plug then backlight LED will display the channel while the car is in the mode of ACC ON or engine start.
2. Dock connector is for audio input and iPod charger while connecting with iPod or iPod mini.  
Stereo jack is for audio in devices such as mp3 player, CD player, or iPod shuffle.
3. Turn on the FM transmitter.
4. Select channel by + button or – button, 200KHz step once. Forward or rewind during selecting process and release it at the desired channel.
5. Tune in the FM radio for the channel you select.

**Tips and Trouble Shooting**

If you experience poor sound quality or distorted sound through FM radio.

This usually happens when your iPod battery level is low or exhausted.

Please allow battery to charge for a while before playing. Best sound quality can be played if iPod battery is fully charged.
