Test Procedures

- a. The EUT was placed 0.4 meters from the conducting wall of the shielded room with EUT being connected to the power mains through a line impedance stabilization network (LISN). Other support units were connected to the power mains through another LISN. The two LISNs provide 50 ohm/ 50uH of coupling impedance for the measuring instrument.
- b. Both lines of the power mains connected to the EUT were checked for maximum conducted interference.
- c. The frequency range from 150kHz to 30MHz was searched. Emission levels under (Limit - 20dB) was not recorded.

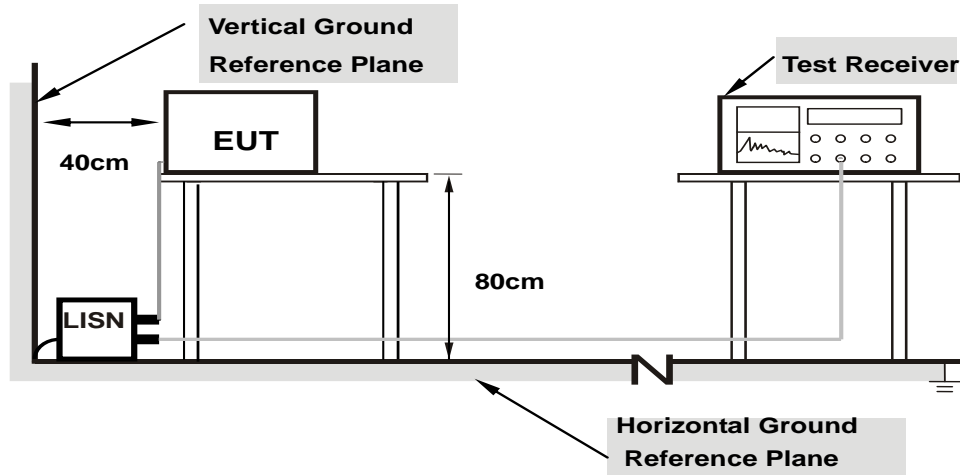

4. Test data of Margin(dB) = Result value (dBuV) - Limit value (dBuV).
5. Test data of Correction Factor (dB) = Insertion loss(dB) + Cable loss(dB).

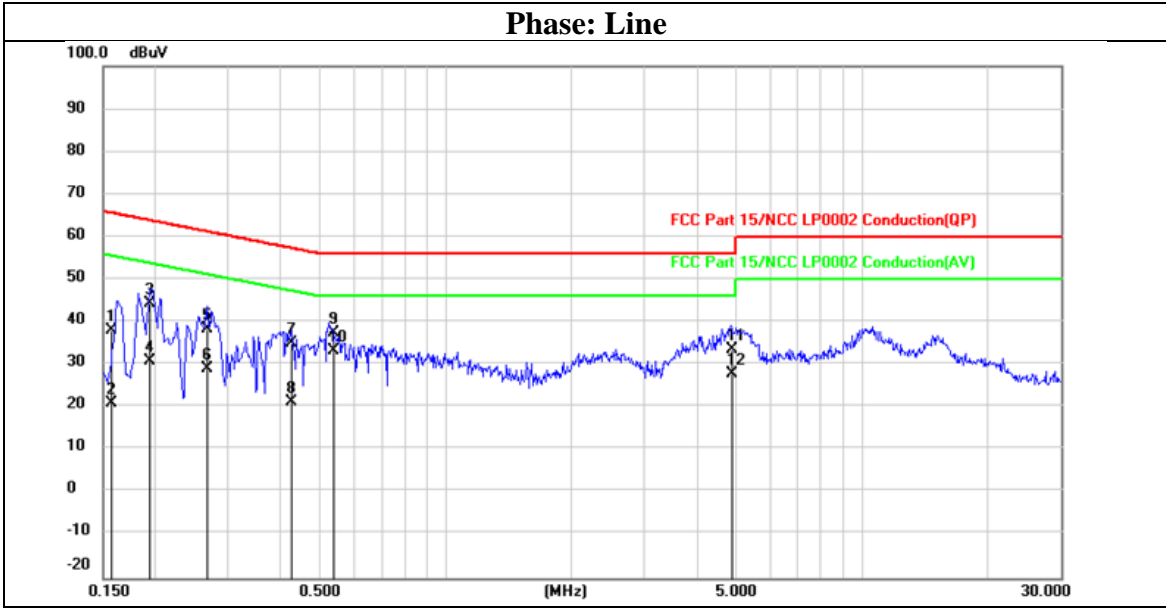

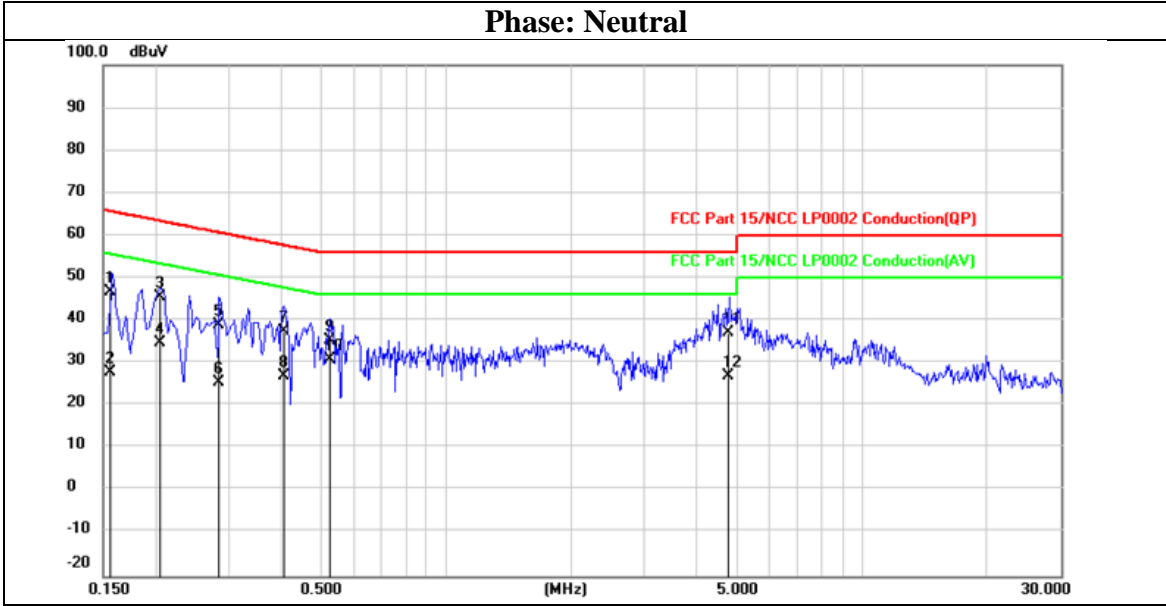
