






20 dB Bandwidth Plot on Channel 0 / 2402 MHz






DH5 Dwell Time Plot on Channel 0 / 2402 MHz






DH1 Dwell Time Plot on Channel 0 / 2402 MHz

DH5 Dwell Time Plot on Channel 39 / 2441 MHz






DH3 Dwell Time Plot on Channel 39 / 2441 MHz

DH1 Dwell Time Plot on Channel 39 / 2441 MHz






DH5 Dwell Time Plot on Channel 78 / 2480 MHz







4.8. Antenna Requirements

4.8.1. Limit
