





#### 2.1 Safety Precautions




#### 2.2 Quick Tour of the MedPC-6200

Before you start to set up MedPC-6200, take a moment to become familiar with the locations and purposes of the controls, drives, connections and ports, which are illustrated in the figures below.

When you place MedPC-6200 on the desktop, its top cover appears as shown in Picture 2-1. When you turn the MedPC-6200 to the back side, the I/O includes four USB and one Ethernet and two dipole antennas for WiFi and BT connectivity, shown in Picture 2-2.




Picture 2.1: Top View of the MedPC-6200

#### 2.3 Turn On and Boot up into Windows and Android OS

Your MedPC-6200 will begin loading Windows/Android OS once you push the power button to turn power on. After less than one minute, Windows/Android desktop screen will appear.
