



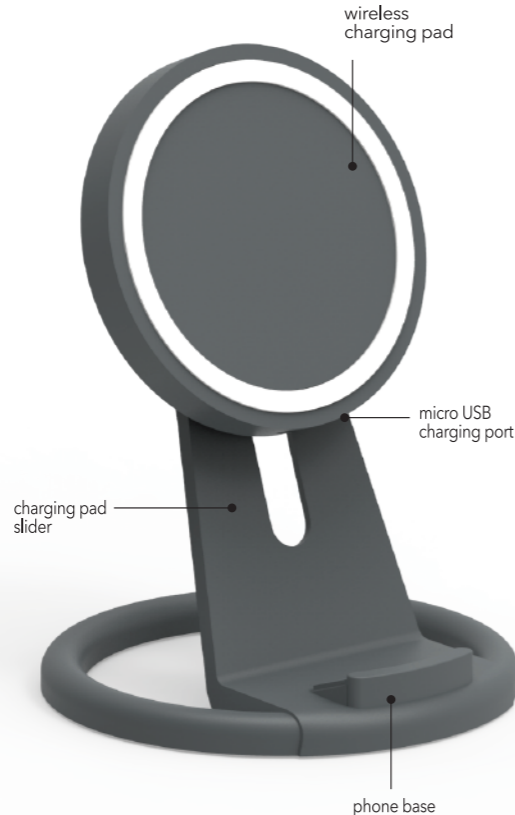

USING THE WIRELESS CHARGER PHONE STAND

1. Connect the micro USB cable to the micro USB port on the charging pad
2. Plug the USB connector into a USB power adapter (not included)
3. Place your smartphone on the phone base either horizontally or vertically and slide the charging pad to the center of your phone. Your device will indicate it is charging.
4. If your wireless-enabled phone does not indicate it is charging, adjust the position of your phone and/or the pad slightly until it does.
