
- comply with the relevant provisions of the certification program;


FCC and IC Confidentiality Request

In accordance with 0.459 & 0.457 of CFR 47, please, accept this letter as an official request to have the schematics, block diagram operational description and the photographs of all portions of the EUT that are contained within the shielded castings of DBHB-20 treated as confidential.

The information contained within is a result of extensive investment and development effort by Shyam Telecom, inc. and its disclosure will compromise Shyam Telecom's Intellectual Property and competitive edge. We thus ask the FCC and IC **NOT** to publish the enclosed information including Schematics, Block diagram, operational description and the photographs of all portions of the EUT that are contained within the shielded castings, in order to protect Shyam Telecom Inc.'s Intellectual Property.

The internal photos could reveal to a competitor certain proprietary design and manufacturing techniques, which differentiate our products from those of other vendors.
