# **System Test Configuration**

# **EUT Configuration**

The EUT configuration for testing is installed on RF field strength measurement to meet the Commissions requirement and operating in a manner which intends to maximize its emission characteristics in a continuous normal application.

#### 2.2 **EUT Exercise**

An engineering test mode (software/firmware) that applicant provided was utilized to manipulate the EUT into transmit, selection of the test channel, and modulation scheme.

#### 2.3 **Test Procedure**

## 2.3.1 Conducted Emissions

The EUT is a placed on as turn table which is 0.8 m above ground plane. According to the general criterion in Section 7.1 of ANSI C63.4:2009 and RSS-Gen:2010. Conducted emissions from the EUT measured in the frequency range between 0.15 MHz and 30MHz, and the measurement procedure 7.3 in ANSI 63.4:2009 is followed to carry out the test. The CISPR Quasi-Peak and Average detector mode is employed according to §15.107

## 2.3.2 Radiated Emissions

The EUT is a placed on as turn table which is 0.8 m above ground plane. The turn table shall rotate 360 degrees to determine the position of maximum emission level. EUT is set 3m away from the receiving antenna which varied from 1m to 4m to find out the highest emission. And also, each emission was to be maximized by changing the polarization of receiving antenna both horizontal and vertical. In order to find out the max. emission, the relative positions of this hand-held transmitter (EUT) was rotated through three orthogonal axes and measurement procedures for electric field radiated emissions above 1 GHz the EUT measurement is to be made "while keeping the antenna in the 'cone of radiation' from that area and pointed at the area both in azimuth and elevation, with polarization oriented for maximum response." is still within the 3dB illumination BW of the measurement antenna according to the requirements in Section 8 and 13 and of ANSI C63.4:2009 and RSS-Gen:2010.





# ANTENNA REQUIREMENT

# **Standard Applicable:**

According to §15.203, Antenna requirement.

An intentional radiator shall be designed to ensure that no antenna other than that furnished by the responsible party shall be used with the device. The use of a permanently attached antenna or of an antenna that uses a unique coupling to the intentional radiator shall be considered sufficient to comply with the provisions of this Section. The manufacturer may design the unit so that a broken antenna can be replaced by the user, but the use of a standard antenna jack or electrical connector is prohibited. This requirement does not apply to carrier current devices or to devices operated under the provisions of Sections 15.211, 15.213, 15.217, 15.219, or 15.221. Further, this requirement does not apply to intentional radiators that must be professionally installed, such as perimeter protection systems and some field disturbance sensors, or to other intentional radiators which, in accordance with Section 15.31(d), must be measured at the installation site. However, the installer shall be responsible for ensuring that the proper antenna is employed so that the limits in this Part are not exceeded.

According to RSS-GEN 7.1.2, a transmitter can only be sold or operated with antennas with which it was certified. A transmitter may be certified with multiple antenna types. An antenna type comprises antennas having similar in-band and out-of-band radiation patterns. Testing shall be performed using the highest-gain antenna of each combination of transmitter and antenna type for which certification is being sought, with the transmitter output power set at the maximum level. Any antenna of the same type and having equal or lesser gain as an antenna that had been successfully tested for certification with the transmitter, will also be considered certified with the transmitter, and may be used and marketed with the transmitter. The manufacturer shall include with the application for certification a list of acceptable antenna types to be used with the transmitter

When a measurement at the antenna connector is used to determine RF output power, the effective gain of the device's antenna shall be stated, based on measurement or on data from the antenna manufacturer.

For transmitters of RF output power of 10 milliwatts or less, only the portion of the antenna gain that is in excess of 6 dBi (6 dB above isotropic gain) shall be added to the measured RF output power to demonstrate compliance with the radiated power limits specified in the applicable standard. For transmitters of output power greater than 10 milliwatts, the total antenna gain shall be added to the measured RF output power to demonstrate compliance to the specified radiated power limits.
