# 1 General Information

## 1.1 Product Description for Equipment under Test (EUT)

This test and measurement report has been compiled on behalf of *Mobile Communications, Inc.* and their product model: BRM220-50, FCC ID: S4RBM22050, which will be henceforth in this report referred to as the EUT (Equipment Under Test). The EUT is a Cellular/PCS Dual-band, bi-directional booster/amplifier.

## 1.2 Mechanical Description

The EUT measures approximately 160mm (L) x 90mm (W) x 25mm (H), and weighs approximately 454 g. *The test data gathered are from typical production sample, serial number: 1000000 provided by the Manufacturer.*

## 1.3 Objective

This type approval report is prepared on behalf of *Mobile Communications, Inc.* in accordance with Part 2, Subpart J, Part 22 Subpart H, and Part 24 Subpart E of the Federal Communication Commissions rules.

The objective is to determine compliance with FCC rules for RF output power, modulation characteristics, occupied bandwidth, spurious emissions at antenna terminal, field strength of spurious radiation, frequency stability, band edge, and conducted and radiated margin.

## 1.5 Test Methodology

All tests and measurements indicated in this document were performed in accordance with the Code of Federal Regulations Title 47 Part 2, Sub-part J as well as the following parts:

Part 20.21 – Signal Boosters  
Part 22 Subpart H - Cellular Radiotelephone Service  
Part 24 Subpart E – Broadband PCS

Applicable Standards: TIA/EIA603-C, ANSI C63.4-2009.

All radiated and conducted emissions measurement was performed at Bay Area Compliance Laboratory, Corp. The radiated testing was performed at an antenna-to-EUT distance of 3 meters.

## 1.6 Measurement Uncertainty

All measurements involve certain levels of uncertainties, especially in the field of EMC. The factors contributing to uncertainties are spectrum analyzer, cable loss, antenna factor calibration, antenna directivity, antenna factor variation with height, antenna phase center variation, antenna factor frequency interpolation, measurement distance variation, site imperfections, mismatch (average), and system repeatability.

Based on CISPR16-4-2:2011, The Treatment of Uncertainty in EMC Measurements, the values ranging from  $\pm 2.0$  dB for Conducted Emissions tests and  $\pm 4.0$  dB for Radiated Emissions tests are the most accurate estimates pertaining to uncertainty of EMC measurements at BA CL Corp.

## 1.7 Test Facility

Bay area compliance Laboratories Corp. (BA CL) is:

1- An independent Commercial Test Laboratory accredited to **ISO 17025: 2005** by **A2LA**, in the fields of: Electromagnetic Compatibility & Telecommunications covering Emissions, Immunity, Radio, RF Exposure, Safety and Telecom. This includes NEBS (Network Equipment Building System), Wireless RF, Telecommunications Terminal Equipment (TTE); Network Equipment; Information Technology Equipment (ITE); Medical Electrical Equipment; Industrial, Commercial, and Medical Test Equipment; Professional Audio and Video Equipment; Electronic (Digital) Products; Industrial and Scientific Instruments; Cabled Distribution Systems and Energy Efficiency Lighting.

The test site at BA CL Corp. has been fully described in reports submitted to the Federal Communication Commission (FCC) and Voluntary Control Council for Interference (VCCI). The details of these reports have

been found to be in compliance with the requirements of Section 2.948 of the FCC Rules on February 11 and December 10, 1997, and Article 8 of the VCCI regulations on December 25, 1997. The test site also complies with the test methods and procedures set forth in CISPR 22:2008 §10.4 for measurements below 1 GHz and §10.6 for measurements above 1 GHz as well as ANSI C63.4-2009, ANSI C63.4-2009, TIA/EIA-603 & CISPR 24:2010.

The Federal Communications Commission and Voluntary Control Council for Interference have the reports on file and they are listed under FCC registration number: 90464 and VCCI Registration No.: A-0027. The test site has been approved by the FCC and VCCI for public use and is listed in the FCC Public Access Link (PAL) database.

### 4.3 Test Result

The device complies with the MPE requirements by providing a safe separation distance of 20 cm between the antenna, including any radiating structure, and any persons when normally operated based on the maximum antenna gain of 7.14. The proposed RF exposure safety information has been included in the User's Manual.

**4.4 Applicable Standard**

Requirements: FCC §2.1053, §22.917, §24.238.

**4.5 Test Procedure**

The transmitter was placed on a wooden turntable, and it was transmitting into a non-radiating load which was also placed on the turntable.

The measurement antenna was placed at a distance of 3 meters from the EUT. During the tests, the antenna height and polarization as well as EUT azimuth were varied in order to identify the maximum level of emissions from the EUT. The test was performed by placing the EUT on 3-orthogonal axis.

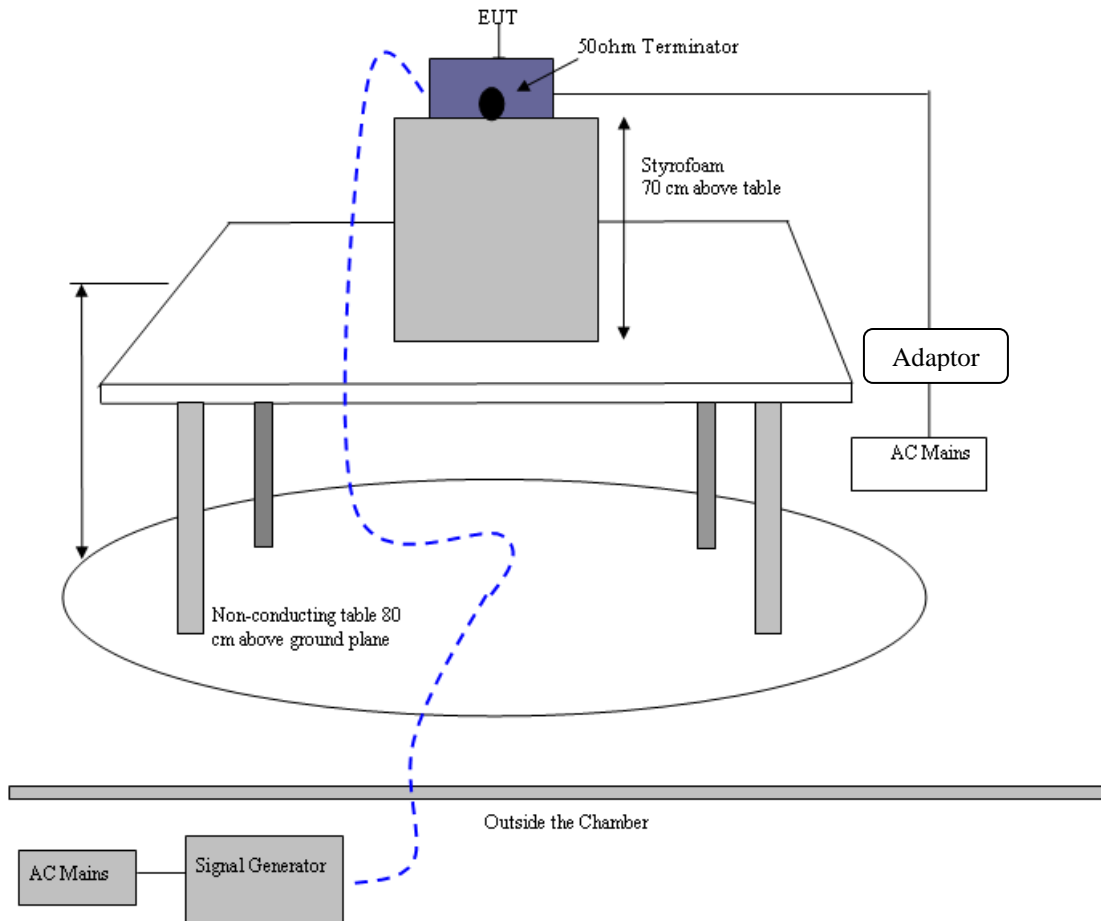
The frequency range up to tenth harmonic of the fundamental frequency was investigated.

Remove the EUT and replace it with substitution antenna. A signal generator was connected to the substitution antenna by a non-radiating cable. The absolute levels of the spurious emissions were measured by the substitution.

Spurious emissions in dB =  $10 \lg(\text{TXpwr in Watts}/0.001)$  – the absolute level

Spurious attenuation limit in dB =  $43 + 10 \text{Log}_{10}(\text{power out in Watts})$
