#### **Taking Sobriety Test**

- 1. Device will alert for testing with 3 beep tones.
- 2. Tap display screen on **SoberTrack.** Screen will indicate: "Sobriety Test Required Now. Insert Straw and Tap Below to Begin".
- 3. Click green **GO** arrow. Screen will display, "Preparing Sobriety Test, Please Wait".
- 4. Display will read "blow into tube until buzzer". Device will give a short beep when ready to start the test.
- 5. Stop when device sounds again.
