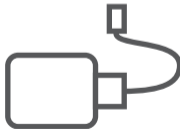

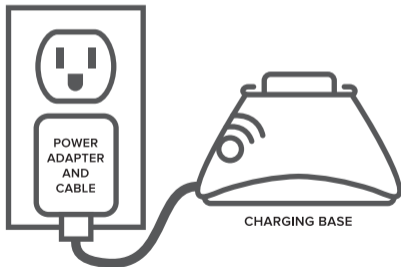


POWER ADAPTER AND CABLE

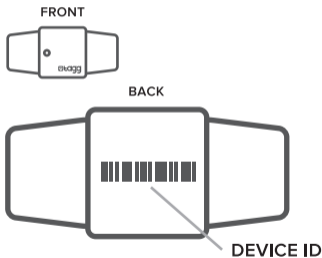

Go to login.pettracker.com to activate your device.

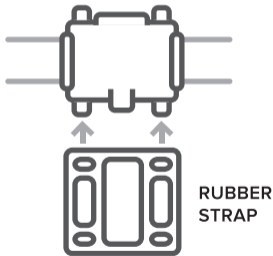
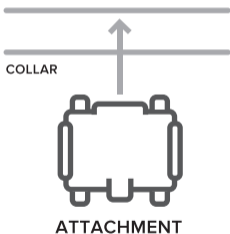


Attach Tagg to your pet's collar

- 1 | Place attachment on top of collar.

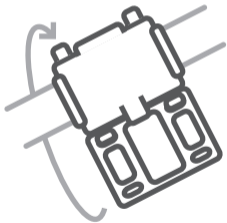
- 2 | Attach strap onto hooks on one side of attachment.

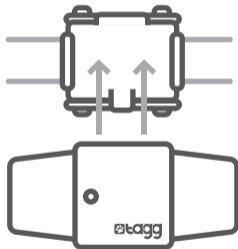
Note: Multiple strap sizes are provided—the clear strap is for small collars and gray is for large collars.

- 3** | Stretch strap under collar to attach onto hooks on second side of attachment.



CAUTION: It may take some force to stretch the strap all the way. Do not use other tools or devices as this may cause damage.

- 4** | Slide Tagg tracker onto attachment until it locks in place.

INDICATOR LIGHT

Solid blue: Battery is fully charged.

Flashing blue: Battery is charging (may take up to 60 seconds to start flashing).

Flashing blue/red: Tracker is being paged, or is actively tracking your pet.

Flashing red: Battery is low.

VACATION MODE BUTTON

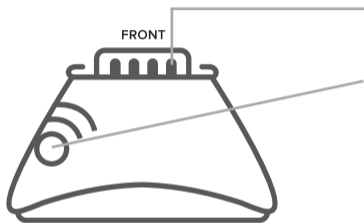
Tap once to put the tracker in "Vacation mode" to pause alerts when you leave home together.

POWER BUTTON

Press and hold to turn on/off.

Tap once to check battery level.

Charging base



CHARGING PINS

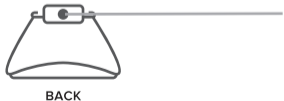
Align with charging contact on tracker.

INDICATOR LIGHT

Blue: Connected to power source.

Red: Software upgrade in progress. Do not remove tracker from base during this process.

Flashing blue/red: Tracker is being paged, or is actively tracking your pet.



PAGE BUTTON

Tap once to locate the tracker when it's near the docking station.

Helpful information

OPTIMIZE SIGNAL PERFORMANCE

- Place the charging base indoors, in an open area away from metal appliances.
- Do not attach your Tagg to metal collars, spiked collars, or collars with studs, jewels, or other raised adornments.

MAXIMIZE BATTERY LIFE

- Leave the charging base plugged in and positioned near the area where your pet spends most of its time.
- When your tracker is near the charging base, it automatically enters power saving mode.
