






Photograph of the Tissue Simulant Fluid Liquid Depth





















Fig.3 EUT Front side to flat phantom






Fig.4 EUT Back side (WWAN) to flat phantom






Fig.5 EUT Back side (WLAN Main) to flat phantom







Fig.6 EUT Back side (WLAN Aux) to flat phantom






Fig.7 EUT Top side to flat phantom






Fig.8 EUT Bottom side to flat phantom






Fig.9 EUT Right side to flat phantom






Fig.10 EUT Left side to flat phantom




Fig.13 Antenna position of EUT (Back view & Right view)
