




Fig.3 Right Head Section / Cheek-Touch Position

Fig.6 Left Head Section / Ear-Tilt Position(15°)






Fig.7 EUT front to flat phantom






Fig.8 EUT back to flat phantom




Fig.17 Antenna position of EUT
