# 2. EUT DESCRIPTION

The EUT is an 802.11a/b/g Access Point employs two transmitters and three receivers on each of two radio cards.

The transmitter has a maximum peak conducted output power as follows:

The radio utilizes five identical external dipole antennas for diversity, each with a maximum gain of 2dBi in 2.4GHz band and 3dBi in 5.8GHz band.

### 3. TEST METHODOLOGY

The tests documented in this report were performed in accordance with ANSI C63.4/2001, FCC CFR 47 Part 2 and FCC CFR 47 Part 15.

## 4. FACILITIES AND ACCREDITATION

The test sites and measurement facilities used to collect data are located at 561F Monterey Road, Morgan Hill, California, USA. The sites are constructed in conformance with the requirements of ANSI C63.4, ANSI C63.7 and CISPR Publication 22. All receiving equipment conforms to CISPR Publication 16-1, "Radio Interference Measuring Apparatus and Measurement Methods."


### 6 DB BANDWIDTH (802.11b MODE)






### 6 DB BANDWIDTH (802.11g MODE)






### 6 DB BANDWIDTH (802.11a MODE)


### 99% BANDWIDTH (802.11g MODE)








### 7.3. PEAK OUTPUT POWER

#### **PEAK POWER LIMIT**

§15.247 (b) The maximum peak output power of the intentional radiator shall not exceed the following:

\$15.247 (b) (3) For systems using digital modulation in the 902-928 MHz, 2400-2483.5 MHz , and 5725-5850 MHz bands: 1 watt.

§15.247 (b) (4) Except as shown in paragraphs (b)(3) (i), (ii) and (iii) of this section, if transmitting antennas of directional gain greater than 6 dBi are used the peak output power from the intentional radiator shall be reduced below the stated values in paragraphs (b)(1) or (b)(2) of this section, as appropriate, by the amount in dB that the directional gain of the antenna exceeds 6 dBi.

The maximum antenna gain is 3 dBi, therefore the limit is 30 dBm.

#### **TEST PROCEDURE**

The transmitter output is connected to a spectrum analyzer and the analyzer's internal channel power integration function is used to integrate the power over a bandwidth greater than or equal to the 99% bandwidth.

# **OUTPUT POWER (802.11g MODE)**









# 7.6. PEAK POWER SPECTRAL DENSITY

#### **LIMIT**

§15.247 (d) For direct sequence systems, the peak power spectral density conducted from the intentional radiator to the antenna shall not be greater than 8 dBm in any 3 kHz band during any time interval of continuous transmission.

# **TEST PROCEDURE**

The transmitter output is connected to a spectrum analyzer, the maximum level in a 3 kHz bandwidth is measured with the spectrum analyzer using RBW = 3 kHz and VBW > 3 kHz, sweep time = span / 3 kHz, and video averaging is turned off. The PPSD is the highest level found across the emission in any 3 kHz band.






# PEAK POWER SPECTRAL DENSITY (802.11b MODE)






# PEAK POWER SPECTRAL DENSITY (802.11g MODE)








# 7.7. CONDUCTED SPURIOUS EMISSIONS

#### **LIMITS**

§15.247 (c) In any 100 kHz bandwidth outside the frequency band in which the spread spectrum intentional radiator is operating, the radio frequency power that is produced by the intentional radiator shall be at least 20 dB below that in the 100 kHz bandwidth within the band that contains the highest level of the desired power, based on either an RF conducted or a radiated measurement. Attenuation below the general limits specified in §15.209(a) is not required. In addition, radiated emissions, which fall in the restricted bands, as defined in§15.205(a), must also comply with the radiated emission limits specified in §15.209(a) (see §15.205(c)).





# SPURIOUS EMISSIONS, LOW CHANNEL (802.11b MODE)





# SPURIOUS EMISSIONS, MID CHANNEL (802.11b MODE)





# SPURIOUS EMISSIONS, HIGH CHANNEL (802.11b MODE)







# SPURIOUS EMISSIONS, LOW CHANNEL (802.11g MODE)




# SPURIOUS EMISSIONS, MID CHANNEL (802.11g MODE)




# SPURIOUS EMISSIONS, HIGH CHANNEL (802.11g MODE)




# SPURIOUS EMISSIONS, LOW CHANNEL (802.11a MODE)




# SPURIOUS EMISSIONS, MID CHANNEL (802.11a MODE)






# 7.8.2. TRANSMITTER RADIATED EMISSIONS ABOVE 1 GHZ






# RESTRICTED BANDEDGE (b MODE, LOW CHANNEL, VERTICAL)





# RESTRICTED BANDEDGE (b MODE, HIGH CHANNEL, HORIZONTAL)





# RESTRICTED BANDEDGE (b MODE, HIGH CHANNEL, VERTICAL)





# HARMONICS AND SPURIOUS EMISSIONS (b MODE)



# RESTRICTED BANDEDGE (g MODE, LOW CHANNEL, HORIZONTAL)





# RESTRICTED BANDEDGE (g MODE, LOW CHANNEL, VERTICAL)





# RESTRICTED BANDEDGE (g MODE, HIGH CHANNEL, HORIZONTAL)





# RESTRICTED BANDEDGE (g MODE, HIGH CHANNEL, VERTICAL)







# 7.9. POWERLINE CONDUCTED EMISSIONS

#### **LIMIT**

 $\S15.207$  (a) Except as shown in paragraphs (b) and (c) of this section, for an intentional radiator that is designed to be connected to the public utility (AC) power line, the radio frequency voltage that is conducted back onto the AC power line on any frequency or frequencies within the band 150 kHz to 30 MHz shall not exceed the limits in the following table, as measured using a 50  $\mu$ H/50 ohms line impedance stabilization network (LISN). 


