Company Name Hisense Communication Co., Ltd. Product name Wi-Fi Module, model name: MW506, FCC ID: SARMW506 would like to have your authorization as a modular approval. The requirements of Public Notice DA00- 1407 have been met and shown on the following statements.

1. The modular transmitter must have its own RF shielding.	Yes, it has its own RF shielding. Please refer to external photos.
2. The modular transmitter must have buffered modulation/data inputs (if such inputs are provided) to ensure that the module will comply with Part 15 requirements under conditions of excessive data rates or over-modulation.	Yes, it has buffered modulation/data inputs to ensure that the device will comply with Part 15 requirements with any type of input signal.
3. The modular transmitter must have its own power supply regulation.	No. Host device should provide a regulated 3.3V power supply to guarantee the module's RF performance meeting FCC requirement.
4. The modular transmitter must comply with the antenna requirements of Section 15.203 and 15.204(c). The antenna must either be permanently attached or employ a "unique" antenna coupler (at all connections between the module and the antenna, including the cable)..	Yes, the requirements of antenna connector and spurious emissions have been fulfilled. Please refer to Test Report. <i>The module consists of a SMT metal antenna and an external IPEX antenna.. When the module works , choose one antenna with strong signal according to the signal strength. During the test ,the test can be performed separately ; the metal antenna of the on-board patch only or external IPEX antenna only.</i>
5. The modular transmitter must be tested in a stand-alone configuration, i.e., the module must not be inside another device during testing. This is intended to demonstrate that the module is capable of complying with Part 15 emission limits regardless of the device into which it is eventually installed.	Yes, it was tested in a stand-alone configuration. Please refer to Setup Photo.
