Setup:

- 1. Download the Vantaa App from Apple App Store or Google Play Store
- 2. Follow the onscreen instructions for setting up the Bridge:
 - a. Connect power cable to Bridge and plug into a wall outlet
 - Note: for best performance avoid power conditioning power strips as this unit uses both radio signals and powerline signals for wireless communication.
 - b. Connect Ethernet cable to Bridge and connect the other end to an available port on your router
 - c. Wait for the LED on the Bridge to turn green
 - d. Follow the app instructions to add the Bridge to the app
- 3. When finished setting up the Bridge in the app, tap the + button in the Devices tab to add your first Vantaa device
