All calculations were made in accordance with FCC OET Bulletin 65 Edition 97-01 and IC Safety Code 6.

3. REFERENCES

All measurements were made as documented in test report UL CCS Document "12U14339-1 FCC IC DTS WLAN Report" for operation in the 2.4 GHz band and UL CCS Document "12U14339-2 FCC IC UNII WLAN Report" for operation in the 5 GHz bands.

Output power, Duty cycle and Antenna gain data is excerpted from the applicable test reports.

4. FACILITIES AND ACCREDITATION

The test sites and measurement facilities used to collect data are located at 47173 Benicia Street, Fremont, California, USA.

5. EUT DESCRIPTION

The EUT possesses an 802.11 g/n wireless card. It is a 2.4/5GHz dual band concurrent module based on two Atheros' Osprey chipsets, AR9381 for 2GHz radio and AR9382 for 5GHz radio. The wireless card supports 802.11g,n functionality for 2.4GHz, and 802.11n for 5GHz. The 2.4GHz radio supports (3x3) MIMO, the 5GHz radio support (2x2) MIMO.

The wireless card is manufactured by Alpha Networks, and the model number of this card is WMC-ND06.

6. REQUIREMENTS - LIMITATION OF EXPOSURE

6.1. LIMITS

6.1.1. FCC RULES

§1.1310 The criteria listed in Table 1 shall be used to evaluate the environmental impact of human exposure to radio-frequency (RF) radiation as specified in §1.1307(b), except in the case of portable devices which shall be evaluated according to the provisions of §2.1093 of this chapter.

NOTE 1 TO TABLE 1: Occupational/controlled limits apply in situations in which persons are exposed as a consequence of their employment provided those persons are fully aware of the potential for exposure and can exercise control over their exposure. Limits for occupational/controlled exposure also apply in situations when an individual is transient through a location where occupational/controlled limits apply provided he or she is made aware of the potential for exposure.

NOTE 2 TO TABLE 1: General population/uncontrolled exposures apply in situations in which the general public may be exposed, or in which persons that are exposed as a consequence of their employment may not be fully aware of the potential for exposure or can not exercise control over their exposure.

6.1.2. IC RULES

IC Safety Code 6, Section 2.2.1 (a) A person other than an RF and microwave exposed worker shall not be exposed to electromagnetic radiation in a frequency band listed in Column 1 of Table 5, if the field strength exceeds the value given in Column 2 or 3 of Table 5, when averaged spatially and over time, or if the power density exceeds the value given in Column 4 of Table 5, when averaged spatially and over time.

6.1.3. LIMITS APPLICABLE TO THE EUT

For mobile radio equipment operating in the cellular phone band, the lowest power density limit is calculated using the lowest frequency, as 824 MHz / 1500 = 0.55 mW/cm² (FCC) and 824 MHz / 150 = 5.5 W/m² (IC).

For operation in the PCS band, the 2.4 GHz band and the 5 GHz bands, from FCC §1.1310 Table 1 (B), the maximum value of S = 1.0 mW/cm² and from IC Safety Code 6, Section 2.2 Table 5 Column 4, S = 10 W/m².

6.2. EQUATIONS

Power density is given by:

$$S = \text{EIRP} / (4 * \text{Pi} * \text{D}^2)$$

where

S = Power density in W/m²
EIRP = Equivalent Isotropic Radiated Power in W
D = Separation distance in m

Distance is given by:

$$D = \text{SQRT} (\text{EIRP} / (4 * \text{Pi} * S))$$

where

D = Separation distance in m
EIRP = Equivalent Isotropic Radiated Power in W
S = Power density in W/m²

Where applicable (for example, multi-slot cell phone applications) a duty cycle factor may be applied.

$$\text{Source-based time-averaged EIRP} = (\text{DC} / 100) * \text{EIRP}$$

where

DC = Duty Cycle in %, as applicable
EIRP = Equivalent Isotropic Radiated Power in W

For multiple chain devices, and colocated transmitters operating simultaneously in frequency bands where the limit is identical, the total power density is calculated using the total EIRP obtained by summing the Power * Gain product (in linear units) of each transmitter.

$$\text{Total EIRP} = (\text{P1} * \text{G1}) + (\text{P2} * \text{G2}) + \dots + (\text{Pn} * \text{Gn})$$

where

P_x = Power of transmitter x
G_x = Numeric gain of antenna x

For multiple colocated transmitters operating simultaneously in frequency bands where different limits apply, either the lowest limit applicable to the co-located transmitters can be applied or a fraction of the exposure limit is established for each band, such that the sum of the fractions is less than or equal to one.

In the table(s) below, Power and Gain are entered in units of dBm and dBi respectively and conversions to linear forms are used for the calculations.

6.3. RESULTS

Note: the PK output power and antenna gain chosen for the calculations below are worst-case and cover the rest of modes.
