1.	The modular transmitter must have its own RF shielding.	Yes. The EUT provides the RFshielding. See EUT photo.
2.	The modular transmitter must have buffered modulation/data inputs (if such inputs are provided) to ensure that the module will comply with Part 15 requirements under conditions of excessive data rates or over-modulation.	Yes. The EUT has its buf fered modulation. Please see the Schematic Diagram.
