

4 Test Types and Results

4.1 Radiated Emission Measurement

4.1.1 Limits of Radiated Emission Measurement

The power of any emission outside of the authorized operating frequency ranges must be attenuated below the transmitting power (P) by a factor of at least 43 + 10 log(P) dB. The emission limit equal to –13dBm.

4.1.2 Test Procedure

- a. In the semi-anechoic chamber, EUT placed on the 0.8m (below or equal 1GHz) height of Turn Table, rotated the table around 360 degrees to search the maximum radiation power and receiver antenna shall be rotated vertical and horizontal polarization and moved height from 1m to 4m to find the maximum polar radiated power. The "Read Value" is the spectrum reading the maximum power value.
- b. The height of antenna is varied from one meter to four meters above the ground to determine the maximum value of the field strength. Both horizontal and vertical polarizations of the antenna are set to make the measurement.
- c. Perform a field strength measurement and record the worse read value, is the field strength value via a spectrum reading obtained corrected for antenna factor, cable loss and pre-amplifier factor and then mathematically convert the measured field strength level to EIRP/ERP level.
- d. Following C63.26 section 5.5 and 5.2.7
 - EIRP (dBm) = E (dBμV/m) + 20log(D) 104.8; where D is the measurement distance (in the far field region) in m.
 - ERP (dBm) = E (dBμV/m) + 20log(D) 104.8 2.15; where D is the measurement distance (in the far field region) in m.

Note:

- 1. The resolution bandwidth and video bandwidth of test receiver/spectrum analyzer is 1MHz/3MHz.
- 2. The emission levels were against the limit of frequency range 9 kHz ~ 30 MHz: The amplitude of spurious emissions attenuated more than 20 dB below the permissible value is not required to be report.
