## **FIREMASTER IV “Millennium Three” FIRING SYSTEM**

### **Manufacturer’s declaration concerning details about the “Professional installation of the System” and antenna characteristics.**

a)

The use and operation of the **FIREMASTER IV “Millennium Three” FIRING SYSTEM** is RESERVED to SPECIALIZED PROFESSIONALS operating in the CIVILIAN FIREWORKS SECTOR duly licensed and provided with all the necessary Authority permits required by the Government of the Country where the SYSTEM is operated.

Any other use IS NOT ALLOWED and the warranty will be immediately void in case of ABUSE, MISUSE or modifications made to the equipment without a prior written permit of the Manufacturer.

The equipment FIREMASTER IV IS NOT SOLD TO common people for private use nor it is distributed using dealers but it is always sold BY THE PRODUCER (Parente Fireworks s.r.l.) under its direct supervision and responsibility DIRECTLY to the FINAL USER.

PROFESSIONAL OPERATORS in the CIVILIAN FIREWORKS sector must have a SPECIAL GOVERNMENT PERMIT released after a severe training and test. The technical skill required to operate with explosive devices like fireworks, grants a technical knowledge more than sufficient to install and operate a FIRING SYSTEM WITHOUT NEED for a specific training course. In the Fireworks sector a FIRING SYSTEM like the FIREMASTER IV, should be considered as A COMMON WORKING TOOL.

The GENERIC PERSONNEL eventually hired by Professional Fireworks Operators is used for the common duties only. This personnel is NOT ALLOWED to operate directly with explosive material nor with the FIRING DEVICES and FIRING SYSTEMS: this is always under the direct supervision and responsibility of the company owner.

b)

The antennas for the correct operation of the FIREMASTER IV SYSTEM (both TX5000 and RX48) are SUPPLIED WITH THE INSTRUMENT and must be considered as INTEGRAL part of the FIREMASTER SYSTEM.

It is FORBIDDEN the use of any other commercial ANTENNA eventually provided by the user.

A "wing nut" turret attachment allows to REMOVE the "integral" antenna during transportation and storage.

In no cases this turret must be considered as a "general purpose antenna connector" for the connection of other radiating devices other than the whip antenna certified and supplied with the System by the Manufacturer.

The wing nut provided with the FIREMASTER SYSTEM is specially machined for this purpose only (the thread is a non-standard one). Other commercial antennas provided with a SIMILAR connector CANNOT BE DIRECTLY INSTALLED (mechanical modifications and adjustments requiring specialized machinery are required).
