1.0 GENERAL DESCRIPTION

1.1 Product Description

The Equipment Under Test (EUT), is a portable 2.4GHz Transceiver (Controller Unit) for a RC Truck. The sample supplied operated on 71 channels, normally at 2405 - 2475MHz. The channels are separated with 1MHz spacing.

The EUT is powered by 2 x 1.5V AAA batteries. The truck has 2 modes, the “TRY ME” mode and the on mode. For the “TRY ME” mode, after switching on the EUT, sound will be emitted from the truck based on the button pressed on the truck. For the on mode, it has all the functions that the “TRY ME” mode has. In addition, the truck will be moved forward or backward and turned left and right based on the switches pressed in the controller. Sound will be emitted from the truck based on the button pressed on the controller.

The Models: WH1330D, WH1330Z, WH1331, WH1331D, WH1331Z, WH1332, WH1332D, WH1332Z, WH1333, WH1333D and WH1333Z are the same as the Model: WH1330 in hardware aspect as declared by client. The models are different in outlook only as declared by client.

Antenna Type: Internal, Integral

1.2 Related Submittal(s) Grants

This is a single application for certification of a transceiver.

The Certificate procedure of transceiver for this transceiver (with FCC ID: SLU23D24R17) is being processed as the same time of this application.

1.3 Test Methodology

Radiated emission measurements were performed according to the procedures in ANSI C63.10 (2013). All radiated measurements were performed in an 3m Chamber. Preliminary scans were performed in the 3m Chamber only to determine worst case modes. All radiated tests were performed at an antenna to EUT distance of 3 meters, unless stated otherwise in the “**Justification Section**” of this Application.

1.4 Test Facility

The 3m Chamber used to collect the radiated data is located at Workshop No. 3, G/F., World-Wide Industrial Centre, 43-47 Shan Mei Street, Fo Tan, Sha Tin, N.T., Hong Kong SAR, China. This test facility and site measurement data have been placed on file with the FCC.

2.0 SYSTEM TEST CONFIGURATION

2.1 Justification

The system was configured for testing in a typical fashion (as a customer would normally use it), and in the confines as outlined in ANSI C63.10 (2013).

The device was powered by DC 3.0V (2 x 1.5V AAA batteries).

For maximizing emissions, the EUT was rotated through 360°, the antenna height was varied from 1 meter to 4 meters above the ground plane, and the antenna polarization was changed. This step by step procedure for maximizing emissions led to the data reported in Exhibit 3.0.

The unit was operated standalone and placed in the center of the turntable.

The equipment under test (EUT) was configured for testing in a typical fashion (as a customer would normally use it). The EUT was mounted to a plastic stand if necessary and placed on the wooden turntable, which enabled the engineer to maximize emissions through its placement in the three orthogonal axes.

2.2 EUT Exercising Software

There was no special software to exercise the device. Once the unit is powered up, it transmits the RF signal continuously.

2.3 Special Accessories

There are no special accessories necessary for compliance of this product.

2.4 Measurement Uncertainty

Decision Rule for compliance: For FCC/IC standard, the measured value must be within the limits of applicable standard without accounting for the measurement uncertainty. For EN/IEC/HKTA/HKTC standard, conformity rules will be used as per standard directly excepted EN/IEC 61000-3-2, EN/IEC 61000-3-3, HKTA1004, HKCA1008, HKTA1019, HKTA1020, HKTA1041 and HKTA1044. For these excepted or not mentioned standards, Cl 4.2.2 of ILAC-G8:09/2019 decision rules will be reference and guard band will be equal to our measurement uncertainty with 95% confidence level ($k=2$). In case, the measured value is within guard band region, undetermined decision will be used.

Uncertainty and Compliance - Unless the standard specifically states that measured values are to be extended by the measurement uncertainty in determining compliance, all compliance determinations are based on the actual measured value.

3.0 EMISSION RESULTS

Data is included of the worst case configuration (the configuration which resulted in the highest emission levels). A sample calculation, configuration photographs and data tables of the emissions are included.

3.1 Field Strength Calculation

The field strength is calculated by adding the Antenna Factor and Cable Factor, and subtracting the Amplifier Gain (if any), Average Factor (optional) from the measured reading.

The basic equation with a sample calculation is as follows:

$$FS = RA + AF + CF - AG - AV$$

where

- FS = Field Strength in dB μ V/m
- RA = Receiver Amplitude (including preamplifier) in dB μ V
- AF = Antenna Factor in dB
- CF = Cable Attenuation Factor in dB
- AG = Amplifier Gain in dB
- AV = Average Factor in dB

In the following table(s), the reading shown on the data table reflects the preamplifier gain.

An example for the calculations in the following table is as follows:

$$FS = RR + LF$$

where

- FS = Field Strength in dB μ V/m
- RR = RA - AG - AV in dB μ V
- LF = CF + AF in dB

Assume a receiver reading of 52.0 dB μ V is obtained. The antenna factor of 7.4 dB and cable factor of 1.6 dB are added. The amplifier gain of 29.0 dB and average factor of 5.0 dB are subtracted, giving a field strength of 27.0 dB μ V/m. This value in dB μ V/m was converted to its corresponding level in μ V/m.

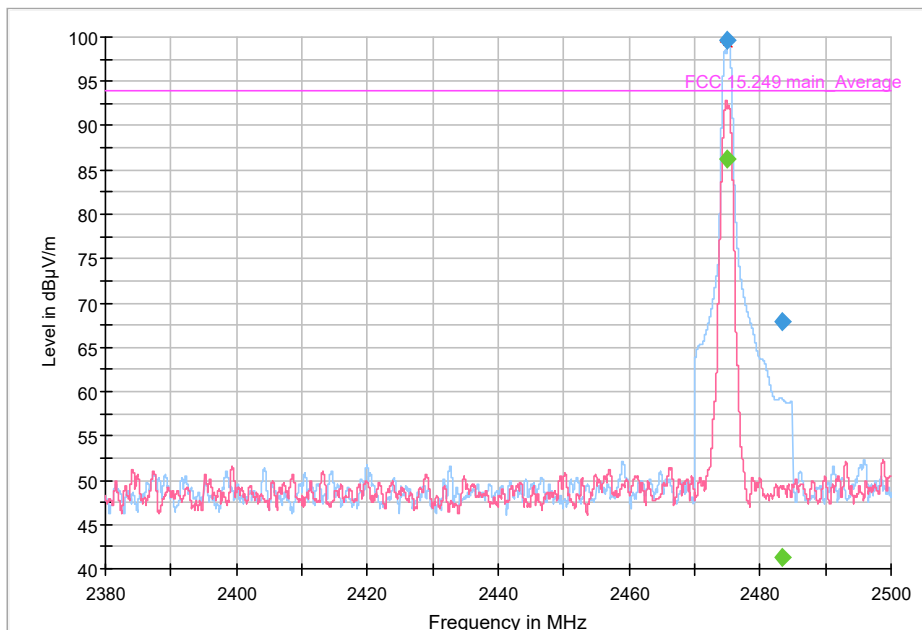
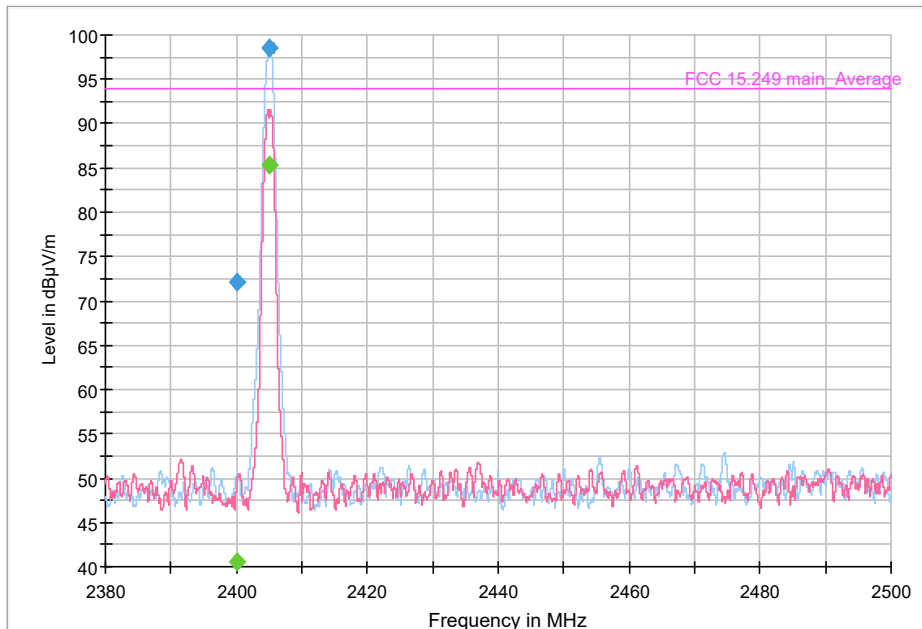
8.0 MISCELLANEOUS INFORMATION

The miscellaneous information includes details of the test procedure and measured bandwidth.

8.1 Radiated Emission on the Bandedge

The emission of bandedge data were shown on the above radiated data table of 1 & 3 respectively.

Emissions radiated outside of the specified frequency bands, except harmonics, are attenuated by 50dB below the level of the fundamental or to the general radiated emissions limits in Section 15.209, whichever is the lesser attenuation, which meet the requirement of Part 15.249(d).

8.2 Emissions Test Procedures

The following is a description of the test procedure used by Intertek Testing Services Hong Kong Ltd. in the measurements of transmitter operating under the Part 15, Subpart C rules.

The transmitting equipment under test (EUT) is placed on a wooden turntable which is four feet in diameter and approximately 0.8m in height above the ground plane for emission measurement at or below 1GHz and 1.5m in height above the ground plane for emission measurement above 1GHz. During the radiated emissions test, the turntable is rotated and any cables leaving the EUT are manipulated to find the configuration resulting in maximum emissions. The EUT is adjusted through all three orthogonal axis to obtain maximum emission levels. The antenna height and polarization are also varied during the testing to search for maximum signal levels. The height of the antenna is varied from one to four meters.

Detector function for radiated emissions is in peak mode. Average readings, when required, are taken by measuring the duty cycle of the equipment under test and subtracting the corresponding amount in dB from the measured peak readings. A detailed description for the calculation of the average factor can be found in Exhibit 8.3.

The frequency range scanned is from the lowest radio frequency signal generated in the device which is greater than 9 kHz to the tenth harmonic of the highest fundamental frequency or 40 GHz, whichever is lower.

The EUT is warmed up for 15 minutes prior to the test.

AC power to the unit is varied from 85% to 115% nominal and variation in the fundamental emission field strength is recorded. If battery powered, a new, fully charged battery is used.

Conducted measurements were made as described in ANSI C63.10 (2013).

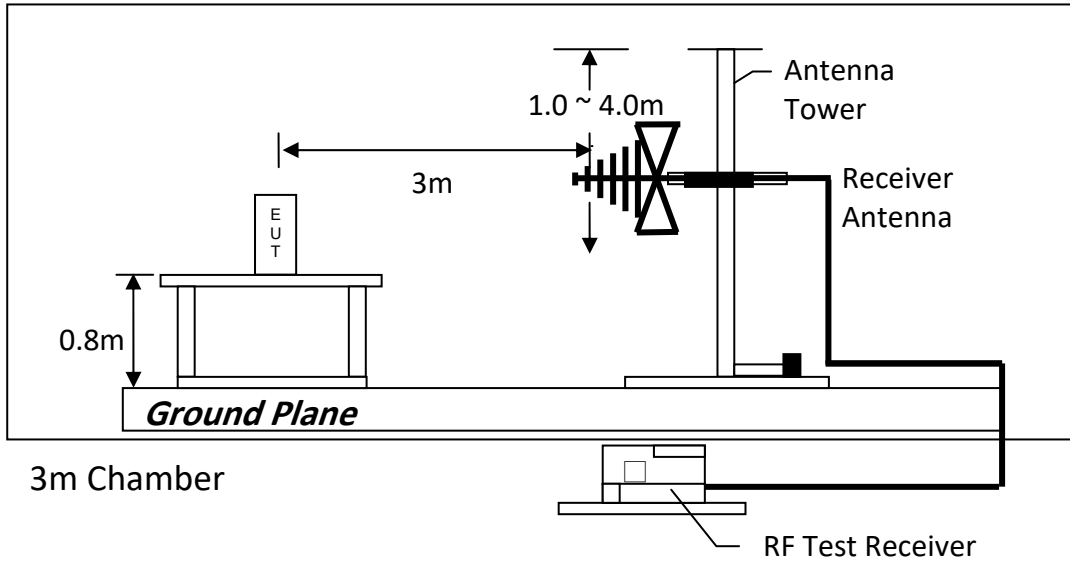
The IF bandwidth used for measurement of radiated signal strength was 100 kHz or greater when frequency is below 1000 MHz. Where pulsed transmissions of short enough pulse duration warrant, a greater bandwidth is selected according to the recommendations of Hewlett Packard Application Note 150-2. A discussion of whether pulse desensitivity is applicable to this unit is included in this report (See Exhibit 8.1). Above 1000 MHz, a resolution bandwidth of 3 MHz is used.

Transmitter measurements are normally conducted at a measurement distance of three meters. However, to assure low enough noise floor in the forbidden bands and above 1 GHz, signals are acquired at a distance of one meter or less. All measurements are extrapolated to three meters using inverse scaling, unless otherwise reported. Measurements taken at a closer distance are so marked.

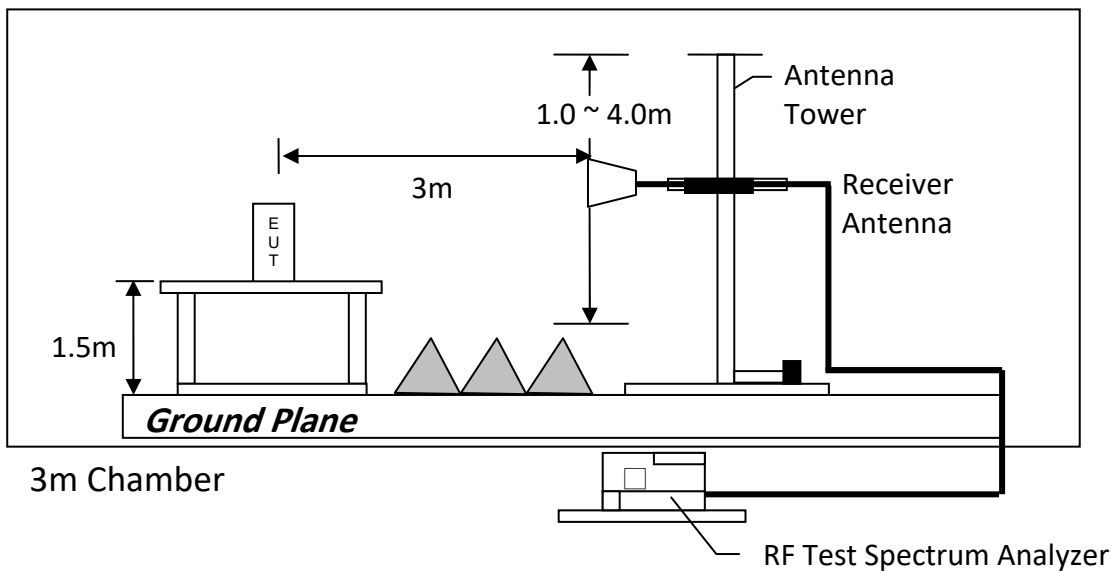

Test setup of radiated emissions above 1GHz

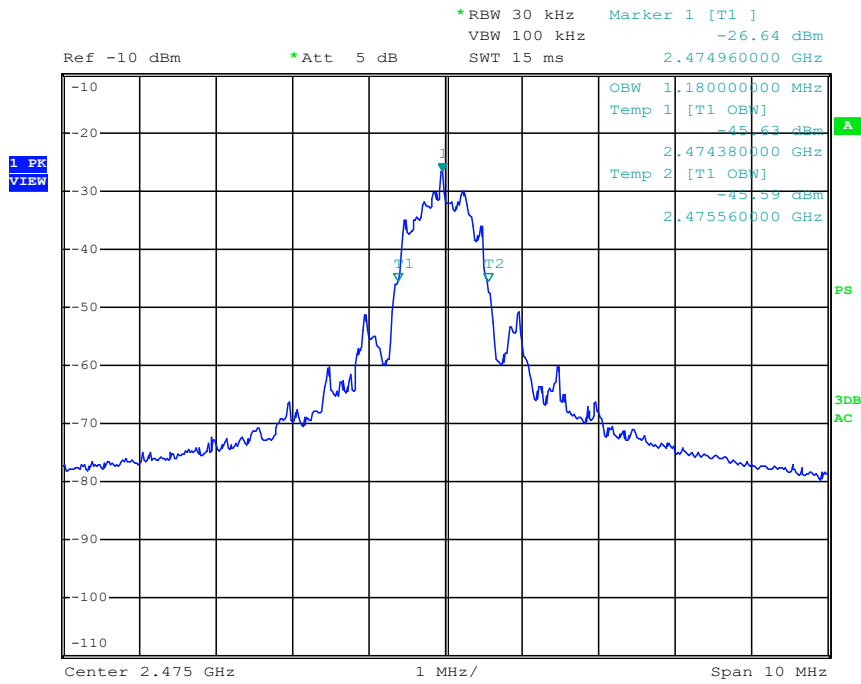
