7.1 Conducted Emission

Test Method

- 1 The EUT was placed on a table, which is 0.8m above ground plane
- 2 The power line of the EUT is connected to the AC mains through a Artificial Mains Network (A.M.N.).
- 3 Maximum procedure was performed to ensure EUT compliance
- 4 A EMI test receiver (R&S Test Receiver ESCS30) is used to test the emissions from both sides of AC line





7.2 Radiated emissions

Test Method

- 1 The EUT is placed on a turntable, which is 0.8m above ground plane.
- 2 The turntable shall be rotated for 360 degrees to determine the position of maximum
- 3 EUT is set 3m away from the receiving antenna, which is varied from 1m to 4m to find out the highest emissions.
- 4 Maximum procedure was performed on the six highest emissions to ensure EUT compliance.
- 5 Each emission was to be maximized by changing the polarization of receiving antenna both horizontal and vertical.


