Product Description for Equipment under Test (EUT)

The *Circus World Displays Ltd.*'s product, model number: 32008B (FCC ID: SMH32008B) (the "EUT") in this report was a camera unit of 2.4GHz Digital Video Baby Monitor, which was measured approximately: 9.0 cm (L) x 9.5 cm (W) x 11.0 cm (H), rated with input voltage: DC 6V from adapter.

Objective

This report is prepared on behalf of *Circus World Displays Ltd.* in accordance with Part 2-Subpart J, Part 15-Subparts A, B and C of the Federal Communication Commissions rules.

The tests were performed in order to determine compliance with FCC Part 15, Subpart C, section 15.203, 15.205, 15.207, 15.209 and 15.247 rules.

The monitor unit of a system with FCC ID: SMH32006 has been granted on 2013-04-17.

Test Methodology

All measurements contained in this report were conducted with ANSI C63.4-2009, American National Standard for Methods of Measurement of Radio-Noise Emissions from Low-Voltage Electrical and Electronic Equipment in the range of 9 kHz to 40 GHz.

All emissions measurement was performed and Bay Area Compliance Laboratories Corp. (Shenzhen). The radiated testing was performed at an antenna-to-EUT distance of 3 meters.

Measurement uncertainty with radiated emission is 5.91 dB for 30MHz-1GHz and 4.92 dB for above 1GHz, 1.95dB for conducted measurement.






Measurement Uncertainty






