RF Exposure Compliance Justification:

For portable applications model 5144G-R operates in a handheld configuration only. There are no provisions or accessories for body-worn applications. Per KDB 447498 D01 V04 4(c)(iii), hand SAR is required for hand-held and hand-operated devices with output power > 1000·[f(GHz)]^(-0.5)mW that are designed with the hand operating closer than 5 cm from the antenna during normal use.

Model 5144G-R is exempt from SAR based on the output power (higher of conducted or EIRP) begin > 1000·[f(GHz)]^(-0.5)mW. MPE calculations are provided below for satisfying mobile RF exposure conditions.

MPE Calculation

The Power Density (mW/cm²) is calculated as follows:

$$S = \frac{PG}{4\pi R^2}$$

Where:

S = power density (in appropriate units, e.g. mW/cm2)

P = power input to the antenna (in appropriate units, e.g., mW)

G = power gain of the antenna in the direction of interest relative to an isotropic radiator

R = distance to the center of radiation of the antenna (appropriate units, e.g., cm)

Installation Guidelines

The installation manual should contain text similar to the following advising how to install the equipment to maintain compliance with the FCC RF exposure requirements:

RF Exposure

In accordance with FCC requirements of human exposure to radio frequency fields, the radiating element shall be installed such that a minimum separation distance of 20 centimeters will be maintained.
