1.0 GENERAL

1.1 Purpose

The purpose of this report is to demonstrate compliance with Part 24 Subpart E and Part 22 Subpart H of the FCC's Code of Federal Regulations and RSS-131 of Industry Canada's Radio Standards Specifications.

1.2 Product Description

1.2.1 General

The YX300 is a Smart Bi-Directional Amplifier (SBDA) system which captures the signal arriving outside a consumer's home and amplifies it inside the home, as well as capturing the signal from the user's phone and amplifying it to the outdoor network. Wireless Extenders designed the YX300 to meet BOTH the needs of the wireless carrier and the wireless consumer.

The YX300 handles all applicable air-interface protocols including AMPS, TDMA, GSM, and CDMA by amplifying the entire Cellular and PCS frequency bands. It includes multiple patent pending technologies to prevent interference to the network. The combination of low gain and low Noise Floor means that it will not raise the networks Base Transmit Station's (BTS) Noise Floor. The YX300 has a signal delay similar to multi-path signals making it transparent to the wireless network. Additionally, the YX300 is intelligent and continually monitors signal levels and adapts the automatic level control as the network changes so that it does not interfere with the BTS' uplink power control.

The YX300 contains two separate transmit antennas. The Uplink antenna is an Internal PCB Inverted F Type antenna with 5dBi gain at the PCS frequencies and 2dBi gain at Cellular. The Downlink antenna is an external Omni Dipole with 2dBi gain at both PCS and Cellular.

1.3 Test Methodology and Considerations

The EUT was configured and tested utilizing the maximum input drive level resulting in maximum gain conditions for all tests. If the maximum input drive level is exceeded, internal attenuators are activated to produce a level RF output and eliminate the device from operating beyond the maximum RF output power that is below the saturated RF output power.

For intentional radiated emissions the RF output port was configured with a 50 Ohm non-radiating load. For unintentional radiated emissions and AC power line conducted emissions measurements the EUT was configured with the representative antennas attached.

2.3 Radiated Emissions Test Site Description

2.3.1 Semi-Anechoic Chamber Test Site

Model: YX300-PCS-CEL

The Semi-Anechoic Chamber Test Site consists of a 20' x 30' x 18' shielded enclosure. The chamber is lined with Toyo Ferrite Grid Absorber, model number FFG-1000. The ferrite tile grid is 101 x 101 x 19mm thick and weighs approximately 550 grams. These tiles are mounted on steel panels and installed directly on the inner walls of the chamber.

The turntable is 150cm in diameter and is located 160cm from the back wall of the chamber. The chamber is grounded via 1 - 8' copper ground rod, installed at the center of the back wall, it is bound to the ground plane using 3/4" stainless steel braided cable.

The turntable is all steel, flush mounted table installed in an all steel frame. The table is remotely operated from inside the control room located 25' from the range. The turntable is electrically bonded to the surrounding ground plane via steel fingers installed on the edge of the turn table. The steel fingers make constant contact with the ground plane during operation.

Behind the turntable is a 3' \times 6' \times 4' deep shielded pit used for support equipment if necessary. The pit is equipped with 1 - 4" PVC chases from the turntable to the pit that allow for cabling to the EUT if necessary. The underside of the turntable can be accessed from the pit so cables can be supplied to the EUT from the pit.




Figure 2.3-1: Semi-Anechoic Chamber Test Site

A diagram of the Semi-Anechoic Chamber Test Site is shown in Figure 2.3-1 below:

2.3.2 Open Area Tests Site (OATS)

The open area test site consists of a 40' x 66' concrete pad covered with a perforated electro-plated galvanized sheet metal. The perforations in the sheet metal are 1/8" holes that are staggered every 3/16". The individual sheets are placed to overlap each other by 1/4" and are riveted together to provide a continuous seam. Rivets are spaced every 3" in a 3 x 20 meter perimeter around the antenna mast and EUT area. Rivets in the remaining area are spaced as necessary to properly secure the ground plane and maintain the electrical continuity.

The entire ground plane extends 12' beyond the turntable edge and 16' beyond the antenna mast when set to a 10 meter measurement distance. The ground plane is grounded via 4 - 8' copper ground rods, each installed at a corner of the ground plane and bound to the ground plane using 3/4" stainless steel braided cable.

The turntable is an all aluminum 10' flush mounted table installed in an all aluminum frame. The table is remotely operated from inside the control room located 40' from the range. The turntable is electrically bonded to the surrounding ground plane via steel fingers installed on the edge of the turn table. The steel fingers make constant contact with the ground plane during operation.

Adjacent to the turntable is a 7' x 7' square and 4' deep concrete pit used for support equipment if necessary. The pit is equipped with 5 - 4" PVC chases from the pit to the control room that allow for cabling to the EUT if necessary. The underside of the turntable can be accessed from the pit so cables can be supplied to the EUT from the pit. The pit is covered with 2 sheets of 1/4" diamond style reenforced steel sheets. The sheets are painted to match the perforated steel ground plane; however the underside edges have been masked off to maintain the electrical continuity of the ground plane. All reflecting objects are located outside of the ellipse defined in ANSI C63.4.




Figure 2.3-2: Open Area Test Site

A diagram of the Open Area Test Site is shown in Figure 2.3-2 below:

2.4 Conducted Emissions Test Site Description

The AC mains conducted EMI site is located in the main EMC lab. It consists of an 8' x 8' solid aluminum horizontal group reference plane (GRP) bonded every 3" to an 8' X 8' vertical ground plane.

The site is of sufficient size to test table top and floor standing equipment in accordance with section 6.1.4 of ANSI C63.4.

A diagram of the room is shown below in figure 4.1.3-1:




Figure 2.4-1: AC Mains Conducted EMI Site




Figure 6-1: EUT Test Setup

7.1 RF Power Output

7.1.1 Measurement Procedure

The RF output of the equipment under test was directly connected to the input of the Spectrum Analyzer. The resolution and video bandwidths of the spectrum analyzer were set at sufficient levels, >> emission bandwidth, to produce accurate results. Results for PCS and Cellular uplink and downlink configurations are shown below in Table 7.1-1 and Table 7.1-2.

7.2 Occupied Bandwidth (Emission Limits)

7.2.1 Measurement Procedure

The RF output of the equipment under test was directly connected to the input of the Spectrum Analyzer. The spectrum analyzer resolution and video bandwidths were set to 1% of the emission bandwidth. The analyzer was set for Max Hold using a peak detector. Both the input and output bandwidths were evaluated to show similar characteristics of the emissions. Results for PCS and Cellular uplink and downlink configurations are shown below in Table 7.2-1 and 7.2-2.

7.3 Spurious Emissions at Antenna Terminals and Inter-modulation Products

7.3.1 Measurement Procedure

The RF output of the equipment under test was directly connected to the input of the Spectrum Analyzer. For inter-modulation products the two tone two test method was used with the device operating at maximum drive levels. Two tones were placed at the lower band-edge and upper band-edge. Intermodulation products were tested using TDMA, CDMA, and CW signals. CW covers FM (GSM and F1D) for inter-modulation products. The spectrum analyzer resolution and video bandwidths were set to 1% the emission bandwidth

For out of band spurious emissions the spectrum analyzer resolution and video bandwidths were set to 1 MHz according to Section 24.238 (b). The spectrum was investigated for the 30 MHz to 20 GHz in accordance to CFR 47 Part 2.1057. The analyzer was set for Max Hold using a peak detector. Spurious emissions were evaluated for all modulation modes.

7.4 Band-edge Compliance

7.4.1 Measurement Procedure

The RF output of the equipment under test was directly connected to the input of the Spectrum Analyzer. The spectrum analyzer resolution and video bandwidths were set to 1% the emission bandwidth. The analyzer was set for Max Hold using a peak detector. The center frequency was set to both the upper and lower cellular frequency block edges. Band-edge compliance was evaluated for all modulation modes.

7.5 Field Strength of Spurious Emissions

7.5.1 Measurement Procedure

The equipment under test is placed on the Open Area Test Site (described in section 2.1) on a wooden table at the turntable center. For each spurious emission, the antenna mast is raised and lowered from one (1) to four (4) meters and the turntable is rotated 360° and the maximum reading on the spectrum analyzer is recorded. This repeated for both horizontal and vertical polarizations of the receive antenna.

The equipment under test is then replaced with a substitution antenna fed by a signal generator. The signal generator's frequency is set to that of the spurious emission recorded from the equipment under test. The antenna mast is raised and lowered from one (1) to four (4) meters to obtain a maximum reading on the spectrum analyzer. The output of the signal generator is then adjusted until the reading on the spectrum analyzer matches that obtained from the equipment under test. The signal generator level is recorded.

The power in dBm of each spurious emission is calculated by correcting the signal generator level for the cable loss and gain of the substitution antenna referenced to a dipole. The spectrum was investigated in accordance to CFR 47 Part 2.1057. A CW was used for both uplink and downlink for low, middle and high channels. The worst case emissions are reported of both uplink and downlink configurations. All emissions not reported were below the noise floor of the measurement equipment.

Results of the test are shown below in Table 7.5-1 to 7.5-4.

Using a signal generator, both the uplink and downlink ports were driven with a CW signal. The frequency of the signal generator was sweep across the entire range of operation. 


Figure 7.6-3: Cellular Frequency Response Uplink

7.7 Radiated Emissions (Unintentional Radiators) - FCC Section 15.109

7.7.1 <u>Measurement Procedure</u>

The equipment under test is placed on the Open Area Test Site (described in section 2.1) on a wooden table at the turntable center. For each radiated emission, the antenna mast is raised and lowered from one (1) to four (4) meters and the turntable is rotated 360° to obtain a maximum peak reading on the spectrum analyzer. The radiated emissions are then measured using an EMI receiver employing a CISPR quasi-peak detector for frequencies below 1000 MHz and an Average detector function for frequencies above 1000 MHz. This repeated for both horizontal and vertical polarizations of the receive antenna.

The field strength of each radiated emission is calculated by correcting the EMI receiver level for cable loss, amplifier gain, and antenna correction factors.

Field Strength (dBuV/m) = EMI Receiver Level (dBuV) + Cable Loss (dB) - Amplifier Gain (dB) + Antenna Correction Factor (1/m)

7.8 Power Line Conducted Emissions - FCC Section 15.107

7.8.1 Measurement Procedure

ANSI C63.4 sections 6 and 7 were the guiding documents for this evaluation. Conducted emissions were performed from 150kHz to 30MHz with the spectrum analyzer's resolution bandwidth set to 9kHz and the video bandwidth set to 30kHz. The calculation for the conducted emissions is as follows:

Corrected Reading = Analyzer Reading + LISN Loss + Cable Loss Margin = Applicable Limit - Corrected Reading
