Hi Tom,

The unit was setup to transmit continuously in order to capture the transmission more easily. See customer response:

“The bridge only transmits packets when requested to do so by a separate controller, such as an app or Home Automation System. For example, if a user integrates the Bridge to a 3rd Party Controller such as Control4, they may issue a command to change the position of the shade (% open) from their Control4 app/account to the Pella Bridge. The Pella Bridge then transmits this command to the appropriate shade per 15.231(a)(2). The Bridge does not poll devices at a periodic frequency. Within our ecosystem, sensors are only transmitters (not transceivers), so the sensors transmit status to the Bridge when they change state (opened/closed, locked/unlocked, tamper) or roughly every 70 minutes (supervisory signal). The bridge does not transmit to sensors, only receives data from them. Pella Shades contain a transceiver, so they are able to receive transmissions from the Pella Bridge. As described above, the Bridge only issues commands to shades when commanded to do so by the user.”
