Fig.1 Photograph of the SAR measurement System




Fig.2.1 Photograph of the Tissue Simulant Fluid liquid depth 15cm for Left-head Side




Fig.2.2 Photograph of the Tissue Simulant Fluid liquid depth 15cm for Flat (Body)




Fig.2.3 Photograph of the Tissue Simulant Fluid liquid depth 15cm for Right-head Side




Fig.2.4 Photograph of the Tissue Simulant Fluid liquid depth 15cm for Flat (Body)




Fig.2.5 Photograph of the Tissue Simulant Fluid liquid depth 15cm for Flat (Body)




Fig.3 Right Head Section / Cheek-Touch Position_Slider off





Fig.4 Right Head Section / Ear-Tilt Position(15°)_Slider off





Fig.5 Left Head Section / Cheek-Touch Position_Slider off




Fig.6 Left Head Section / Ear-Tilt Position(15°)_Slider off





Fig.7 Right Head Section / Cheek-Touch Position_Slider on




Fig.8 Right Head Section / Ear-Tilt Position(15°)_Slider on





Fig.9 Left Head Section / Cheek-Touch Position _ Slider on




Fig.10 Left Head Section / Ear-Tilt Position(15°)_Slider on




Fig.11 Body worn- EUT front to flat phantom and distance between flat phantom and mobile phone is 1.5 cm




Fig.12 Body worn- EUT back to flat phantom and distance between flat phantom and mobile phone is 1.5 cm




Fig.13 Body worn- EUT back to flat phantom and distance between flat phantom and mobile phone is 1.5 cm with headset.




Fig.20 RF cable
