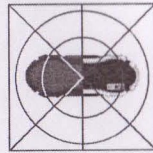

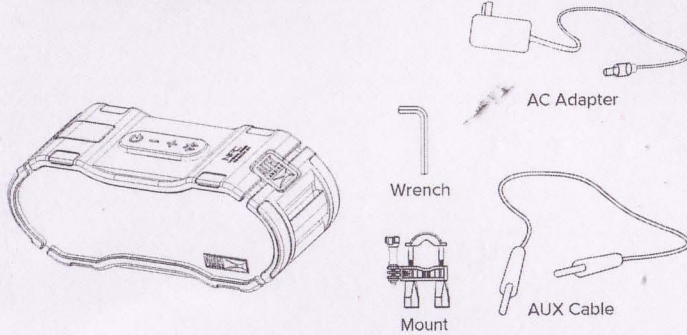

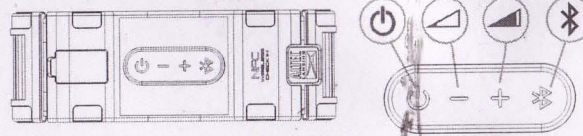

1. Make sure the following items are included in your package.



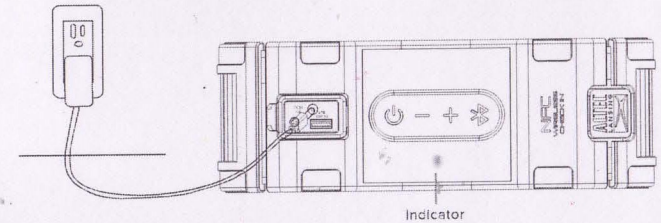
2. For a look at the various buttons on your speaker, view the graphic below.



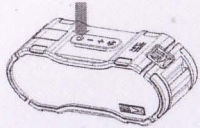
Power On.....	Press
Power Off.....	Hold for 2 Seconds
Play / Pause.....	Press
Volume Up / Down.....	Press + or -
Pairing Mode / Disconnect Device.....	Press
Battery Status.....	Press and +
Voice Control.....	Press 2 Times
Answer / End Call.....	Press
Multiple Connection.....	Hold for 2 Seconds
Factory Reset.....	Hold + and - for 5 Seconds

3. Connect the included AC Adapter to the DC In port on your speaker in order to charge your speaker's internal battery. A full charge takes approximately 4 hours.

Charging: When charging, an orange LED light will illuminate. The orange light will turn off when your unit is fully charged.



4. Pairing Your Speaker with a Bluetooth Device



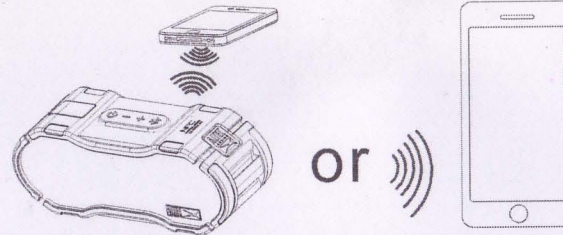
-Pairing the Omni Jacket Ultra Speaker with a Bluetooth Device for the First Time
When you power on your Omni Jacket Ultra speaker for the first time, it will automatically go into pairing mode. The LED status light will flash rapidly, as your speaker searches for a Bluetooth audio source to pair with.

-Pairing Additional Bluetooth Devices to the Omni Jacket Ultra Speaker
By pressing the Bluetooth Button () your speaker will again go into pairing mode. The LED status light will flash rapidly, as your speaker searches for another Bluetooth audio source to pair with.

Once you have successfully paired your speaker with a Bluetooth audio source, the LED status light will stop flashing rapidly, and begin shining steadily while remaining blue. In addition, your speaker will emit an audible tone to confirm that pairing was successful.

* Pairing mode times out in 3 minutes.

5. Pair the Speaker Using NFC
With Near Field Communication (NFC), you can easily pair and connect your speaker to your compatible device. Just hold your NFC enabled device directly against the wireless check in spot on your speaker.



Power on your speaker. Go to the Bluetooth Manager of your Bluetooth device. Search Bluetooth devices and select "OMNI JACKET ULTRA" to start connecting.

6. By downloading the "ALTEC CONNECT" app (for iOS and Android) you can personalize your OMNI JACKET ULTRA speaker.

ALTEC CONNECT will allow you to:

- Enable the Multi Connection setting
- Monitor the battery level and charging status
- Control Play/Pause/Skip/Volume/Mute
- Get over the air software updates for your Omni Jacket Ultra speaker
- Select EQ sound settings



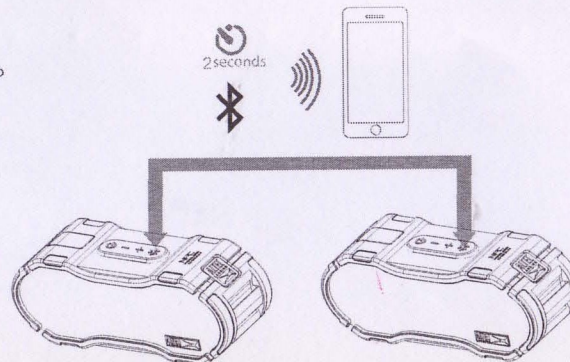
7. Using the Multi Connection Feature

The Multi Connection feature allows you to connect two Omni Jacket Ultra speakers together for a bigger, more powerful sound.

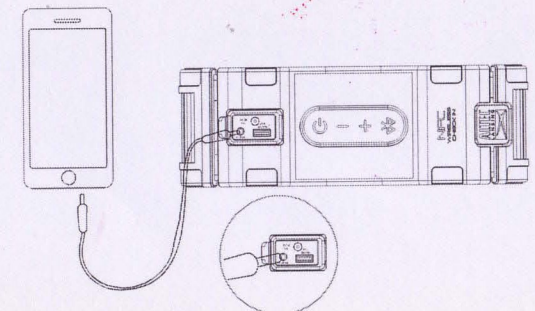
The Multi Connection feature can be accessed through the Altec Connect app, but you can also use it without the app. To do so, follow the steps below:

1. Have one Omni Jacket Ultra speaker turned on, paired and playing music.
2. Power on your second Omni Jacket Ultra speaker.
3. Press and hold the Bluetooth buttons on both speakers at the same time for two seconds.

The two connected speakers will now play the same music from the same device.

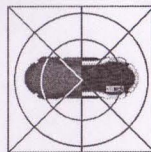


8. You can also use the included 3.5mm Auxiliary Cable to connect audio devices through the AUX In port on your speaker

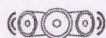

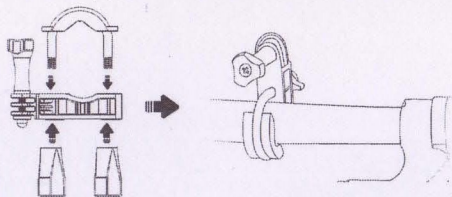

Using the Mount: The included mounting bracket allows you to attach your speaker to cylinder shaped surfaces such as the handle bars of a bicycle or ATV, or the rails on a yacht. This bracket comes unassembled. To use it, first attach the pieces as shown below. Next connect your speaker by screwing it into your speaker's tripod mount, and then attach the bracket to a suitable surface. Use the included wrench to help you loosen or tighten when necessary.
