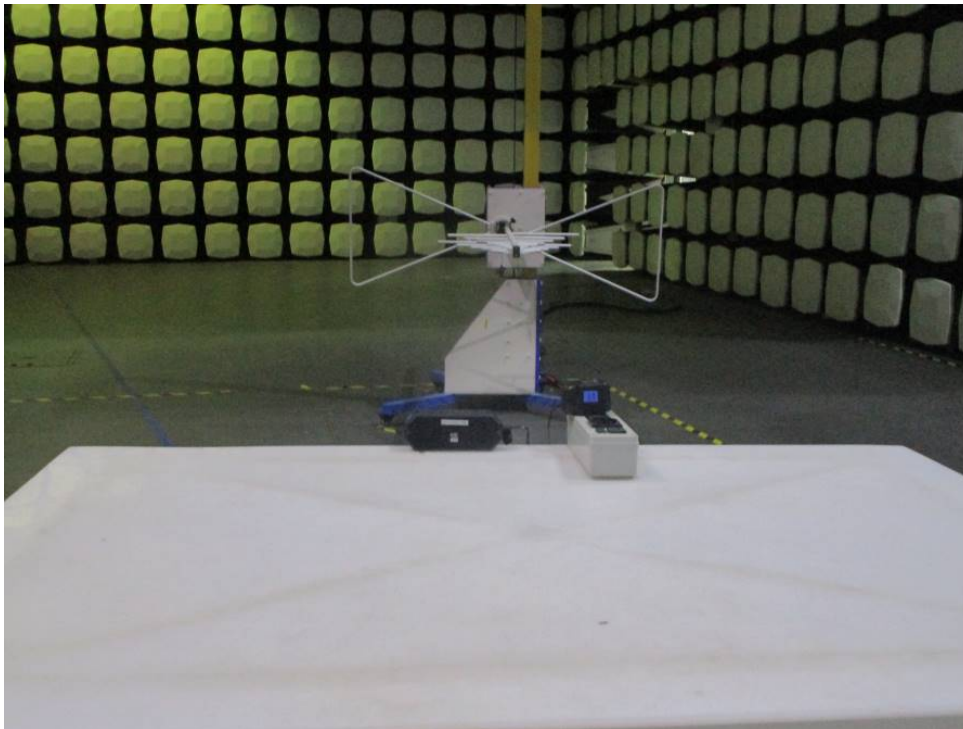

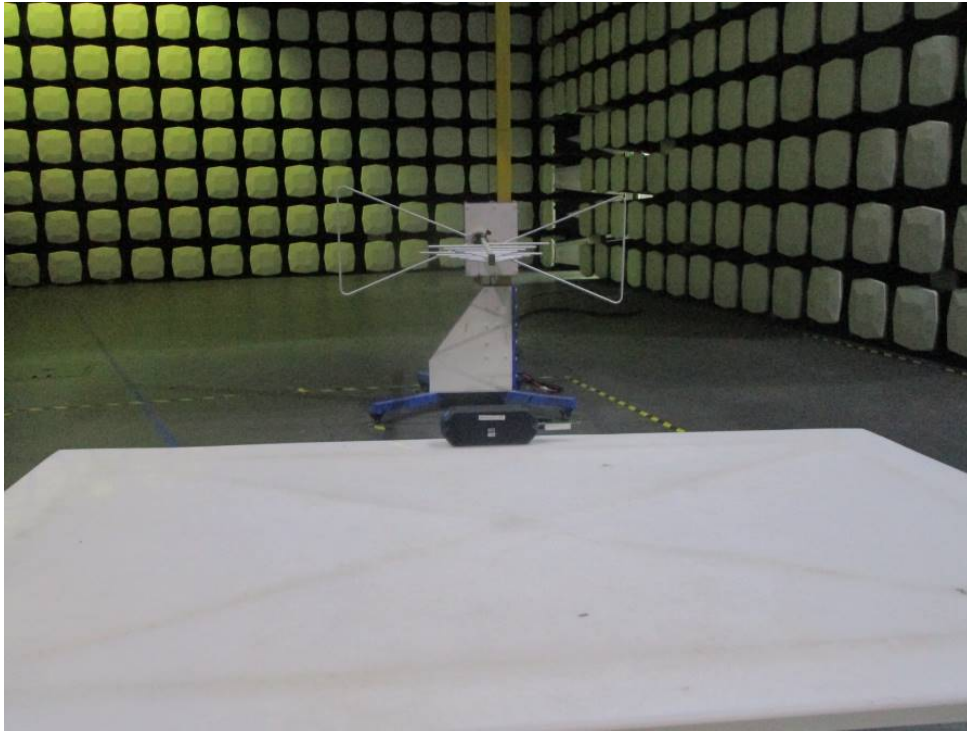
Conducted Emissions at AC Power Line (150kHz-30MHz)



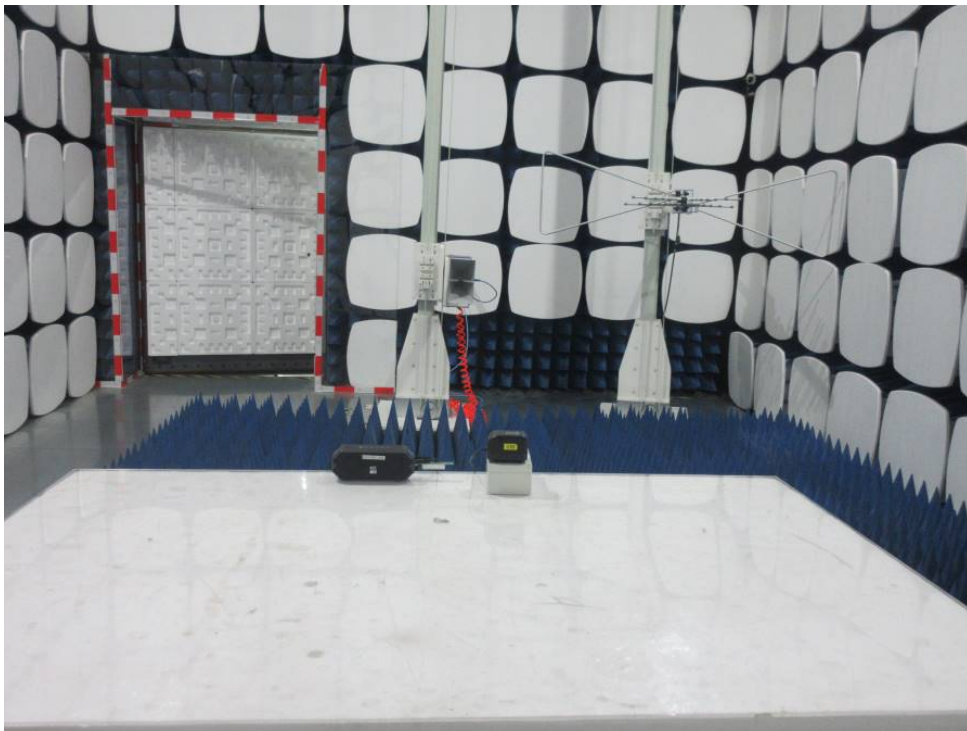
Radiated Emissions (30MHz-1GHz) Test Setup

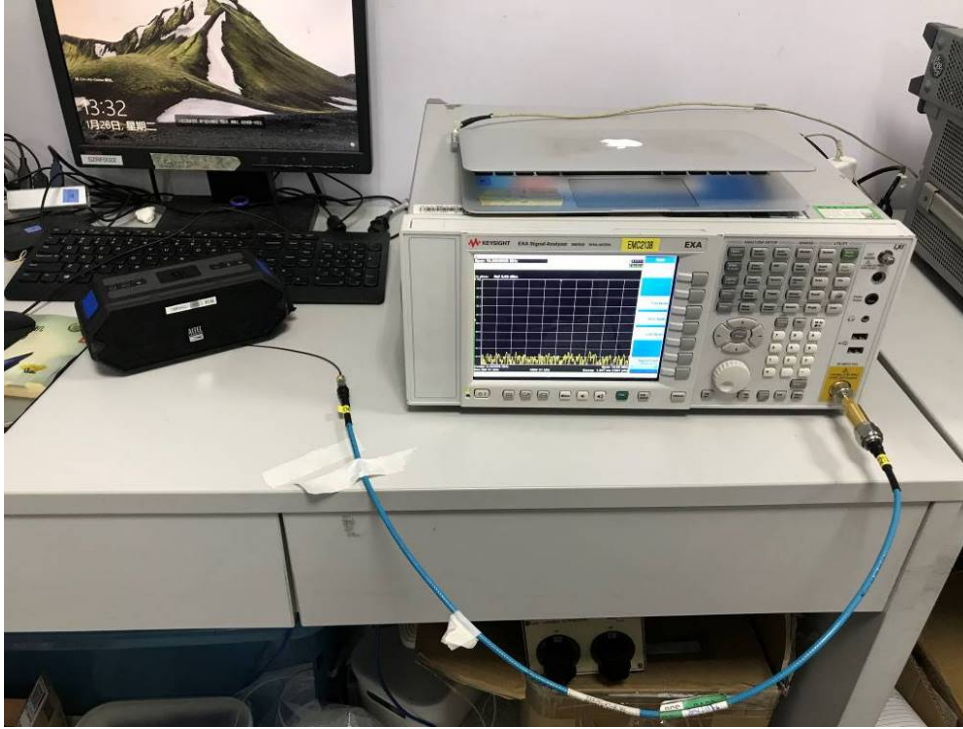
Radiated Emissions (above 1GHz) Test Setup
