### 6. True Wireless Pairing : Party Mode & Stereo Mode

Any two speakers that have the True Wireless Pairing feature can be paired together for a bigger, more powerful sound with Party Mode. Once you have two speakers paired together, you can then switch to Stereo Mode, where one speaker acts as a left channel and the other acts as a right channel.

#### Step 1



Pair your first speaker (Speaker 1) with a Bluetooth phone.

#### Step 2



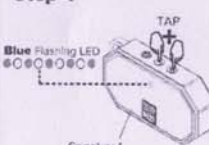
Power on your second speaker (Speaker 2).

#### Step 3



Enter True Wireless Mode on your second speaker (Speaker 2).

#### Step 4



Enter True Wireless Mode on your first speaker (Speaker 1).

#### Step 5



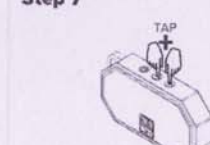
Once both speakers are in True Wireless Mode, wait for up to 60 seconds and then both speakers will be paired to your phone.

#### Step 6



Simultaneously tap the + and - buttons on either speaker to switch to Party Mode.

#### Step 7

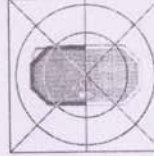


Once in Party Mode, simultaneously tap the + and - buttons on either speaker to switch back to Stereo Mode. To exit Stereo Mode and Party Mode, power off either speaker.

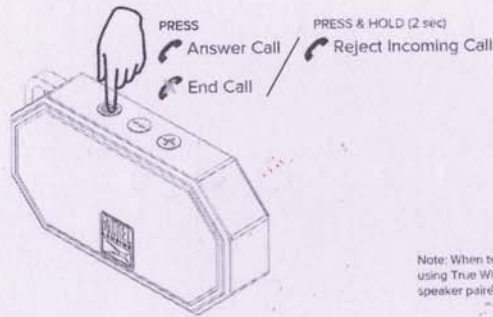

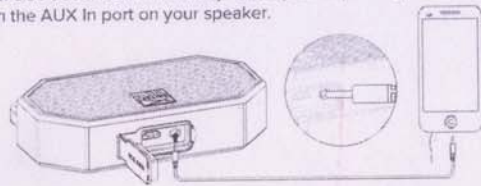
### 7. Making Phone Calls



Note: When two speakers are connected using True Wireless Pairing, only the first speaker paired will receive phone calls.

### 8. Wired External Audio Input

You can also use a 3.5mm Auxiliary Cable (sold separately) to connect audio devices through the AUX In port on your speaker.
