The data captured from your head is organized in a way that charts your exertion and gives you visual indicators when you hit your goals in each area of activity.


Features include Body Temperature, Distance Traveled, Speed, Time, Heart Rate, Calories Burned, Optimal Work Out Zones, and more. All of this data is captured in our headband unit that is simple to wear and designed for comfort and accuracy.

How to use your Spree



1. Place Spree on your head

Insert the Performance
Optimization Device (POD) into the headband, with logo facing inside the band. Make sure the band is tight around your head and is not shifting, while you move around.
Tighten or loosen the band using the adjustment rings on the back of the band.



2. Open the Spree app


First you will have to connect your headband to the app. This is necessary only when you first start using the device.

On the lower left side of the screen, tap on CONNECT DEVICE.



3. Connect to your Spree

The connection window will open and in a few seconds you will see your Spree device appear. Tap on the checkbox next to the device name. Once checked, tap on the green checkmark above. You will return to the main screen and your device will connect to the app.



4. Select your activity

Tap on the top left field in the section YOUR WORKOUT. This will let you select your exercise. Tap on a checkbox next to the activity you would like to select and then on the green checkmark to return to the main screen.



5. Select your goal

Tap the top right corner of YOUR WORKOUT section to access the selection of your goal. Tap on the checkbox next to the goal to select it and then tap on the green checkmark to return to the main screen.

6. Begin workout

Now after you set up your device, you can start your activity. Tap on BEGIN WORKOUT bar at the bottom of the main screen and you are ready to go.

7. Prepare for workout

The SNAPSHOT screen will appear after you tap on BEGIN WORKOUT. This screen provides an overview of your workout and your goal in form of the yellow square in the graph. On top you will see the Time, Distance, Speed and other metrics based on your type of

activity and/or your selection.

Below the basic info you see a graph that maps your heart rate (horizontal axis) and body temperature (vertical axis). Your realtime personal metrics are shown in form of a "+" sign. In order to achieve the most effective workout based on your selected activity and

goals (see Steps 4 and 5), you should lock the "+" in the yellow square, which is your optimal goal.

8. Warm up

Start with your regular warm up routine, until your temperature reaches 97.5° F (36.4° C). At that point numbers should appear by your "+" with the actual values for your body.



9. Push yourself to your goal

Once you are warmed up you can start pushing yourself to your target zone. As your heart rate and temperature rises your "+" will get closer to the yellow square = your optimal workout zone.

When you reach your zone, your heart rate and temperature indicate that you are on target to reach your goals. Make sure

you stay within your zone during the rest of the exercise, before you start to cool down.

If you prefer numbers rather than graphics, you can tap on SPECIFICS where you will see all metrics in detail.

10. Cool down

Before you stop your workout, you should cool down and stretch in order to ensure that your muscles properly recover. Your Spree app will show your body temperature and heart rate declining.

11. Review your results

You can take your Spree off now and see how you did during your activity. Tap on a HISTORY tab to review your body temperature, heart rate, step count, distance, average speed, pace or cadence, calorie burn and other metrics related to your exercise.

12. Charge Spree

Remove the Spree POD from the headband and insert

the provided USB cable into the USB port on the Spree. Plug the other end into a computer or standard USB charging power supply (not supplied).

12. Clean your Spree

Remove the POD from the headband and wipe it with a soft cloth or disinfecting wipe. (Caution! Do not rinse the POD or submerge in water.)

The headband itself (without the POD) can be rinsed under warm water with a soap or mild detergent and to left air-dry.
