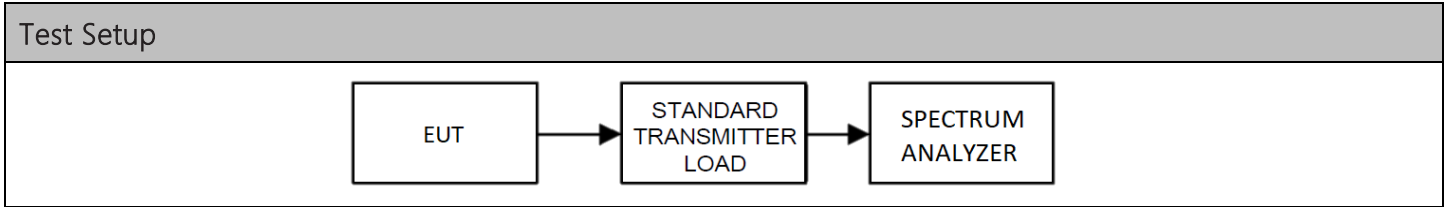

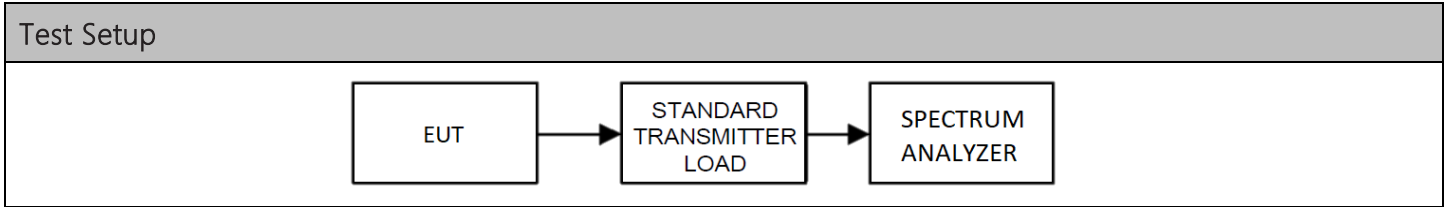

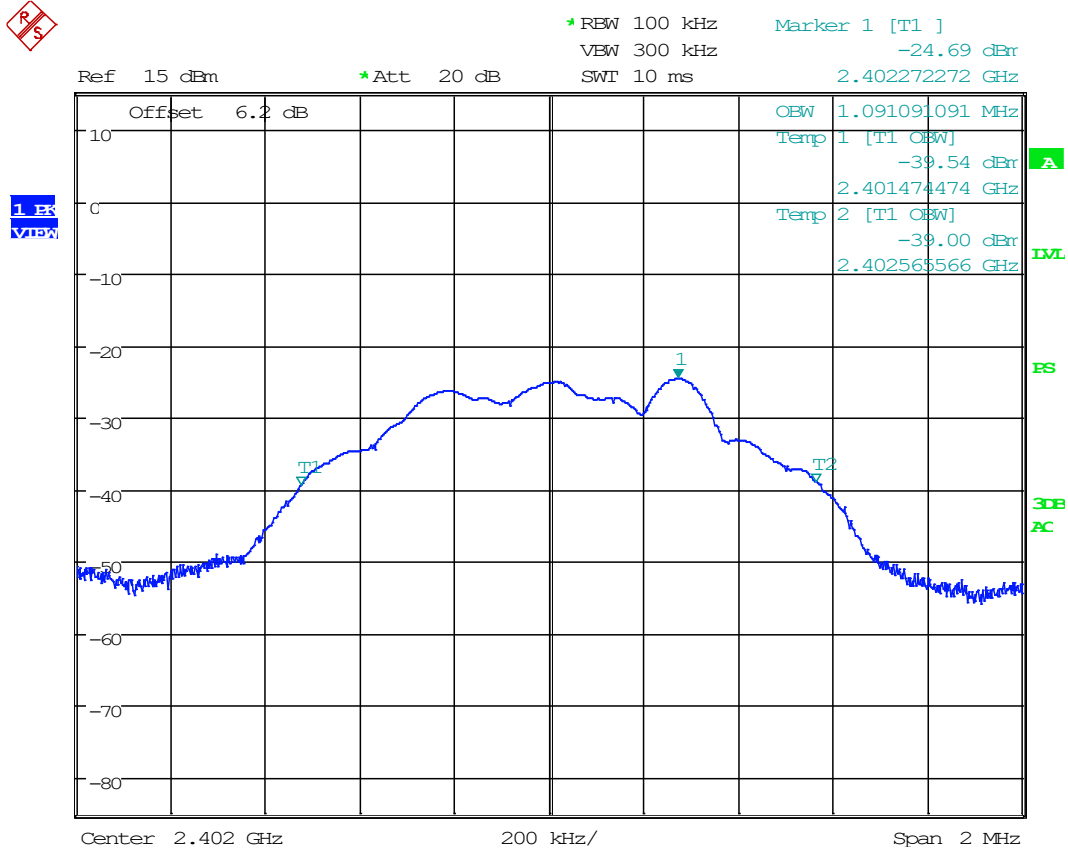

Occupied Bandwidth, Spectrum Plots

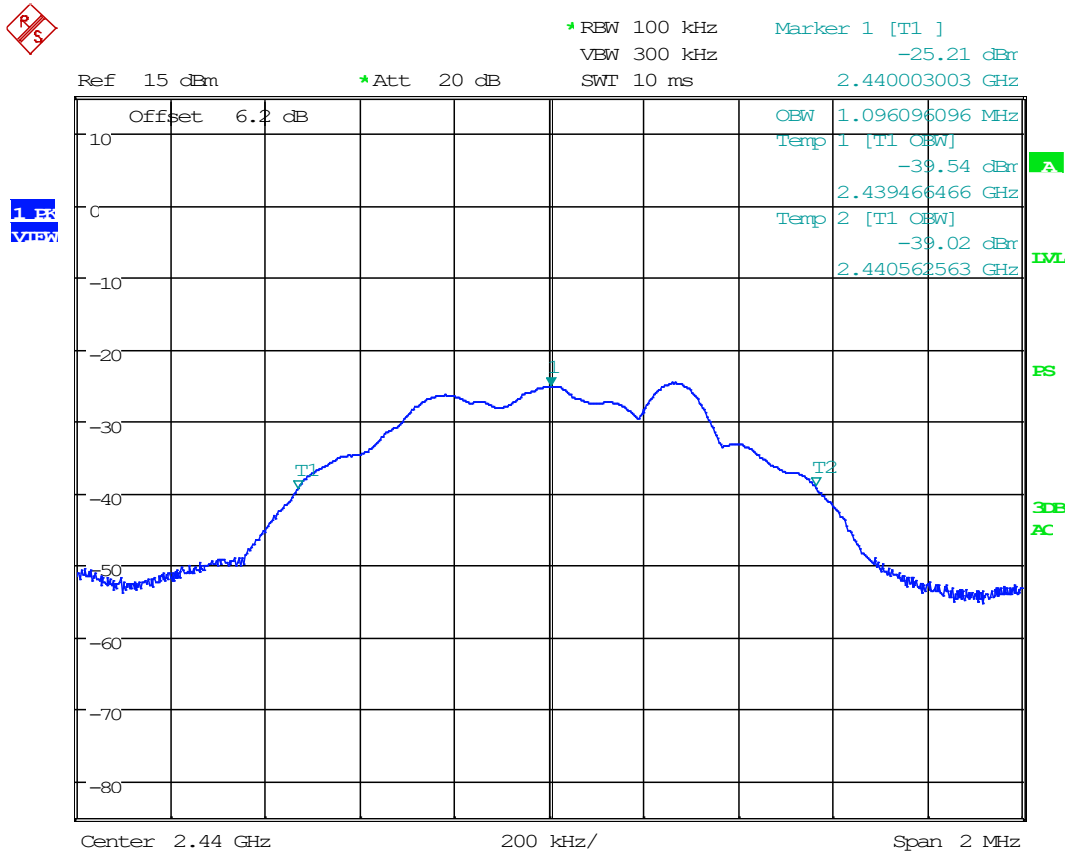

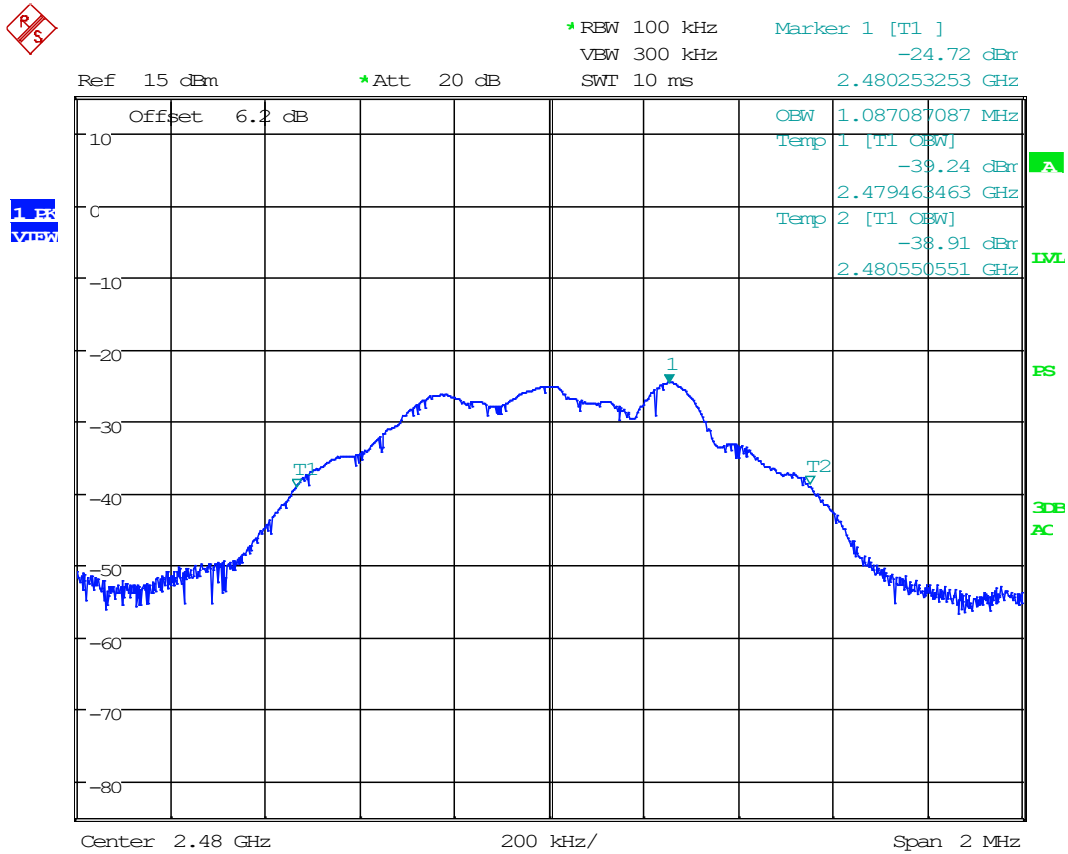


8.2.2 99% Bandwidth, 2440 MHz

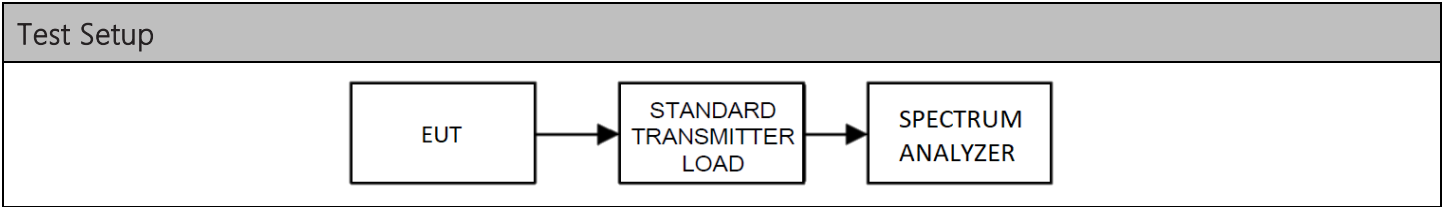

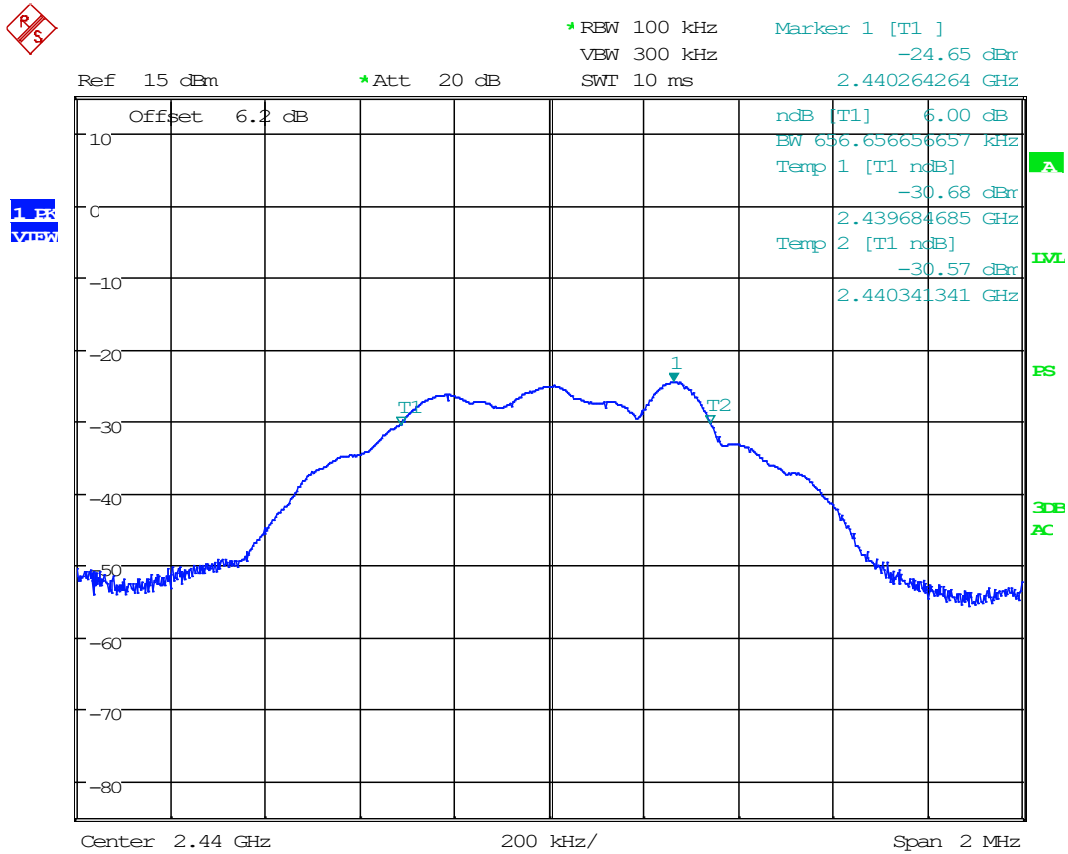

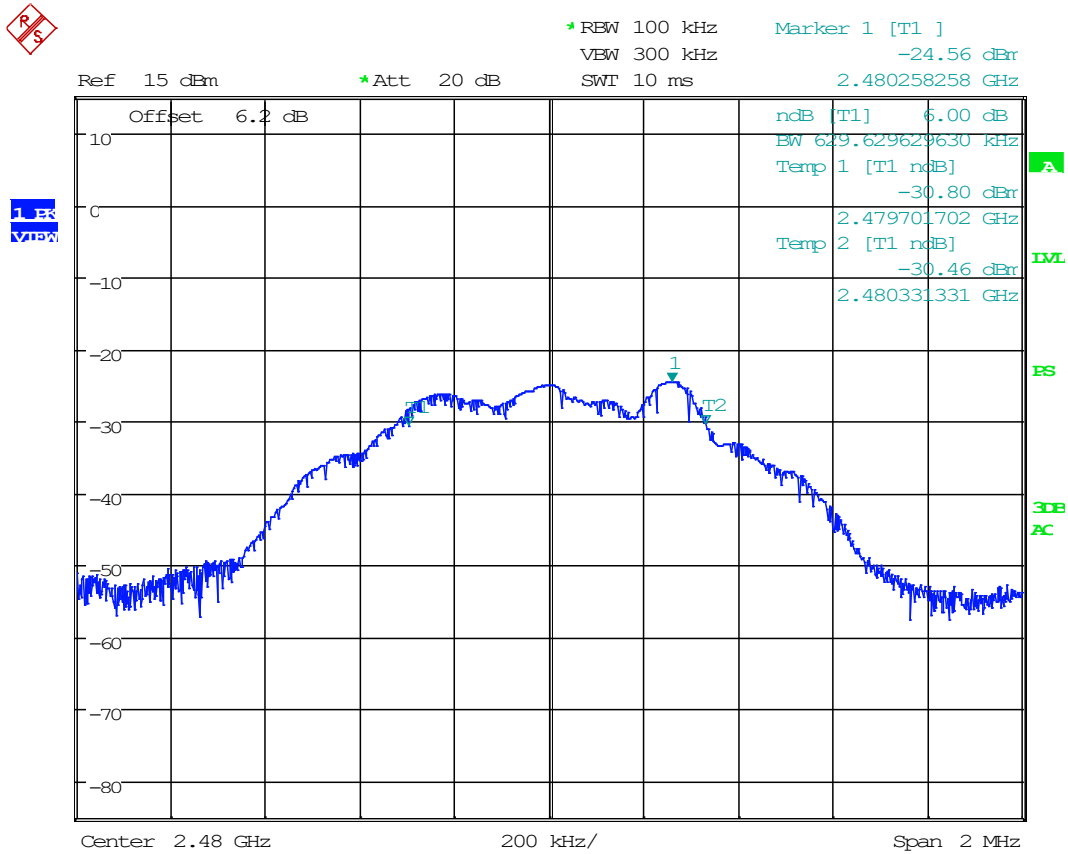


8.3.2 6 dB DTS Bandwidth, 2440 MHz

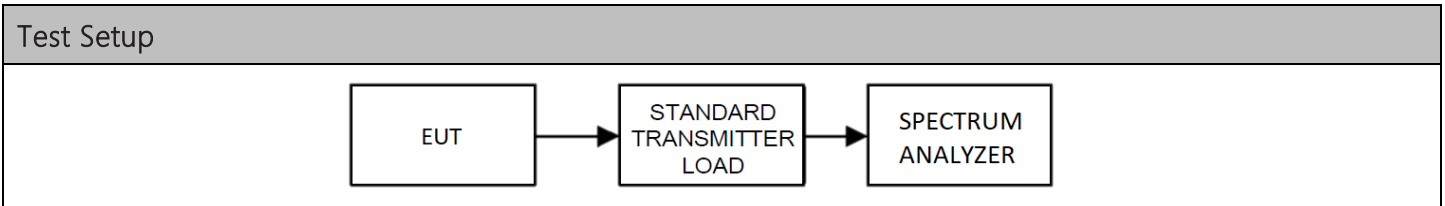

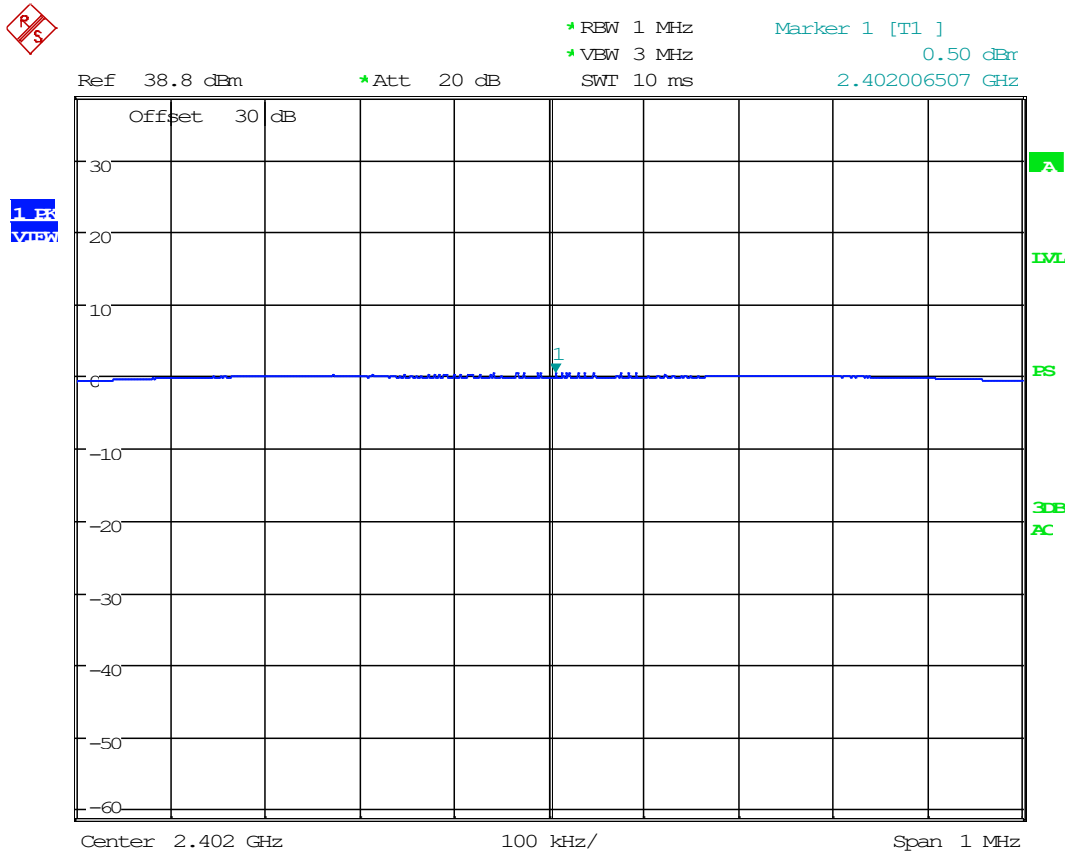

8.4.1 Conducted Output Power, 2402 MHz

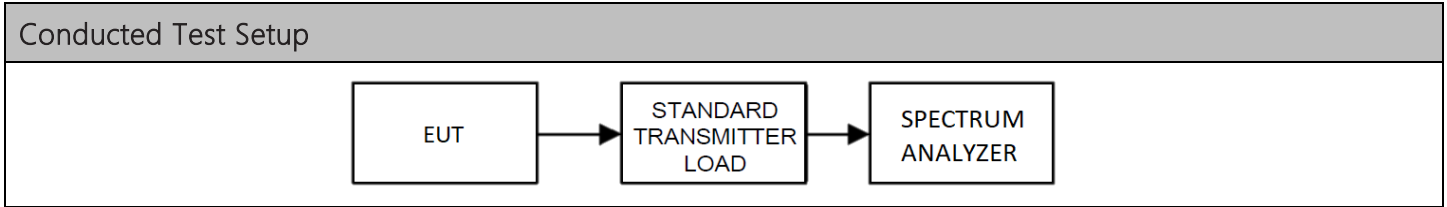

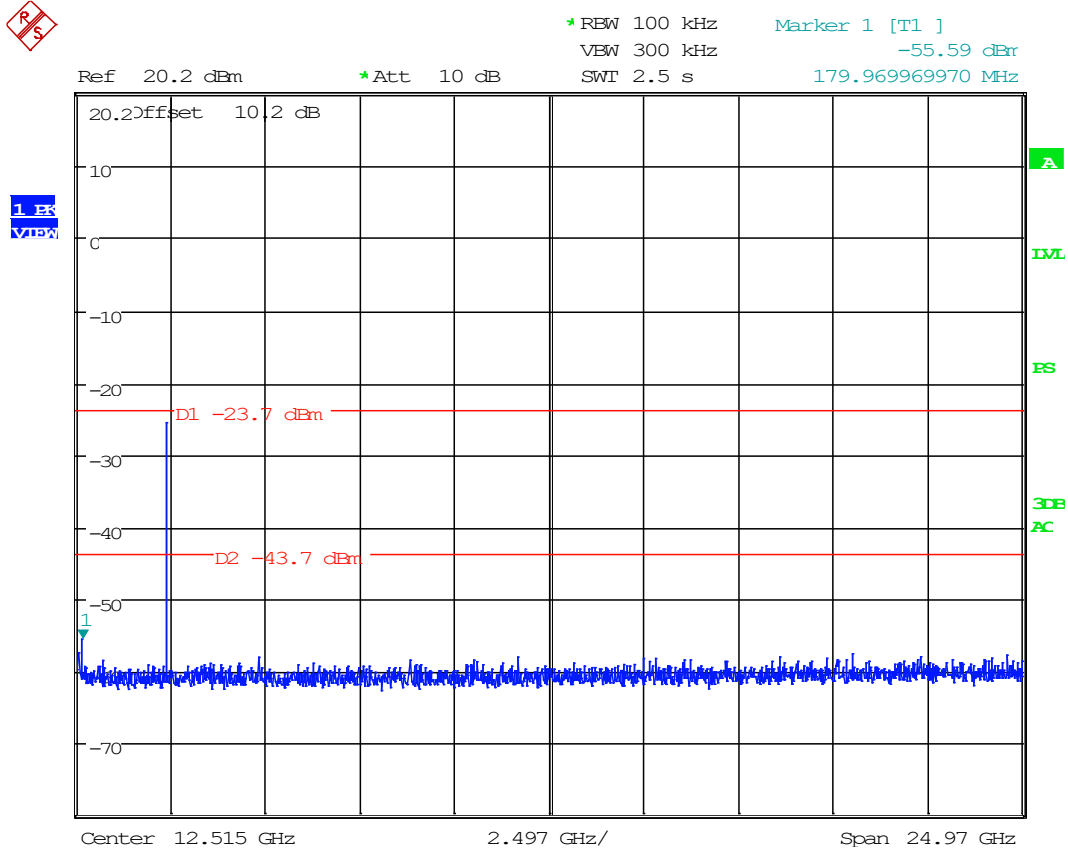

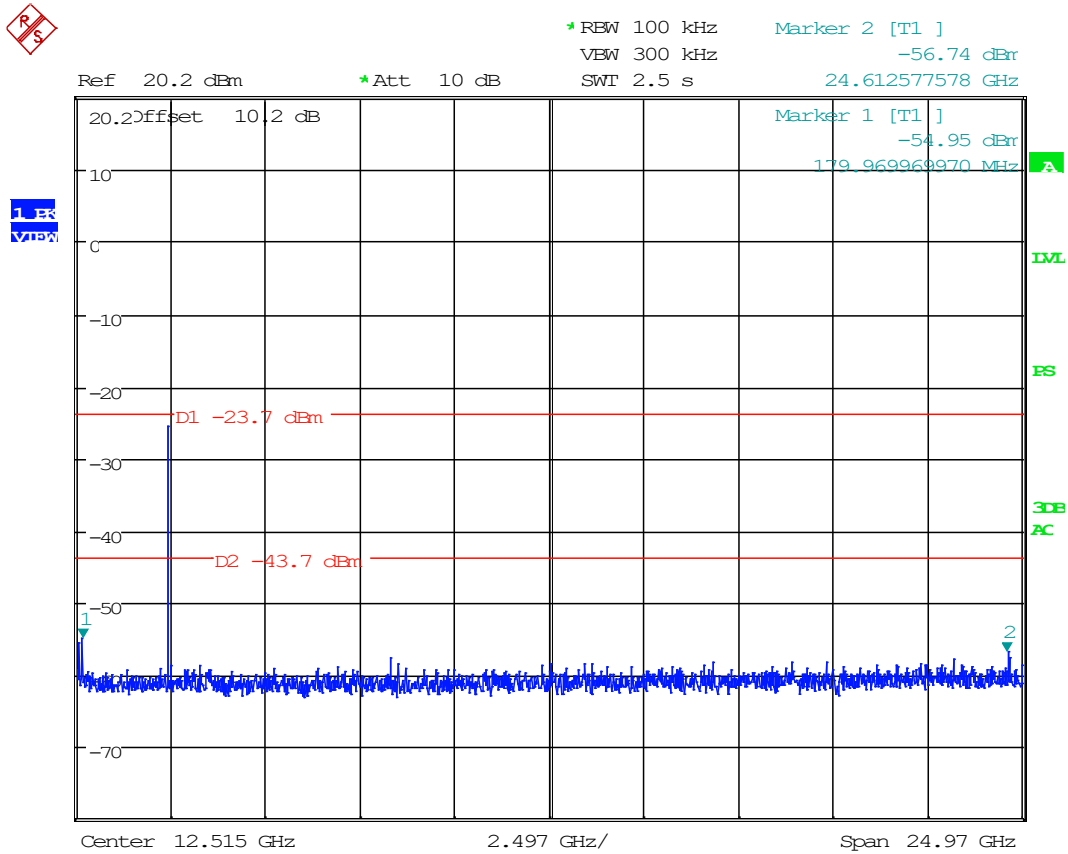
Conducted Emissions in Non-Restricted Bands, Spectrum Plots

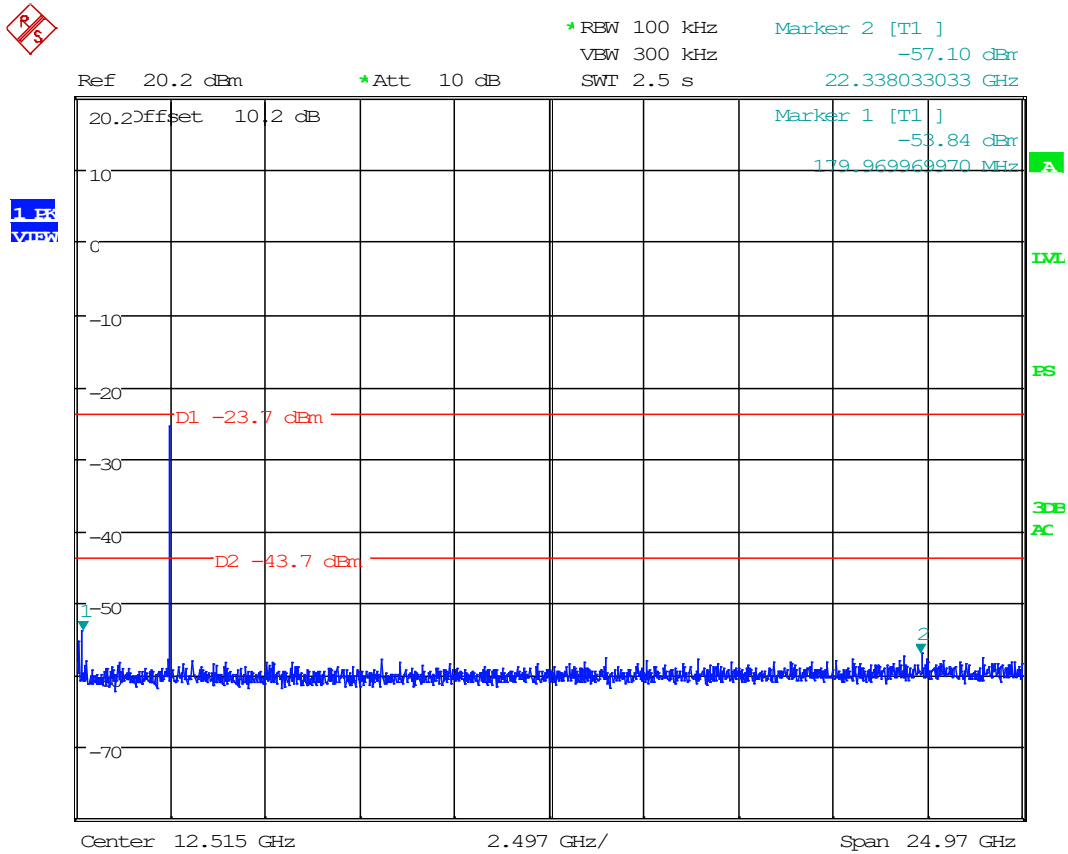

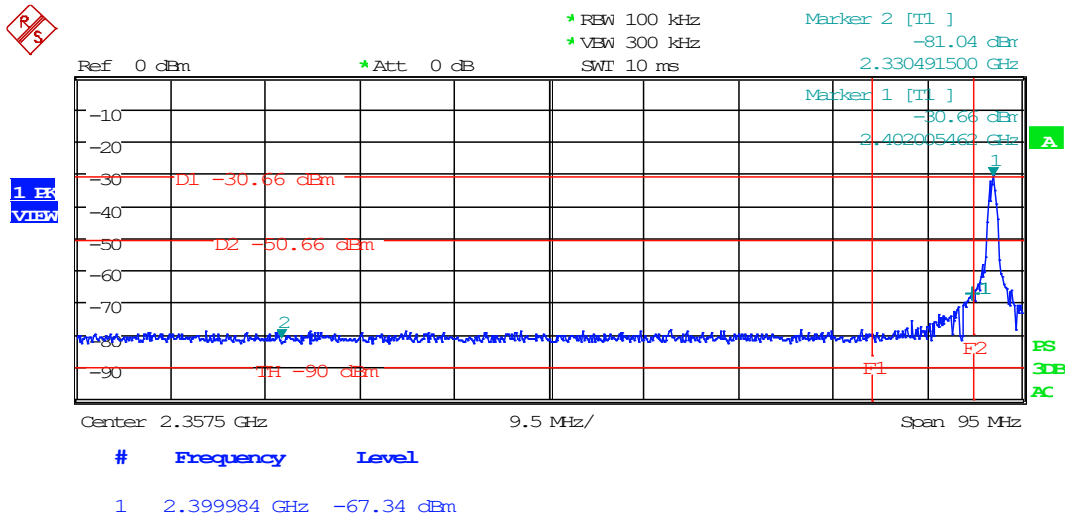

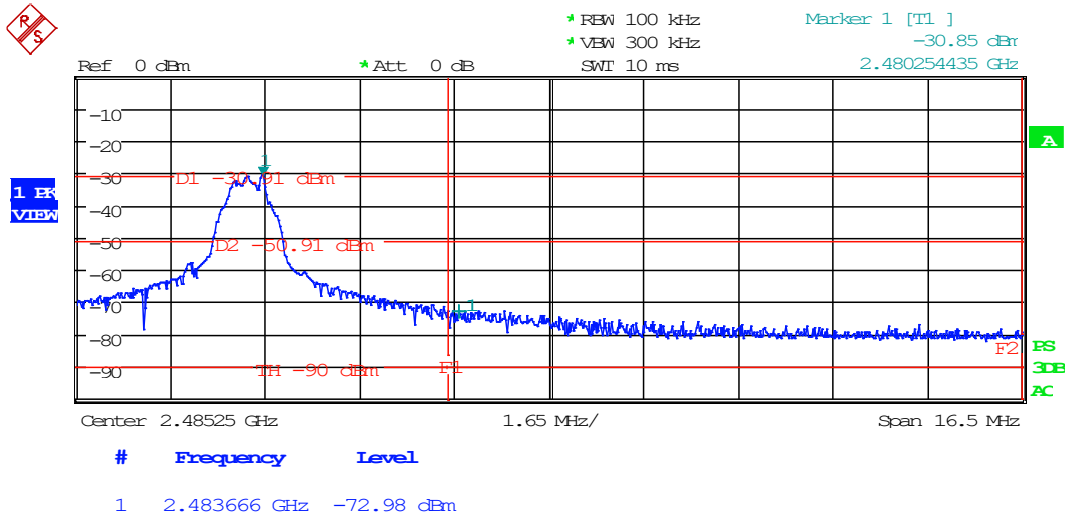

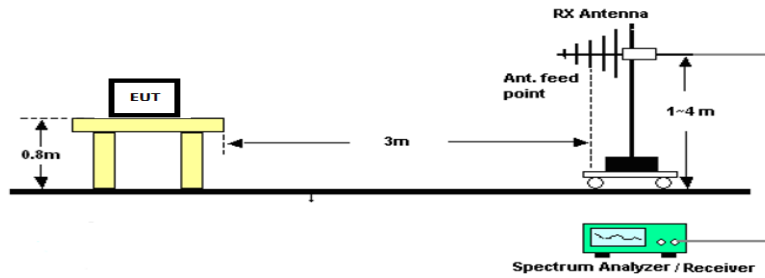

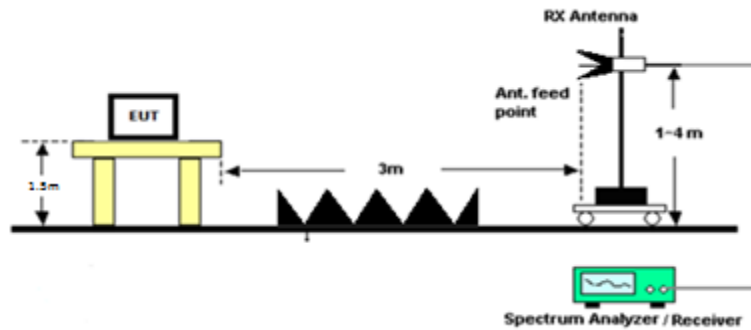
